Besides, many people are unaware about BRTC services due to poor publicity. "We usually travel by private buses

like Hanif, Shyamoli or SR. We don't know that BRTC operates special services and where tickets are distributed," said Zahirul Islam, a government officer, who travels from Dhaka to Rajshahi every Eid.

About uncomfortable travel, BRTC Chairman Mizanur Rahman told The Daily Star, "We have to run the services with the buses we have."

About public apathy to BRTC services, he said, "Low-income people travel by our buses. I think the rush will increase after closing of the garments factories." TRAINS

The sale of advance train tickets yesterday continued for the fourth consecutive day at Kamalapur Railway Station in Dhaka and at Chittagong Railway Station.

Tickets of July 16 were sold yesterday, while tickets of July 17 will be sold today.

Like the previous day, hundreds of people thronged the stations for tickets, and many returned empty handed even after long waits.

Bangladeshi expat killed in Dhaka

Around six to seven armed men stormed the flat of a man who just returned from the US and stabbed him to death yesterday. The incident happened at Bhasantek in the capital. The dead is Monsur Rahman, 59.

The assailants also took away 25

tolas of gold ornaments, 1.5 lakh in cash, two laptops and other valuables from the flat in a five-storey building. Sufia Rahman, the victim's wife,

told The Daily Star that around 7:10pm the criminals entered the flat finding its door open and started to look for one Sumon. Monsur was out then. "When the killers were told that no

one named Sumon lived there, they said they would search for him themselves," she said.

At one point, the criminals tied the hands of the five family members, including Sufia and her daughter Jhumur, with rope.

When Monsur entered the flat after offering his prayers in a local mosque, his hands were tied as well. He was stabbed six to seven times in the back the moment he tried to resist the killers, Sufia said, sobbing uncontrollably.

The assailants fled afterwards.

Locals rushed in and rescued the family hearing their screams for help.

Monsur was rushed to a local hospital where duty doctors declared him dead, said sources.

The victim went to the USA around five years ago and had been living in New York. He returned to Bangladesh

Tanzania's ruling party picks presidential candidate

Tanzania's ruling party yesterday anointed government minister John Magufuli as its candidate for presidential elections due to be held in October, party officials said.

Magufuli, 55 and currently the east African nation's minister of works, will be widely expected to succeed President Jakaya Kikwete, who will be stepping down after his second and final term.

"I am proud of our candidate, he is a very hardworking man and I am certain he will be the best president," Kikwete said after ballots were counted in Tanzania's administrative capital of Dodoma.

"He is a no nonsense man. We hope he will help the country to conquer poverty, fight graft and indiscipline."

Presidential, parliamentary and local polls are due to take place on October 25. The ruling Chama Cha Mapinduzi (CCM) party has been in power since modern Tanzania was formed in 1964, and currently has twothirds of seats in parliament.

The party said Magufuli scored 87 percent of the votes, beating off Justice Minister Asha-Rose Migiro, a former UN deputy secretary general and exforeign minister, and Amina Salum Ali, currently the African Union's ambassador to Washington.

Magufuli had not initially been

seen as a frontrunner, but was among three shortlisted from a field of nearly 40 other candidates that included Vice-President Mohamed Bilal, Prime Minister Mizengo Pinda, and former prime ministers Edward Lowassa and Frederick Sumaye.

"I am profoundly overwhelmed by the results," Magufuli said. "But I promise to give the CCM a resounding victory in October. I also promise to serve all Tanzanians to the best of my ability in line with the law of the land and spirit of good governance."


