Water supply 'controlled'

TIB survey reveals nexus between Dhaka Wasa employees, political activists, brokers

A research of Transparency International Bangladesh claims that officials and employees of Dhaka Wasa control water supply in connivance with brokers and political activists.

A section of Water Development Board officials are also involved in corruption, the TIB said.

The study analysed Dhaka Water Supply And Sewerage Authority (Wasa) and Bangladesh Water Development Board (BWDB) to find out the level of integrity in the water sector under the city and rural contexts.

Prof Sheikh Tawhidul Islam and Syed Hafizur Rahman of Jahangirnagar University, who jointly conducted the research, presented the report titled "Integrity in Water Management of Bangladesh: Present Perspective and

EXTORTION IN TIKATULI Jubo League man finally expelled

Three days after he had been detained and released by Rapid Action Battalion, a top leader of Jubo League, the youth front of ruling Awami League, was expelled from the organisation yesterday over allegations of extortion.

Iqbal Mahmud, publications secretary of Jubo League, confirmed that Rezaul Karim Reza, 45, acting general secretary of the Jubo League's Dhaka South unit, has indeed been expelled for extortion.

A Rab official said Reza and 10 other ruling party men were detained Thursday in connection with extortion and vandalism at Rajdhani Super Market in the capital's Tikatuli.

The 10 men had been detained during a Rab-backed mobile court raid that morning and sentenced to different jail terms.
