

Relief ministry land under illegal occupation

Influential people in 4 upazilas of Nilphamari made false ownership documents and handed over possession to others in exchange for money

Most of 3,602 acres of land belonging to relief and disaster management ministry is under illegal occupation of influential people in four upazilas of the district due to lack of proper maintenance.

In 1947-1952 period, the then Pakistan government acquired 3,031.83 acres of land in Dimla upazila, 543.10 acres in Sadar upazila, 22.50 acres in Jaldhaka upazila and 4.41 acres in Saidpur upazila to rehabilitate refugees coming from India in face of communal violence there, sources said.

A good number of Indian refugees were given shelter in a small portion of those lands while the rest remained unused till independence of Bangladesh, said Tabibul Islam Ahmed, chairman of Dimla upazila parishad.

After 1971, a section of unscrupulous people gradually occupied those lands and started handing over possession to others in exchange for money. For this, buyers and sellers usually make unregistered deeds on government stamps," he said.

Some people in collusion with dishonest land officials even made false land ownership documents and sold those through registration in government land offices, sources said.

survey, some illegal occupiers got a large portion of the government lands recorded as private property through bribing officials concerned but no action was taken despite filing of several written allegations to the higher authorities concerned.

The lands are under direct control of government's relief department and project implementation officers (PIO) of the upazilas concerned are to be recovered by the government's tenure of 2007-2008, the authorities took a strong initiative to recover the occupied land, but the process discontinued later.

The government can earn a good amount of money if the 3,602-acre government land worth hundreds of crore taka is handed over to them legally.

District administration made several attempts to recover the occupied land but those efforts ended in smoke as a section of political and local leaders backed illegal occupiers.

During last caretaker government's tenure of 2007-2008, the authorities took a strong initiative to recover the occupied land, but the process discontinued later.

The government can earn a good amount of money if the 3,602-acre government land worth hundreds of crore taka is handed over to them legally.

Sadar upazila parishad Chairman Abu Zar Rahman suggested that the government determine value of the occupied land, realise the prices from those who are in possession and hand it over to them legally.

Expressing concern about the situation, Nilphamari Deputy Commissioner Zakir Hossain said, "None can occupy government land permanently. The administration will recover it if the higher authorities give directives."

LAND SUBSIDENCE AROUND BARAPUKURIA COAL MINE 8 affected edn institutions get compensation

Eight land subsidence affected educational institutions around the Barapukuria Coal Mining Company Ltd (BCMCL) in Parbatipur upazila of the district on Sunday got Tk 35 lakh and computers as compensation.

As part of their social responsibility, BCMCL authorities distributed the cash and computers at its complex in the afternoon.

As chief guest, local lawmaker Mostafizur Rahman Fizar distributed the cheques and computers to eight institutions at the

programme chaired by Aminuzzaman, managing director of BCMCL.

Addressing the programme, Fizar, minister of Primary and Mass Education Ministry, heavily came upon the affected villagers as they are yet to vacate the land in spite of getting proper compensation.

He also urged the affected people to leave their land as soon as possible.

The BCMCL authority distributed Tk 191 crore among the affected people to acquire 646 acres of land around the coal-mine area that subsided.

Friend's fun costs his life

A boy met a tragic death as his friend hurled brick chips at him out of fun while bathing in the Purkhai River in Jaintapur upazila under Sylhet district on Sunday.

The deceased, Abdul Kadir Shahriar, 12, is son of Jahangir Uddin of Sarighat Sarufoud village in the upazila.

Shahriar along with his friend Jamil, 9, son of Tendal Hajir of Tikar village of Gainghat upazila, went to the river for bathing at about 5:00pm, locals said.

At one stage, Jamil hurled brick chips at Shahriar just as a fun, leaving him unconscious.

Seeing Shahriar's body floating on the river, locals informed police who recovered the body and sent it to Sylhet Osmani Medical College Hospital morgue for an autopsy.

Officer-in-charge of Jaintapur Model Police Station, Golok Chandra Basak confirmed the incident.

Farmers demand withdrawal of certificate cases

Hundreds of poor farmers of Dariapur area under Gaibandha Sadar upazila besieged the local Rajshahi Krishi Unnayon Bank yesterday, demanding withdrawal of certificate cases and restoration of easy-term bank loan for poor and marginal farmers.

Organised by the Gaibandha unit of Samajtantrik Khetmajur and Krishak Front, the farmers held a meeting at Dariapur market. Later, they laid siege to the local branch of Rajshahi Krishi Unnayon Bank.

Addressing a meeting at the venue, speakers said poor farmers were not getting fair prices of their agricultural products and it was becoming difficult to support their families. But, instead of waiving interest of bank loans, the bank authorities are filing certificate cases against the poor peasants.
