

National moon sighting body meets Friday

A meeting of the National Moon Sighting Committee will be held in the Islamic Foundation Baitul Mukarram in the capital on Friday.

The meeting will review reports on Shawal moon sighting and ascertain the date for the holy Eid-ul-Fitr of 1436 Hijri year.

Religious Affairs Minister Matiar Rahman will preside over the meeting, said a handout yesterday.

The committee has requested all to inform over the phone or fax number if they see the Shawal moon in the sky from anywhere in the country.

Govt appeals against HC bail orders for Anwar, Mintoo, Aman

The government yesterday filed 52 appeals with the Supreme Court against the High Court orders that granted bail to BNP leaders MK Anwar, Abdul Awal Mintoo and Amanullah Aman in 52 areas and vandalism cases.

Chamber judge of the Appellate Division may hold hearing on the appeals on Tuesday, Deputy Attorney General Amit Talukder told The Daily Star.

Following separate bail petitions, the HC on July 9 granted anticipatory bail to BNP's standing committee member Anwar in nine cases, to party Chief Khaleda Zia's adviser Mintoo in one case and its Joint Secretary General Aman in 42 cases.

The HC granted the bail for four weeks after the leaders appeared before it with separate bail petitions.

The cases were filed during the countrywide blockade and hartals enforced by BNP-led 20-party alliance this year.

AL, BNP men's joint grabbing of Kuakata Rakhine land protested

Grabbers are siblings

Two brothers who are leaders of the ruling Awami League and the BNP have allegedly grabbed a piece of land of indigenous Rakhine people in Kuakata tourist zone in Patuakhali, triggering protests.

The siblings are constructing a market encroaching upon Rakhine Women's Market, which is close to the scenic Kuakata beach in Kalapara upazila.

Indigenous people staged protests both in Kuakata and the capital.

Addressing a rally in front of the National Museum in Dhaka, indigenous leaders said Monir Ahmed Bhuiyan, general secretary of Kuakata Municipality Awami League, and Babul Bhuiyan, joint convener of Kuakata Municipality

BNP, are erecting "Bhuiyan Market" on the Rakhine's land.

Representatives from different organisations of indigenous communities including Bangladesh Rakhine Students Union, Bangladesh Adivasi Union, Bangladesh Rakhine Student Council, and Metropolitan Hajong Welfare Samity joined the protest, organised by Adivasi Kalyan o Unnayan Sangstha (AKUS).

Luma Rakhine, president of Kuakata Rakhine Women's Market, said 25 Rakhine family donated 80 decimals of their land to the district administration on the direction of then Prime Minister Sheikh Hasina in 1999 for the development of the livelihoods of the indigenous community.

Later the administration built 14 tin-roof concrete shops on the south of the land turning it into Rakhine

Women's Market and a big concrete platform on the west, she said, adding that most of the remaining land was open, where different cultural programmes were organised.

Luma said the two influential brothers had long been trying to grab a part from the east side of the market. Early this month, they started building Bhuiyan Market on around five decimals of the market land, she added.

The Rakhine people filed a complaint with the district administration on July 7, she said.

Jahangir Hossain, upazila nirbahi officer (UNO) of Kalapara, said there was a dispute over the ownership of the land as both the Rakhine and Monir Ahmed and his brother claimed the land to be theirs.

"After getting the complaint we

halted the construction work of Bhuiyan Market on July 8," he added.

The UNO said none could construct anything without the permission of Kuakata Development Authority headed by the deputy commissioner, and Monir did not take any permission.

"We will settle the matter after Eid-ul-Fitr measuring the land," he said.

Monir Ahmed claimed that it was their property and they took permission of Kaukata Municipality.

Luma Rakhine, however, feared that the two might resume the construction work.

The construction was halted when the foundation works were underway.

WAR CRIMES TRIAL

Verdict on Forkan Mallik tomorrow

The International Crimes Tribunal-2 is set to deliver a verdict tomorrow on Forkan Mallik, who was allegedly involved in several crimes committed in Patuakhali during the Liberation War.

The alleged Razakar from Patuakhali's Mirzaganj faces five charges including murder and rape. The three-member tribunal led by Justice Obaidul Hassan concluded the proceedings of the case against Forkan on June 14.

Wrapping up their arguments, the prosecution sought the capital punishment for Forkan, claiming that they had been able to prove all five charges brought against him. The defence on the other hand prayed for his acquittal, saying the charges could not be proved.

The tribunal-2 so far delivered 10 verdicts in as many war crimes cases, while the tribunal-1 passed nine judgments till date.

Forkan was an active supporter of the Muslim League, an anti-liberation party in 1971, joined the Razakar force, and carried out crimes under the local Razakar commander, says the prosecution.

Forkan was arrested in Barisal on June 25 last year. The tribunals' investigation agency completed the probe into the allegations against him on October 27 that same year, while the tribunal indicted him on December 18. The prosecution produced 14 witnesses including the investigation officer, while the defence produced four witnesses.

The five charges include the killing of four people including two local Awami League leaders in Mirzaganj on August 12; forcible religious conversion of three Hindu brothers in Subidkhali Bazar and their deportation; abduction, rape and subsequently death of a Hindu girl of Subidkhali Bazar on August 17 and 18; abduction and rape of two Hindu girls of Subidkhali Bazar on August 20 and 21 and deportation of their family; and abduction and rape of a Muslim woman and murder of another.

House owner shot dead by tenants

A house owner was shot dead by his tenants at Mirdha Bari in the capital's Jatra Bari early yesterday.

Mojibur Rahman, 55, of Nawabpur Road, was shot as soon as he stepped into the gate of his building around 3:00am, said police. Before shooting, the two tenants, who rented a room on the second floor of the building a few days back, confined the security guard to their room with his hand and legs tied, police quoted the guard as saying.

Mojibur with bullet wounds in his neck and back was rushed to Dhaka Medical College Hospital where doctors declared him dead. Police said they heard that the building had CCTV camera and the two were seen in the footage, but they could not ascertain the motive of the killing.

Hawker killed being sandwiched between two launches

A hawker was killed as he was sandwiched between two launches at Sadarghat launch terminal in the capital yesterday.

Mohammad Ibrahim, 20, standing on a rowing boat, was vending bread and biscuit to the launch passengers.

Fire service officials said Ibrahim sustained head injury as he was caught between MY Kamaphuli and MV Dighal and drowned in the river Buriganga around 1:00pm.

Fire service divers retrieved his body from the river around 4:00pm.

Incumbent Palestinian envoy ends tenure in Bangladesh

Palestinian Ambassador Shaher Mohammad is leaving Bangladesh after discharging nine-and-a-half-year-long diplomatic assignment in the country.

Shaher is considered as the longest serving diplomat in Bangladesh. He has also served as the dean of diplomatic corps and will leave soon, said the foreign ministry.

The outgoing envoy yesterday met Foreign Minister AH Mahmood Ali and thanked Prime Minister Sheikh Hasina for providing facilities to train Palestinian military officials in Bangladesh.

to four-lane ones.

While talking to Bandarban Deputy Commissioner's office through the videoconferencing, Hasina said construction of Thanchi-Alikadam Highway might have not been possible had the Bangladesh Army not been involved in the project as it has been built in one of the most remote, highest height and hilly areas of the country.

She hoped that the Thanchi-Alikadam road will play a very significant role in easing road communications and transportation of local products.

Speaking to Rangpur DC office also through videoconferencing, the prime minister urged the people to monitor the ongoing development activities across the country so that these are accomplished properly.

Meanwhile, Hasina said Eid holidaymakers might have been able to go home enjoying better comfort during the Eid-ul-Fitr had the BNP-Jamaat alliance not burned

might have been able to go to their homes more conveniently," she said.

Hasina made the remarks while inaugurating newly constructed state-of-the-art passenger ship "MV Madhumati" and two newly-built ferries of Bangladesh Inland Water Transport Corporation (BIWTC) through another videoconferencing from Gono Bhaban.

The newly built 75.50-meter long and 12.50-meter wide vessel is capable of accommodating 750 passengers, and has been constructed at a cost of Tk 26.58 crore by Western Marine Shipyard.

Speaking on the occasion, the prime minister said it was very much regretful that some days ago in the name of the movement BNP-Jamaat burnt buses and trucks. "They set fire to railway compartments...even launches couldn't escape their destructive hands," she said.

Hasina said the attack on the launches was first time in Bangladesh's history. "BNP-Jamaat can only commit such destructive activities." She also said the losses of various sectors during the BNP-Jamaat movement cannot be described in words.

She mentioned that steps have been taken to introduce new ships and steamers to further improve the shipping sector.

EXTORTION IN RAJDHANI SUPER MARKET

Rab to probe fresh allegations

Rapid Action Battalion will investigate fresh allegations of extortion at Rajdhani Super Market in the capital.

Jahangir Hossain Matubbar, commanding officer of Rab-10, said some traders alleged that illegal tolls were collected from street vendors in the last two days. He said they would soon send a team to verify the allegation, and take necessary steps if required. The allegation came after a mobile court on Thursday detained 10 ruling party men and seized extorted money around Tk 1.6 lakh from the detainees, said Rab. Meanwhile, local ward councillor Mainul Haq Manju yesterday alleged that Rab shut down the market committee's office after the raid on Thursday. Jahangir dismissed the claim saying they only detained those who were guilty of extortion.

special benefits to public servants.

In criminal cases, there is no barrier even to arrest public representatives including parliamentary members or ministers, he said. "Besides, earlier the High Court in its judgment termed such benefits, included in 32 (ka) of the Anti-Corruption Commission Act (Amended) 2013, anti-constitutional," he noted, adding that the proposed Public Service Act also went against the High Court judgment.

However, Cabinet Secretary M Musharraf Hossain Bhuiyan said the new law would not be in conflict with the existing ACC act. "Everything will remain within the framework of the constitution and existing laws. It's an epoch-making step as the appointment and other activities of the civil servants have been in discussion for a long time," he said. TIB suggested that experts and stakeholders' opinions about the draft should be taken into account before placing the act in parliament. The draft was approved by the cabinet on Monday.
