Bank official among 3 held for Tk 1.18 cr embezzlement

Members of Rapid Action Battalion (Rab) yesterday arrested three people including a bank official and his wife for embezzling Tk 1.18 crore from Sonali Bank's Tanore branch in the district.

The arrested are Nazir

Hossain, 35, an IT official of Sonali Bank Tanore branch, his wife Salma Jahan, 28, and Masud Hasan, 36, of Dori Khorbona area of Rajshahi city who sheltered Nazir Hossain after the embezzlement, Rab officials said at a press conference held at Rab-5 headquarters yesterday noon.

In separate raids, Rab officials held Nazir and Masud from a house in the city and Nazir's wife from Tanore upazila in the morning.

Nazir Hossain started embezzling the bank's money using his own passwords in 2011, said ASP Rezanur Rahman of Rab-5.

He deposited the embez-

zled money with two bank accounts opened in the names of his wife and his father.

He went into hiding in June this year when the matter was disclosed and the bank manager filed a case with the Anti-Corruption Commission on June 24, said the Rab official.

Abducted farmer traceless for 3 days

A farmer, who was abducted from Jhenidah court area on Sunday, still remains traceless.

The victim, Nazir Biswas, 55, hails from Narankandi village under Harinakundo upazila of the district.

Officer-in-Charge (OC) Ershadul Kabir of Harinakundo Police Station, said Nazir went to Jhenidah court on July 12 to file a case and remained missing since then.

On the night of July 13, the abductors phoned Nazir's family members, demanding Tk 5.50 lakh as ransom for his release.

Family members filed a general diary (GD) with Harinakundo Police Station the same day.

3.9 lakh to get special VGF rice before Eid in Nilphamari

The government has allocated 3,894 tonnes of rice for distribution among 3,89,414 VGF (Vulnerable Group Feeding) cardholders under six upazilas and four municipalities of the district on charge of misappropriating rice under Vulnerable Group Feeding (VGF) programme.

Of the total allocation, 646.63 tonnes of rice were allocated for 64,624 VGF beneficiaries in Dimla upazila, 516.52 tonnes for 51,652 beneficiaries in Domar, 750.23 tonnes for 75,023 in Jaldhaka, 543.89 tonnes for 54,389 in Kishoreganj upazila, 872.29 tonnes for 87,229 in Sadar upazila and 426.34 tonnes for 42,634 people in Saidpur upazila, sources at district relief and disaster management office said.

Besides, 46.21 tonnes of rice were allocated for 4,621 beneficiaries in Sadar municipality, 46.21 tonnes for 4,621 in Saidpur municipality, 30.81 tonnes for 3,081 people in Jaldhaka municipality and 15.40 tonnes for 1,540 beneficiaries under Domar municipality.

Each cardholder will get 10 kg of rice before the festival, Tajul Islam, district relief and disaster management officer, said.

MISAPPROPRIATION OF VGF RICE

UP chairman arrested in Sunamganj

Police on Monday arrested a union parishad (UP) chairman in Bishwambharpur upazila of the district on charge of misappropriating rice under Vulnerable Group Feeding (VGF) programme.

The arrestee is Soleyman Mia, 42, chairman of Palashpur Union Parishad (UP) under the upazila.

Sources said Soleyman received 266 sacks (each contains 50 kilograms) of rice from a government food godown to distribute among the VGF cardholders.

Later, the poor people who were in a queue for VGF rice on the premises of the UP office, took out a procession, chanting slogans against Soleyman. They later confined him to a room of the union parishad complex. On information, Upazila Nirbahi Officer Abdulla Al Mahamud along with a police team went to the spot and arrested the UP chairman.
