KMP to bring city under digital monitoring system

Khulna Metropolitan Police (KMP) has completed all preparations to set up internet protocol camera (IPC) at 72 important points in the city by December 2015.

KMP also have taken steps to distribute "modern secret video devices" and "special detective sunglasses" among the officials with a view to curbing crimes in the city.

A total of four IPCs have been set up at Picture Palace Intersection while other four IPCs have been set up in the city's Sonadanga bus terminal area, officials said.

The remaining IPCs will be set up at Shibbari, Moylapota, Gollamari, Royal Intersections, Rail Station, Launch Terminal, Rupsha Ferryghat, Daulatpur, Khalishpur, Khan Jahan Ali, Shiromony, Zero Point and other important places in the city, the sources said.

Seven killed, 12 injured in Munshiganj alone

Thirteen people were killed and 28 others injured in road accidents in four districts yesterday and Tuesday. Our Munshiganj correspondent

reports, seven people were killed and 12 others injured as a bus rammed a human-hauler in Nimtali area on Dhaka Mawa highway of Sirajdikhan upazila yesterday. The deceased were human hauler

driver Md Ershad, 35, Rassel Mia, 30, his wife Shima Akther, 25, and his 10-year-old niece Alo, of Hashara village, Madhuri Akther, 18, and Shipra Mondol, 28, of Laxmibilash village, and Alamin, 14, of Chaltipara village.

Following the accident, agitated locals blocked the highway and vandalised several vehicles halting the traffic movement for an hour.

Our staff correspondent from Chittagong reports, Josna Begum, 60, of Pahartali area was killed and a man was injured as a three-wheeler hit them while they were crossing the road in the Hajji Camp area of the city.

Charge framing hearing now

HALL-MARK LOAN SCAM

on Aug 20 COURT CORRESPONDENT

A Dhaka court yesterday deferred to August 20 for hearing on charge framing against 24 people, including Hall-Mark Group Chairman Jasmine Islam and its Managing Director Tanvir Mahmud, in 11 cases filed for misappropriating over Tk 2,600 crore from Sonali Bank.

The court passed the order as one of the accused Mainul Haque, now in jail, was not produced before it due to his illness.

The Bangladesh Bank in May 2012 unearthed a loan scam of over Tk 3,600 crore in Sonali Bank's Ruposhi Bangla Hotel branch. Of the sum, little known Hall-Mark Group alone took Tk 2,686 crore, using forged documents in connivance with some bank officials. Later, the central bank

handed the matter over to the Anti-Corruption Commission for investigation. In October 2012, the anti-

graft body filed the 11 cases against 27 top officials of Sonali Bank and Hall-Mark Group on charges of misappropriation of Tk 2,600 crore. In 2013, the ACC pressed

charges against 25 of them. But Atiqur Rahman, another accused and also a former deputy managing director of Sonali Bank died in a prison cell on August 25 last year. Six accused, including

Tanvir, are now in jail while Jasmine is on bail. The rest are absconding.
