

# EID RETURN TRIPS People suffer for tailbacks

People in numbers returned to the capital yesterday after celebrating the Eid with their dear ones at village homes.

Buses, trains and launches that entered the capital were filled up with passengers. Besides, many were seen travelling on the roofs of vehicles.

Some passengers suffered due to tailbacks at Kawrakandi ferry ghat in Madaripur and on Dhaka-Tangail highway.

Dhaka-bound vehicles from southern districts had to wait for hours to board ferries for crossing the Padma river through Kawrakandi-Shimulia route as the ferries were plying slowly for lack of navigability in the river, said passengers.

"A tailback of around 250 vehicles was created, and the vehicles might take several hours to cross the river," said Ashiquzzaman, assistant general manager of Bangladesh Inland Water Transport Corporation, who is in charge of Mawa ferry ghat.

He also added that operation of three ferries would be suspended at night due to navigability problem.

Apart from the three, 14 other ferries would continue plying.

Around 20km traffic jam was created on Dhaka-Tangail highway, from Rabda under Sadar upazila to Baoikhola of Basail upazila, yesterday afternoon following an accident in Gazipur. Eight people were killed as a train rammed their three-wheeler at a level crossing.

However, the gridlock eased in the evening, reports our Tangail correspondent.

People who used others routes enjoyed a hassle-free journey as vehicular movement on their routes was smooth.

Transport operators think home-goers' rush towards Dhaka will be more on Friday and Saturday.

# Australia backs turning Northern Territory into seventh state

Australian political leaders yesterday backed the establishment of the country's seventh state -- the Northern Territory -- by mid-2018, with Prime Minister Tony Abbott conceding the national flag could be changed.

The push for the Northern Territory, which has a population of 244,000 and is slightly smaller than Luxembourg, to be a state was initiated by Chief Minister Adam Giles who said it should not be a "second-class citizen" in Australia.

# Brutality at its worst

"Water? There's a lot of water down there," says the man with the stick, pointing to the river. "Go now and drink as much as you like."

Then the first man again kicks the body back into the water.

His head barely above the water, the boy feebly opens his mouth for more air but water, dirty and stinky, seeps through.

Crowds on the shore keep jeering at him and cursing him.

"Why can't he die?" says one.

"Say your last prayers to God ... And die!" says the other.

The boy makes one last frantic effort to move out of the water but fails.

The mob bursts into barbaric laughter at this. Some even clap in a sick display of what man is capable of.

This is no scene from some horror film; nor is it a work of fiction. It is all so real as it can be.

This is exactly how Najim Uddin, 16, was killed by a mob in the capital's Khilkhet area on April 13. He was the son of local vegetable vendor Jalal Uddin from Mastul village.

What was Najim's crime? He allegedly had stolen a pigeon from a neighbour's house.

This gruesome incident was videotaped and The Daily Star has obtained one of the clips.

Though he was alive till the end of the 5:39 minute long footage, he was later killed and his body was dumped in the nearby Balu river.

However, the family came to know about this incident not until April 17 when a neighbour, who claimed to have witnessed the incident, told them.

"I was told by locals that they started torturing my son from 3:00am and went on for six hours," Jalal told the Daily Star.

He filed a case with Khilkhet Police Station that very day.

Najim's body, meanwhile, was found in the Shitalakkhya river at Noapara of Rupganj in Narayanganj on April 16.

"The body was sent for an autopsy and later buried as an unidentified body," said Officer-in-Charge Jahurul Islam of Rupganj Police Station.

They had notified other police stations and sent a photo of the body.

Najim's parents saw the photo at Khilkhet Police Station and went to Rupganj to claim the body.

"To ascertain their claim, we collected DNA samples from the grave and sent those to the CID [Criminal Investigation Department] for screening," the OC said, adding that

they hadn't got the test result and the victim's family was yet to get the body even though more than three months had passed since then.

After Jalal filed the case on April 17, Khilkhet police had arrested three people, including witness Rajan. But none of them were seen taking part in the savagery.

So where are the real killers?

"The killers seen in the video have fled the area. We are trying to track them down," said Inspector Gholam Faruq of the Criminal Investigation Department. He is investigating the case.

Meanwhile, unhappy with the probe progress, the CID on Wednesday formed a three-member committee led by an assistant superintendent of police, said Special Superintendent of Police Mirza Abdullahel Baqui.

"We will scrutinise the process of investigation. If we find a lack of sincerity in the investigation, we will take actions against the official concerned," he added.

In a similar incident of savagery, a mob beat Samiul Islam Rajan, 13, to death in Sylhet on July 8 for "trying to steal a rickshaw".

Sources at the elite force said some of the detainees could be ruling party men.

Lt Col Khandaker Golam Sarwar, commanding officer of Rab-3, said on information they raided the Rajuk Bhaban around 3:00pm and arrested the six who were trying to snatch the tender documents of a Rajuk project.

Some 15 to 20 men were trying to snatch the tender files in front of police, said a Rab press release.

Rajuk had floated the tender of Tk 30 crore for the construction of internal roads and surface drains at different sectors of Purbachal New Town Project. Yesterday was the last day for submitting the bidding documents.

Project Director Anwar Hossain, however, last night told The Daily Star that he knew nothing about the detainees or yesterday's incident.

Earlier this month, 10 alleged ruling party men were awarded different terms of imprisonment for extorting money from businessmen of a supermarket in the capital's Tikatuli.

Later, Jubo league expelled its Publication Secretary Iqbal Mahmud from the organisation for his involvement with the extortion.

# RAJON KILLING Charge sheet by Monday

Police will submit charge sheet in the murder case of teenager Samiul Alam Rajon by Monday, says Law Minister Anisul Huq.

"The case will then be sent to a speedy trial tribunal for its quick disposal," he said yesterday.

The minister was talking to reporters after attending the inaugural of a two-month training course for newly appointed assistant judges at the Judicial Administration Training Institute in Dhaka.

"I will ensure that the prosecution will extend all cooperation to hold the trial in short time. I hope that an exemplary punishment will be given to the people involved in the killing of Rajon so that nobody dares to commit such offence in the future," Anisul warned.

Rajon died of brain haemorrhage after he was tortured by a group of brutes who were "punishing" him in Kumargaon Bus Stand area of Sylhet on July 8 on charges of theft. Around 64 injury marks were found in his body.

Twelve people, including the four accused in the murder case, have been held, reports our Moulvibazar correspondent.

Jalalabad police filed the case, accusing Muhith Alam, his brother Kamrul Islam, their accomplice Ali Haider and security guard Moyna Mia.

Meanwhile, Haider yesterday confessed to his involvement in the crime, said Suranjit Talukdar, investigation officer of the case. He is the seventh to have given confessional statement under Section 164.

Sylhet Metropolitan Magistrate Sajedul Karim recorded the statement, said Suranjit. The magistrate then sent Haider to jail.

Locals caught and handed over Haider to police when he was trying to take away the body of Rajon after torturing him to death.

Farhana Yesmin, judge of Sylhet Metropolitan Magistrate's Court-2, yesterday granted five days of remand for Badal Mia, the 12th person who was caught and handed over to police by locals on Wednesday.

Earlier, Suranjit produced Badal before the court and sought his remand for 10 days.

Badal, a worker of a garage near Jalalabad where Rajon was beaten up cruelly, is a witness to the incident.

Mentioning the names of the cases against Hasina, Mahbub asked Harun-or-Rashid, deputy director of the Anti-Corruption Commission, whether he knew about all those cases.

Harun, also plaintiff of the Zia Charitable Trust graft case, replied in the negative.

Then Mosharraf Hossain Kajol, chief public prosecutor of the case, interrupted Mahbub and said the ACC did not withdraw any of those cases filed against Hasina.

All these cases were either dismissed or quashed by the Supreme Court on different dates, he said.

So the question regarding those cases was irrelevant, Kajol said.

Judge Abu Ahmed Jamadar of the Special Judge Court-3 was seen taking notes while Mahbub was questioning the ACC deputy director.

Kajol appealed to the court not to take note of Mahbub's statement on the cases filed against Hasina.

While Kajol was placing the appeal before the judge, Mahbub brought before the court the murder case filed against Hasina in connection with the Paltan killing in October 2006.

Mahbub said the murder case was also withdrawn, and asked Harun, the ACC deputy director, if he had any knowledge of the case.

Before Harun replied, the judge termed the question irrelevant and said he would not take note of it. Then Mahbub asked Harun different questions on the graft case.

During the proceeding, Khaleda Zia was sitting on a chair with the permission of the court at Bakshibazar in the capital.

The judge recorded the statement of

the witness in the case.

Later, the court adjourned the proceedings of the Zia Charitable Trust and the Zia Orphanage Trust graft cases until August 3 following an application by the defence.

The witness, Harun, denied the allegation that he acted on instructions of the government.

"I filed the case after a woman submitted a complaint about the Zia Charitable Trust graft case," the ACC deputy director said, adding that he did not do it for harassing any of the accused, including Khaleda Zia.

In reply to a question from the defence, the witness said they had documentary evidence that Khaleda Zia collected money from different people in the name of raising funds.

Meanwhile, AM Mahbub Uddin Khokon, another counsel for Khaleda, pleaded unconditional apology after the judge took an initiative against one of the defence lawyers for his indecent remark about a public prosecutor.

# Death lurks

The train ran him over in the blink of an eye.

Such accidental deaths are quite common in Bangladesh. The Daily Star, gathering its reports on train accidents from 2008-2015, has found that 50 percent of the dead were jaywalkers.

Many of the victims were either crossing the railway line or walking on the tracks like Sabbir. A number of the victims were talking over their mobile phones.

According to the road accident stories between 2010 and present, The Daily Star found jaywalkers accounted for 40 percent of all reported deaths due to road accidents in Dhaka city.

On average, 100 railway accidental deaths were reported in a year between 2008 and 2015.

Collision between trains and other vehicles is also a common incident that claimed lives.

The Daily Star reported 122 such incidents since 2008. Of the cases, 23 percents involved trains and buses.

Reckless driving as well as the absence of gatemen at the level crossings are the contributing factors.

According to Bangladesh Railway data, only 13 percent of 1,550 level crossings are manned round the clock.

Many people risk their lives riding on the roof of trains.

In many cases, victims fell from trains while climbing up to the roof while many were hit by bridge girders.

countries.

A total of 979 dwellers in Indian enclaves inside Bangladesh territory have expressed willingness to move to India. But the question arose how their property-related problems would be resolved, officials said.

"We discussed how the 979 people would travel to India and what would happen to their properties in Bangladesh," said Shafiqur Rahman, joint secretary of the home ministry.

The meeting decided that Bangladesh will issue travel documents to the 979 while India will grant them multiple-entry visas.

A joint secretary of the Indian external affairs ministry and Abu Hena Md Rahmatul Muneem, additional secretary of the Bangladesh home ministry, led their respective sides at the meeting.

According to the census of 2011, there were 37,364 people in 111 Indian enclaves, covering 17,158 acres in Kurigram, Lalmonirhat, Nilphamari and Panchagarh districts of Bangladesh.

However, the joint survey conducted earlier this month found that 41,449 people are there.

Talking to BBC Bangla Service, Deputy Commissioner Habibur Rahman of Lalmonirhat said the issue of some 35 people who claimed to have been excluded from a census, also came under discussion during the meeting.

At least 14,215 people are living in 51 Bangladeshi enclaves covering 7,110 acres of Indian land. But none of them were willing to move to Bangladesh.

# Greece passes

The report underlined the headwinds facing leftwing Prime Minister Alexis Tsipras, who must negotiate a bailout worth up to 86 billion euros with sceptical lenders, while struggling to hold his divided Syriza party together.

While his own personal popularity is high, a renewed drop into recession after a modest recovery last year would test his government's ability to push through the tough mix of tax hikes, spending cuts and economic reforms demanded by the lenders.

Formal negotiations with officials from the European Commission, European Central Bank and International Monetary Fund are due to start in Athens today with the aim of wrapping them up by Aug 20.

But already there have been doubts about whether the severely weakened Greek economy can support the program after a six year-long slump that has cut national output by a quarter and sent unemployment over 25 percent.

Banks have re-opened after the ECB restored emergency funding last week but capital controls remain in place, hobbling companies that deal with suppliers outside Greece and highlighting the fragile state of the financial system.

A senior Greek official yesterday said that Greece would not reach a one percent primary budget surplus, net of interest rate payments, this year, missing a target agreed with the lenders prior to the imposition of capital controls.

The banks, which would collapse immediately without the ECB's emergency funding, face recapitalization but how much the operation will cost will only be known after banking stress tests due to start in August, the official said.

After debating the bailout reforms in parliament until near dawn, 36 Syriza rebels defied the government, forcing Tsipras to rely on pro-European opposition parties to pass the measure and raising the prospect of a snap election once the deal is sealed.

The rebellion was slightly smaller than in a vote on a first bailout bill last week when 39 Syriza lawmakers dissented. But it confirmed the deep split in the radical leftwing party, which won power in January vowing to end austerity.

State Minister Nikos Pappas, one of Tsipras' closest aides, told the semi-state Athens News Agency that the government would move to complete the bailout negotiations before taking a decision on its next political move.

"Unfortunately, a rupture has been confirmed but I think we will get the procedures for the deal concluded first and then we will look into all these things at the party," he said.

If the talks are not completed in time, European authorities who provided a 7 billion euro bridging loan to allow Athens to meet debt repayments this week, may have to provide further temporary financing. European Economic Affairs Commissioner Pierre Moscovici said that a change in the rules governing the EFSM, an EU fund that was used to provide the first bridging loan, would enable the fund to be used for a second loan. The new rules provide a guarantee to non-euro member states which had been concerned that the fund, intended for the full 28-member EU rather than the narrower group of countries in the single currency, was being diverted to bailout the euro.

without loosening his grip even when the latter stabbed him indiscriminately.

Parvez died yesterday in the line of duty around 10:00am at a local hospital.

The incident took place in the morning around 7:30am near the Golchokkor field in Baharchora area of the beach town.

Jahirul Islam, additional police super (ASP) of Cox's Bazar Tourist Police, said his team that included Parvez heard the cries of tourist Zakir Hossain, who had been attacked by a gang of six muggers.

The thugs robbed Zakir of Tk 6,000 and were running away. The police team chased them and Parvez caught one named Abu Taher by the arm, said Jahirul.

Taher soon brought out a knife and fatally stabbed Parvez to set himself free, the ASP said.

Among the muggers police were able to catch Taher, 28, and Abdul Malek, 24.


Parvez was immediately rushed to the General Hospital where he succumbed to his injuries about two hours later.

Parvez's body was sent to his ancestral village after an autopsy was carried out around 12:00pm, police sources said.

The slain cop was the son of Mohammad Bashir from Burirchanguapazila in Comilla.

The ASP said they would thoroughly raid the area to arrest the rest of the muggers.

Inspector General of Police (IGP) AKM Shahidul Haque expressed his deep shock at Parvez's death in a statement.
