# Stop distribution of Brazilian wheat

Supreme Court asks govt

The Supreme Court yesterday ordered the government to stop distribution of wheat imported from Brazil as its quality had been questioned.

The food office has already distributed more than 1.5 lakh tonnes to those who are on the government's safety net schemes, including Food for Work, Test Relief and also as ration for the police, sources said.

The remaining wheat will not be distributed to any organisation or department until further order, the apex court told Attorney General Mahbubey Alam.

Furthermore, the four-member Appellate Division bench extended for two weeks a stay order on the High Court verdict that directed the government to take back wheat from an organisation if it was willing to return it.

The bench, headed by Chief Justice Surendra Kumar Sinha, also asked the government to file a leave to appeal petition in two weeks with the SC against the HC verdict.

The apex court came up with the order while hearing a petition moved by the government. The attorney general told the court

After testing some samples in its own laboratories last month, the food ministry claimed that the grains were "fit for human consumption" and the quality "conforms to the contract specifications."

On January 6, the BNP-led alliance launched a non-stop blockade and a series of hartals over the same demand.

But the ruling AL has been rigid on its stand that the election will be held in line with the constitution, meaning the polls will be held under the AL government.

Talking to The Daily Star, BNP Standing Committee Member Moudud Ahmed, who was present at Saturday's meeting, said, "The party chief's approach was different. But the substance of her statement remains the same which means the next parliamentary election must be held under a

non-partisan government.

"As the government has been opposing the term -- caretaker government, she took a realistic approach and didn't use that term. Instead, she said the election-time government can be called by any name. We just want a free, fair and inclusive election," said Moudud.

The BNP chief stated categorically that there would be no election under the AL government. The pollstime government must be comprised of non-political and neutral persons, and that is what the BNP chief wanted to mean in her statement, he added.

Asked, another BNP Standing Committee Member Mahbubur Rahman said the BNP chief, through her statement, invited the ruling party to hold discussions on how to hold a free and fair election, and it was definitely a positive initiative from her

"I believe the BNP chairperson wanted to mean that the party is not sticking to its demand for reinstating the 13th amendment to the constitution regarding caretaker government. Instead, she urged the Awami League government to decide on the formation of the election-time government through dialogue," he added.

#### Iraq retakes key university on edge of Ramadi

Iraqi government forces recaptured a university campus yesterday on the outskirts of Ramadi from the Islamic State group, seizing a key position for any offensive to retake the city, officials said.

Iraqi forces had recaptured parts of Anbar University in May, shortly after losing the provincial capital to the jihadists, but later pulled back.

The university was retaken by elite forces from Iraq's Counter Terrorism Service (CTS), known as the "Golden Brigade".

"The Golden Brigade managed to liberate Anbar University with backing from the army as well as air support from the coalition and Iraqi aircraft," Brigadier General Abdelamir al-Khazraji, deputy commander of CTS forces in Anbar, said.

"Our forces liberated the university early Sunday and now have full control of it, following a week of fierce clashes," he told AFP.

"The Iraqi flag is flying above the university presidency once again," he

A statement from CTS said the Iraqi special forces had "inflicted heavy human and material losses to the enemy."
