Nine held for leaking exam questions

Detectives on Sunday arrested nine people, including three college teachers, in Dhaka and Jessore in connection with HSC and other exams' questions leak.

In Dhaka, three teachers of a Demra college, Nazmul, Hasan and Kamrul, were arrested for their involvement with a gang which used to swindle HSC examinees by offering them to improve their grades or leak questions in exchange for money.

They were arrested on the basis of a confessional statement given by their ringleader Raihan Chowdhury who along with five others was arrested on July 15, said Dhaka Metropolitan Police (DMP) Joint Commissioner Monirul Islam at a press conference yesterday. Raihan used to contact HSC examinees on Facebook through an account named after American crime thriller writer Dan Brown. Police learnt about the group when about 10 students, each of whom paid different amounts, filed complaints.

Meanwhile, police arrested Suman Ahmed, Rahman, Rahman alias Liton, SM Tanvir Alam alias Rizvi, Johny Rahman and Arafat Hossain with question papers of the semester final exam of a private polytechnic institute in Jessore which is scheduled for August 12.

Police also seized a tablet computer and six smart phones which they used for leaking and distributing questions using the internet.

Man accuses cops of shooting him after arrest in Ctg

Bayezid OC claims his cohorts did it during gunfight with police

A 20-year-old man arrested in Chittagong city's Amin Colony field on Sunday says police hours later deliberately shot him in the calf from a close range while the accused claim his cohorts fired the pellets during a gunfight with law enforcers.

Hasan, a resident of the colony and now undergoing treat

ment at Chittagong Medical College Hospital, said he was taken to Bayezid Police Station following the arrest at 5:00pm. He claimed to have been shot after being taken to

Oxygen, a place he was able to make out despite being blindfolded, around 2:00am yesterday, some two kilometres from the colony. His mother Maya Begum told The Daily Star that Zakir

Hossain, general secretary of Awami League's organisational ward 43's A unit, bribed police to maim Hasan. Hasan and his friends had a scuffle with Zakir early July after the latter confronted and accused them of mugging a

relative on the field, she added. The officer-in-charge (OC), Pradip Kumar Das, said Hasan was arrested at 9:00pm with a kirich (a type of a knife) on his person and information he provided led to the seizure of 11 more from the residence of a local friend of his, Rahman.

He said a 15-member police team and Hasan were going to the residence to arrest Rahman yesterday around 2:00am when some 10-15 cohorts of Hasan shot at them from the field, leading to the 15-minute gunfight. SEE PAGE 10 COL 4

Filling station accused of tampering with pumps

Shuts down temporarily after consumers lay siege to it, reopens with cop assistance; motorcyclist starts agitation suspecting stealing of fuel by the station authorities

A state-owned filling station in the capital's Poribagh was shut down for several hours yesterday after some 50 customers laid siege to it alleging that it was selling short measures of petrol by tampering with a dispenser.

Meghna Model Service Centre was shut from around noon and opened with police assistance around 6:00pm. During the agitation, police took away its in-charge, Md Mahbubun Nur, to Shahbagh Police Station around 2:20pm.

Mohammad Ali, the motorcyclist who started the agitation, said for several weeks it felt like his two-wheeler's mileage

dropped whenever he refilled there. "I have asked them several times to get a BSTI-approved pot or something to prove that they are not cheating...But they always say that they do not have any pot," he

told The Daily Star. Ali said yesterday he brought a five-

litre capacity jar approved by the Bangladesh Standards and Testing Institution (BSTI) and asked the salesperson to pour petrol in it.

"Seeing the jar, they first said they

shedding, and after a while they said they ran out of fuel," he said. Ali fears that the station authorities

could not give petrol because of load

had been stealing around two litres from every 10 litres customers bought.

Md Mahbubun Nur said, "It was sheer bad luck that we ran out of fuel when we needed to prove that our measurement was flawless."

Nur also claimed that a loaded tanker had arrived around 40 minutes after the agitation started but could not enter for the "angry mob". "They (customers) kept saying that we would have to give them fuel with-

out touching the machines," he said. Asked how often they ran out of fuel, Nur said it was the third time in the last one year.

HC questions legality of Sylhet stone crushers

The High Court yesterday questioned the legality of setting up and operation of stone crushing machines in Sylhet. It issued a rule asking the government to explain in four

weeks as to why setting up and running of such machines at different areas of Sylhet sadar, its Companiganj, Goainghat, Jointapur and Kanaighat upazilas should not be declared

The HC bench of Justice Farah Mahbub and Justice Kazi Md Ejarul Haque Akondo came up with the rule after hearing a writ petition filed by Bangladesh Environment Lawyers Association.

The organization submitted the petition seeking necessary order from the HC on the authorities concerned of the government to stop operation of illegal and uncontrolled stone crushing machines at the said areas.
