DEMAND FOR SEPARATE PAYSCALE

CU, RU teachers abstain from work

Teachers of Chittagong and Rajshahi universities yesterday observed a daylong work abstention protesting the proposed eighth payscale.

Chittagong University Teachers' Association (Cuta) demonstrated demanding a separate payscale for university teachers, according to our CU correspondent.

However, examinations remained out of purview of the protest programme.

Cuta leaders termed the payscale "discriminatory" and sought intervention of the prime minister for a separate payscale.

Cuta General Secretary Kazi SM Khasrul said all teachers of the university expressed solidarity with their protest

He threatened to go for tougher movement if their demand was not met.

Meanwhile, RU teachers observed work abstention and also organised a sit-in on the campus demanding revision of the eighth payscale, reports our RU correspondent.

They also demanded a separate payscale for university teachers.

Over two hundred teachers under the banner "RU Teachers' Association" observed the sit-in from 10:00am till noon in front of the senate bhaban.

DSCC mayor reprimands Half of Ctg dist vehicles unfit get bail in

Around 44,000 motor vehicles out of the total 82,406 registered ones are plying the roads and highways in Chittagong district without fitness putting the lives of the travellers at danger.

However, the figure excludes the number of motorbikes, said sources of Bangladesh Road Transport Authority, Chittagong. Commuters said during travelling,

many vehicles broke down in the middle of their journeys, and they had to take other vehicles to reach their destinations.

They urged the authorities concerned to take action against such unfit vehicles.

A private firm employee, Mohammad Hossain, who has to commute from Chowdhuryhat in Hathazari upazila to Golpahar in the city, said he faced such troubles.

"The human haulers go out of order very often," he said, adding, "It is very annoying.

Echoing him, Aminul Ahsan, another commuter, said he is always in fear of accidents while travelling in such vehicles.

Fearing that the vehicles will catch fire, passengers of human haulers sometimes asked the drivers to pull over as they see the vehicles emitting a lot of thick black smoke, said Abul Bashar, a street vendor in the city's Prabartok.

Sima Akter, a master's student of Chittagong College, who travels from Gate No-2 area to Chawkbazar regularly, said all the way she remained tensed whether she could reach her destination safely.

Half of the motor vehicles are plying the streets in Chittagong without fitness certificates defying a ban, BRTA sources said. Fitness depends on the proper func-

tioning of different parts of the vehicle including brakes, gears, horns and lights, the sources said, adding that those had to be fit externally too. Md Sirajul Islam, deputy director of

BRTA, Chittagong, told The Daily Star that they conducted mobile courts against unfit vehicles regularly.

Now they expedited such drives, he added.

Masud Ul Hasan, deputy commissioner (traffic-north) of Chittagong Metropolitan Police, said they also conducted drives against the vehicles on a regular basis.

The drives will be increased when they will get the official papers of a High Court order, he added.

The HC on August 3 directed the government to immediately stop operation of all unfit motor vehicles across the country. Issuing a suo moto rule, the court

also ordered the authorities concerned

to freeze around 19 lakh fake driving licences. The HC bench of Justice Quazi-Reza-Ul Haque and Justice Abu Taher Md Saifur Rahman asked the authori-

persons who are using fake licences. Besides, the court also asked the BRTA chairman to submit a report after complying with the order in 30

by a teacher and two students of Daffodil University.

They submitted the petition last week challenging the NBR notification saying that the notification is discriminatory and illegal, since such VAT was not imposed of the tuition fees of the students of public universities and institutions.

Every student has equal rights to get education as per the constitution, they said in the petition.

During hearing yesterday, petitioners' lawyer Hassan MS Azim told the court that education is not a commodity and therefore, VAT is not applicable on it. Education is a basic principle of state policy and the government is constitutionally obliged to give opportunity to the nation for higher education, but the government has failed to give sufficient opportunity to all citizens, he said. The lawyer argued that the deprived citizens have been making own arrangements by going to private universities for education, so the government cannot impose any extra tax on them in the name of VAT.

Mohiuddin Chy gets bail in graft case

A Chittagong court yesterday granted bail to former Chittagong City Corporation (CCC) mayor ABM Mohiuddin Chowdhury and 15 others in a graft case.

According to the first information report (FIR), Mohiuddin during his second term as CCC mayor in 1997 allocated 23 shops of CCC in the port city's Muradpur violating rules and abusing power.

On October 13, 2002, the then Anti-Corruption Bureau filed the case. The court fixed September 22 for the next hearing.
