The convict is Mohammad Sohel Khan, 24, of Kaliganj in Gazipur.

According to the verdict, on the night of July 2, 2013 Sohel hid in the girl's room. When she fell asleep, he took the girl to a nearby field and raped her there.

The victim's grandfather heard her screams and came out to see Sohel raping her. Seeing the

grandfather, Sohel fled. Later, the victim's father filed a case against Sohel and he was arrested.

Strong land commission for plain land Adivasis sought

Indigenous lawyers present draft of law at seminar

The separate land commission demanded for the plain land indigenous people of the country should have the power to take legal action rather than just make recommendations to the government, speakers said at a national seminar yesterday.

"The commission should have teeth. It should not exist in name only," said Khushi Kabir, coordinator of Nijera Kori.

Time has also come to establish a ministry for all indigenous people of the country, both from plain land and the hills, she told the national seminar on "Separate Land Commission for the Plain Land Indigenous Population: Specific Recommendations".

Other discussants echoed her at the programme, organised by Manusher Jonno Foundation (MJF), Jatiya Adivasi Parishad, and Indigenous Peoples Development Services (IPDS) jointly at the capital's Bangla Academy yesterday as part of the two-day celebration of Indigenous Peoples on August 9.

"The land of plain land indigenous people cannot be protected under the current land laws of the country," said Sanjeeb Drong, general secretary of Bangladesh Adivasi Forum, citing several instances of eviction of plain land Adivasis from their land. He said that as indigenous people

used the land collectively and had a spiritual relationship with land, they never had any ownership documents, required by the country's law. This gave government offices reason

to evict the indigenous people from the area, in which they had been living for ages, he said.

Supreme Court lawyer Titus Hillol Rema, member of Bangladesh Indigenous Lawyers Association, presented a draft law with six chapters and 21 sections for creation of the commission. The draft also attached a list of 36 indigenous plain land

communities of the country. History professor at Dhaka University Mesbah Kamal, however, said that through his research, he found 76 indigenous communities in International Day of the World's the country. Care must be taken so that no community is left out, he said.

Sara Hossain, honorary executive director of Bangladesh Legal Aid and Services Trust (BLAST), said, "You can try to give the law constitutional protection so that no government can

change it as they wish." Fazle Hossain Badshah MP, convener of the parliamentary caucus on indigenous affairs, referred to the draft law on the rights commission for indigenous people, which the caucus plans to present in parliament as a private bill soon.

Noting that establishing a separate land commission for plain land communities was part of Awami League's election manifesto both in 2010 and 2014, lawmaker Md Abdur Razzak said a mass movement was required to remind government of its promise.

Robaet Ferdous, associate professor of mass communication and journalism, DU, suggested establishing the headquarters of the land commission outside Dhaka.



It also found that new mothers are considered impure and are not allowed to eat with other family members until the purification ceremony is held in Marma community after birth of a child; mother is only given salt, water and rice at least for two weeks and some babies are fed earlier than the recommended age (6 months) because mothers have to go to work in jhum land.

MJF recommended that local knowledge, wisdom and practice should be analysed, documented, disseminated and considered in designing an intervention and a multi-sector approach -- advocacy, community-specific info, development of IEC (information, education and communication) materials -- should be applied.

Homeopathic medicine shop owners jailed,

A mobile court yesterday penalised the owners of two unauthorised homeopathic medicine shops in the capital's Jatrabari for producing drugs in unhygienic conditions and using harmful ingredients.

Padma Homeo Laboratory at Kazirgaon was sealed off and owner Md Bulbul Ahmed, 46, was jailed for two years and fined Tk 2 lakh, and if he defaults, he has to serve two

more months in prison, said a press release of the Rapid Action Battalion-10 (Rab). The Rab-backed court also fined Nirmal Barman, 62, owner of Harbo Laboratories at South Jatrabari, and realised the money.

apology to the tribunal for his comment on June 10 that drew contempt of court proceedings against him. Zafrullah, if found guilty, may face up to one year imprisonment or Tk 5,000 fine or both. The tribunal on July 12 initiated contempt of court proceedings against Zafrullah for his comments on June 10 over the punishment of Dhaka-based British journalist David Bergman.

"Today's contempt of court verdict is a proof of mental illness of the three judges ... Ensuring justice is not possible if the judges can't take criticism. When they can't stand criticism and lack rationality, they hide themselves under the cover of law," he had told reporters on June 10.

During hearing yesterday, Zafrullah's lawyer Abdul Baset Majumder said his client "completely surrendered himself" before the tribunal.
