Demand for VAT-free Education

Pvt university students to go to PMO today

Private university students will demonstrate before the Prime Minister's Office in the capital today demanding withdrawal of 7.5 percent VAT (value added tax), which is set to be charged on their education from this current fiscal year.

Students of State University, University of Liberal Arts Bangladesh, and East West University under the banner of "No VAT on Education" yesterday organised a press conference at Dhaka University's Madhur Canteen to make the announcement.

Meanwhile, at an International Youth Day programme at Bangla Academy, Dr Iftekharuzzaman, executive director of Transparency International Bangladesh, said, "The decision of imposing tax without discussing with the stakeholders is illogical." In Chittagong city, students of Premier University, East Delta University, BGC Trust University, and USTC Medical College formed a human chain at Prabartak intersection to realise their demand.

Ruet suspends 2nd year classes amid protest

Students demand resumption within three days scrapping new system; threaten tougher movement otherwise

The academic council of Rajshahi University of Engineering and Technology (Ruet) yesterday suspended all academic activities for honours second year students following their agitation for withdrawal of a new credit

The decision has been taken after the students did not respond to their teachers' call to attend classes stopping their "illogical movement", Prof Rafigul Alam Beg, vice chancellor of Ruet, told The Daily Star. The vice chancellor, however, on Tuesday told journalists that they would consider the demand.

The students at a press conference on the campus yesterday threatened to launch tougher programmes if the authorities do not resume classes within three days after fulfilling their demand.

Earlier in the morning, some 50 students attempted to besiege the administrative building but police foiled their several bids.

They later marched on the campus and held a protest rally there.

The second year honours students started the agitation on Tuesday

demanding change in the new credit system introduced in 2013 that made mandatory for the students to secure at least 33 credits, out of 40, in an academic year. If any student fails to secure the mandatory credits in two semester examinations in a year, he or she has to restart the academic year with junior students.

Earlier, the students were allowed to be promoted to the next year despite being unsuccessful in several courses. Out of 725 students, 29 could not secure the required credits in the examinations to be promoted to the second year.

'DOMESTIC VIOLENCE BY ARMY OFFICER'

HC stays transfer of case to military court

The High Court yesterday stayed a move to transfer a case against an army officer over the torture of his wife to a military court from a special tribunal.

Responding to a writ petition, it also stayed the proceedings of the case filed against Maj Nazir Uddin for brutalising his wife Nusrat Jahan Tushti, also a student of Dhaka University, for dowry on March 30.

The case was filed with the Women and Children Repression Prevention Tribunal of Tangail on April 2.

The petitioner's lawyer, Aneek R Haque, told The Daily Star that Area Commander (Logistics) of Army Headquarter Maj Gen Mizanur Rahman Khan on May 11 sent a letter to the judge of the Tangail court, stating that the case against Nazir should be tried in a military court, since the accused was an

army officer. In the letter, Mizanur also asked the Tangail court to

transfer the case to the court-martial for its trial, he said. The HC yesterday issued a rule asking the authorities concerned to explain in two weeks why the letter sent by the

army general should not be declared illegal. It also stayed the proceedings of the case and effective-

ness of the letter till disposal of the rule. The bench of Justice Mirza Hussain Haider and Justice AKM Zahirul Hoque came up with the rule and order after hearing the writ petition filed by Tushti's father Nurul Islam

Bhuiyan challenging the legality of the army official's letter. Aneek R Haque said after hearing the rule, the HC would

decide which court should try the case. Citing from the petition, he said the court-martial had no jurisdiction to hold the trial of the case filed under the

women and children repression prevention act. Nazir faces three years' imprisonment if found guilty by the Tangail court and a one-year jail sentence if convicted by

the court-martial, the lawyer said. Secretaries to the ministries of defence and law, area commander (logistics) of the army headquarters, chief of the army staff, judge of the Women and Children Repression Prevention Tribunal of Tangail, and judge advocate general of the army headquarters were made respondents to the rule, Aneek added.
