JS goes into session on Sept 1

The 10th parliament goes into its seventh session on September 1.

President Abdul Hamid convened the session, exercising his power bestowed upon him by Article 72 (1) of the constitution, a release of the parliament secretariat said yesterday.

The House is set to sit at 5:00pm that day.

Before that, the business advisory committee of parliament will have a meeting with Speaker Shirin Sharmin Chaudhury in the chair to decide duration and businesses of the session.

Sources at the parliament secretariat said the session might continue for a short period of time.

According to the constitution, the president must convene a session within 60 days of the last sitting of the previous session and the first sitting of the next session.

The last session, which was a budget one, was prorogued on July 8 with 26 working days. The 10th parliament was formed

through the January 5, 2014 election boycotted by the BNP-led 20party alliance and most other political parties.

The maiden session of the House took place between January 29 and April 10 last year.

> Joint team to verify complaints tomorrow

An India-Bangladesh joint team is set to begin verification of complaints filed by people of 32 former Indian enclaves inside Bangladesh tomorrow.

According to the Kurigram district administration, a number of people have submitted complaints to the Cooch Bihar district magistrate in India and the upazila nirbahi officers (UNO) concerned in Bangladesh during the recent India-Bangladesh not place their right choices due to "local threats".

The Indian team would also visit Haldibari, Burimari-Changrabandha and Shahebganj-Bagvandar -- besides verifying the complaints.

"A two-member Indian team will hold hearing on six complaints in Dashiarchhara [enclave] in Kurigram. An executive magistrate from Bangladesh will be included in the team," said Aktar Hossain, additional deputy commissioner (General) in Kurigram.

Members of the team are Rabindra Nath Bosh and Md Nur Alom, deputy district magistrates of Cooch Bihar district in India, and Nasir Uddin Mahmud, UNO of Phulbari.

The team would also verify the Shahebganj-Bagvandar border checkpoint where enclave people [who have been interested to take Indian citizenship] would be checked before entering India, the ADC added.

The Indian team would hold hearings on six complaints in Dashiarchhara of Phulbari upazila. Five enclave people have appealed to the Cooch Bihar district magistrate and one to the Phulbari UNO to take Indian citizenship.

social media. The sickening torture video shook the nation to its core and stirred outcries in the social network and the mainstream media.

Tied to a pole, the boy screamed for The investigation officer prayed to help, cried for water and begged for his life. But the group showed no mercy. They laughed, joked and filmed their detainees -- Lipi Begum and Ismail Hossain Ablush -- of the charges as madness to show it off to people.

In the video footage that went viral, Kamrul, in a black T-shirt and lungi, was seen hitting the boy with a stick in the feet, joints of legs, shoulders and in the head.

They kept beating him, at times Rajon's father Sheikh Azizur knocking him down to the ground,

the beating. When Rajon cried for water, they told him to drink his own sweat.

The boy died of brain haemorrhage. His body bore 64 injury marks.

After the killing, the culprits were taking his body on a microbus to dump it in a secluded place, but the locals spotted them and managed to catch one of them. The police recovered the body from the microbus. A murder case was filed with

Jalalabad Police Station on July 8 night.

On July 13, some expatriate Bangladeshis spotted Kamrul in Jeddah, caught him and handed him over to the Bangladesh mission there. Later, Jeddah police took him into custody.

Sylhet Metropolitan Police closed officer-in-charge of Jalalabad Police Station Alamgir Hossain and suspended sub-inspectors Aminul Islam and Zakir Hossain on July 24 after a probe found their negligence in arresting the killers.

When eight-month pregnant Nazma was shot in the lower abdomen during a clash between two factions of Magura Jubo League on July 23, her unborn baby too sustained critical injuries in the shoulder and in one of her eyes.

Although both of them survived after a two-hour caesarean operation, doctors in Magura hadn't expected that the bullet-injured newborn would be able to cling to life.

Suraiya was immediately rushed to the DMCH where doctors saved her putting in a commendable collective effort. However, Nazma stayed in Magura to recuperate but was brought to the DMCH about a week later to

breastfeed Suraiya as per doctors' advice. Until yesterday Nazma could visit

Suraiya now and then to breastfeed her but from now on the two can stay together, said doctors at the DMCH. Dr Kaniz said they were so relieved

that they could finally give the baby to her mother. She said although the mother and

the baby are out of danger now, the baby is still at risk of infection for her low birth weight. "We will observe both of them for three

or four more days before deciding on their discharge," she told The Daily Star. A team from National Institute of

Ophthalmology and Hospital will examine the baby's eye injury on Monday, she added.

of police officers involved in countermilitancy drives, said not trying the arrested militants has become a major setback in fighting the elements. They said the militants sentenced to death could not be executed as they are

accused in dozens of serial bombing cases and the trials are yet to be completed. "From jails, the convicted terrorists

are playing a big role in spreading militancy. They even meet their followers as they are frequently being shifting from one jail to another for case hearings," one of the officers said.

Prof Ziaur Rahman, chairman of Dhaka University criminology department, said only arrest could not wipe out terrorism. He said awareness campaigns in educational institutions and reform curriculum in Qawmi madrasas were crucial in fighting a force that is working in a well-planned manner.

In the last 10 years, more than 400 militants were arrested -- most of them JMB operatives. So far, 478 JMB men have been tried in 185 cases. Of them, 51 top leaders of the JMB were sentenced to death, 178 given life term and 245 jailed for different terms,

The cases remained stuck until a 2009-investigation by The Daily Star disclosed how corruption and manipulation by an employee of the drug regulatory body Directorate General of Drug Administration (DGDA) and a court clerk kept the trial on hold for so many years.

The copies of the stay orders had been found hidden under piles of documents of cases disposed off.

Although the stay on the BCI cases was lifted in 2011, the trial could not begin in the next two years as the complainant, DGDA Director Abul Khair Chowdhury, did not appear before the court that had summoned him 18 times.

Finally, the trial began on August 7 last year, and the court sent Khair to jail for not complying with its orders. Khair was released later on condition that he would appear before the court regularly to testify.

The judgment was scheduled to be delivered on August 13 but Judge M Atoar Rahman deferred it until today.
