In the dishevelled figure of a South Asian male carrying a backpack, the banker recognises a longlost friend, a mathematics prodigy who disappeared years earlier under mysterious circumstances. The friend has resurfaced to make a confession of unsettling power.

"In the Light of What We Know" takes the reader on a journey of exhilarating scope -- from Kabul to London, New York, Islamabad, Oxford, and Princeton -- and explores the great questions of love, belonging, science, and war.

It is an age-old story: the friendship of two men and the betrayal of one by the other.

The visitor, a man desperate to climb clear of his wrong beginnings, seeks atonement; and the narrator sets out to tell his friend's story but finds himself at the limits of what he can know about the world - and, ultimately, himself.

In a feat of imagination, Zia, who studied at Oxford and Cambridge, has telescoped the great upheavals of the young century into a novel of rare intimacy and power.

FROM PAGE 1 Suvra Mukherjee, born in Narail of Bangladesh in 1940, was admitted to the Army Research and Referral Hospital in Delhi Cantonment on August 7 with respiratory complaints.

"It is informed with deep sorrow that First Lady Smt Suvra Mukherjee passed away this morning ... She left for her heavenly abode at 10:51am," said an official statement of Rashtrapati Bhavan, the presidential palace, yesterday.

She is the first First Lady of India to die with her spouse in office.

Indian Vice President Md Hamid Ansari, PM Narendra Modi, former PM Manmohan Singh, Congress chief Sonia Gandhi, West Bengal Chief Minister Mamata Banerjee and cabinet ministers expressed condolences as soon as the death news broke.

An accomplished Rabindra Sangeet singer and talented painter, Suvra Mukherjee last visited her ancestral home in Narail in March 2013 with her husband during the president's 3-day state visit to Bangladesh.

Before that, she visited the home along with her daughter Shormistha Mukherjee in 1995.

Suvra married Pranab Mukherjee when she was a student of history department of Kolkata University in July 1957. President Abdul Hamid, PM Sheikh

Hasina, Finance Minister AMA Muhith, Law Minister Anisul Huq and BNP Chairperson Khaleda Zia, among others, expressed deep shock and prayed for the eternal peace of the departed soul and conveyed sympathy to the members of the bereaved family. In a condolence message to Pranab

Mukherjee, Hasina said: "In Bangladesh, we hold her in high esteem. We are proud that she was born in Bangladesh and fondly remember her love and affection for Bangladesh. With her demise, we've lost a great friend and well-wisher." Hasina developed close personal

relations with Suvra and others of the Mukherjee family during her years in exile in Delhi following the August 15, 1975 coup that saw her father Bangabandhu Sheikh Mujibur Rahman assassinated with most of other family members. Hasina and Rehana escaped the bloodbath as they were abroad at the time.

Sheikh Hasina leaves Dhaka for New Delhi on a special flight of Biman Bangladesh Airlines at 6:00am. She will

be accompanied by her younger sister Sheikh Rehana, daughter Saima Wazed Putul and Foreign Minister AH Mahmood Ali.

From the airport, the PM will go straight to the Rasthrapati Bhavan to meet Pranab Mukherjee at 8:40am, according to an itinerary issued by the Indian external affairs ministry last

From there, she will go to the house of Suvra's son Abhijit and lay a wreath on the First Lady's body at 9:00am.

Though the itinerary doesn't mention whether she will attend the funeral at the Lodhi Road crematorium at 10:00am, sources said she would. Hasina will meet Modi at 11:30am at

his official residence on Race Course Road. The two leaders had last met when Modi had paid his maiden visit to Bangladesh on June 6-7 this year.

After the meeting, she will leave for Dhaka at 3:00pm, according to the ministry itinerary.

There is speculation that Hasina might informally meet West Bengal CM Mamata, who last night arrived in Delhi from Kolkata to attend Suvra Mukherjee's funeral and cremation.

As the matter came to the fore yesterday, Rajon's father Sheikh Azizur Rahman said: "How come a person who tried to save my son's killers could be the complainant? I cannot accept this."

He said he would file a no confidence petition with a Sylhet court once he got the copy of the charge sheet.

"I would be happy when the main accused is brought back and punished," Azizur told The Daily Star. Suranjit Talukder, investigation

officer in the case, however said as per law, the person who files the case becomes the first complainant and main witness in the charge sheet.

"That is why Aminul Islam was kept as the complainant. He will narrate the incident before the court," said Suranjit, also an inspector of the Detective Branch of Sylhet Metropolitan Police (SMP).

The Criminal Investigation Department (CID) recovered arms and ammunition of a murder accused in Satkania upazila of Chittagong on Monday night. As per the confessional statement

of Mahfuzul Haque alias Mahmudul Haque, a member of Eochiya union and also a vice-president of the union unit Jubo League, the CID team took him to his Chhonkhola village around 9:00pm, said Kutub Uddin, additional superintendent of the CID.

The team then recovered an AK-22 rifle, its two magazines, three light guns (LG), six bullets and seven cartridges wrapped in polyethylene bags from a ditch. On January 8, some unidentified

Eight months after his shock defeat in presidential polls, Rajapakse acknowledged there would be no swift return to power in the role of prime minister.

"My dream of becoming prime minister has faded away," Rajapakse told AFP in an early morning phone interview. "I am conceding. We have lost a good fight."

Rajapakse's United People's Freedom Alliance (UPFA) came second with 95 seats, while the minority Tamil National Alliance (TNA) took 16 seats.

The outcome represents another aged to flee the area. bitter blow for Rajapakse, who led Sri Lanka for a decade before he was dramatically ousted by his one-time ally Maithripala Sirisena in a January 8 presidential election.

The former health minister united a fractured opposition to pull off an unlikely victory against Rajapakse,
