Four decades ago, Honours graduate Ainab Ali went abroad in search of his fortune. Ironically, it was when he returned home and turned to guava cultivation that he truly found success. "The decision to go abroad wasn't the right decision," he says. "It's better to grow guavas."

The sweet, green fruit has long been popular in Bangladesh. A little salt on a guava slice is a well-liked treat, almost a taste of national culture. From Jhalakathi's floating bazaar on the Kirtipasha canal, in the midst of Bhimruli's remote, swampy terrain, to the plains of Narsingdi, guava cultivation has rewarded many an entrepre-

Kazi guavas have subsequently revolutionised the local industry.

Pariza paddy brings smile to farmers in Lalmonirhat

Cultivated between boro and aman, it adds to their earning

Cultivation of Pariza, a short duration paddy cultivated between boro and aman, brings happiness to a good number of farmers in the

district. Introduced five years ago, the variety was cultivated on 1,000 bighas of land at 40 villages in the district this year with advice and technical support from Bangabandhu Sheikh Mujibur Rahman Agricultural University and NGO RDRS Bangladesh.

"I have been cultivating short duration Pariza paddy for the last four years. I got 14 maunds of yield from one bigha of land this season. I spent only Tk 2,000 for the additional crop," said Ismail Hossain, a farmer of Panchagram village in Lalmonirhat Sadar upazila.

Motaleb Hossain, another farmer of the same village, said his eight bighas of land usually remains unused for three months between harvesting of boro and start of aman cultivation.

"This year I cultivated Pariza paddy on two bighas of land early May and I harvested it early August. Then I cultivated aman paddy in the same land," he

Chairman of Panchagram union parishad Delowar Hossain, also a farmer, said Pariza cultivation helps farmers to earn additional money but insects and birds often cause harm to it.

"As most of the lands said. remain empty during May to July, insects and birds attack Pariza fields, which are usually detached ones. If much more lands are brought under its cultivation, it

Safayet Hossain, deputy director of the Department of Agricultural Extension (DAE) in Lalmonirhat, said the land which is usually used for boro and aman cultivation, is suitwould be less affected by able for Pariza rice cultiva-

"The seedbed of Pariza is prepared around 15 days after harvesting of boro. Fifteen to 20-dayold seedlings are transplanted on well-ploughed land early May. It can be harvested in late July or early August," he said.

A woman and her daughter drowned as a boat capsized in a haor (water body) in Tahirpur upazila of Sunamganj district on Monday night.

The dead are Nazma Begum, wife of Sohel Mia of Kholahati village in the upazila, and her daughter Binti.

Victims' family members said a small boat carrying four members of Sohel's family sank in the haor after it was caught in a violent storm around 8:00pm.

Sohel and his seven-year old son managed to swim ashore, said Shahidullah, officer-in-charge of Tahirpur Police Station.

70 sued for vandalising madrasa

Around 70 people were yesterday sued for allegedly vandalising Bowdubi Rabeya Khatun Hafizia Madrasa under Zianagar upazila of the district on August 11.

Abdul Halim Khalifa, alias Babul, president of the institution, filed a case with Pirojpur Judicial Magistrate's Court, accusing 16 named and 50-55 unnamed people.

One Rezaul of the area, who claims the ownership of the madrasa land and led the attack on August 11, has been made the main accused in the case, police said.

Around 50-60 youths led by Rezaul stormed the madrasa and damaged to rooms.
