Empowering JS affects free judiciary

Dr Kamal on SC judge impeachment STAFF CORRESPONDENT

The 16th constitutional amendment that reempowered parliament to impeach Supreme Court judges has affected the independence of the judiciary, renowned jurist Dr Kamal Hossain told the High Court yesterday.

Shawkat Mahmud remanded

A Dhaka court yesterday placed BNP chairperson's Adviser Shawkat Mahmud on a three-day remand in a case filed for killing a man in an arson attack in January.

Cheaper way to treat pneumonia

Bangladeshi scientists develop more effective oxygen therapy for infants

In a major breakthrough, scientists in Bangladesh have developed a low-cost technology for treating infants suffering from severe pneumonia and hypoxaemia.

Dr Jobayer Chisti, who led a research to develop this technology, said it is more effective than the standard oxygen therapy used in the developing countries.

Lung infections by bacteria or viruses cause pneumonia while hypoxaemia means abnormally low level of oxygen in the blood. Infants below the age of five who die from diseases constitute 13 percent of the total deaths of children in Bangladesh.

In the traditional low-flow oxygen therapy, patients receive only oxygen but the new method -- called bubble continuous positive airway pressure (Bubble CPAP) -requires a water-filled bottle with a pipe going through a nasal hole in addition to the oxygen flow, explained Dr Chisti.

GIRL HARASSMENT IN SIRAJGANJ

Victim's mother beaten to death

A woman was beaten to death yesterday for protesting the harassment of her daughter by a neighbour in Tarash upazila of Sirajganj, police said.

The deceased, Khushi Begum, 45, is wife of Kamrul Islam of Vatara village.

ATM Aminul Islam, officer-in-charge of Tarash Police Station, said Khushi's 18-year-old daughter was harassed by Abu Hanif a few weeks ago. As Khushi went to his house to protest the harassment around 12:30pm yesterday, an altercation broke out between her and Hanif's wife Nirala Begum.

At one stage, Hanif, Nirala and his sister Rahima Khatun started beating up Khushi. She died on the spot, the OC said.

Police recovered the body and sent it to Sirajganj General Hospital morgue for autopsy.

Nirala and Rahima were arrested, but Hanif managed to flee. SEE PAGE 12 COL 5

3 lawyers held for 'funding militants'

Rab claims the arrestees are linked with Ctg-based outfit Hamja Brigade

The Rapid Action Battalion on Tuesday arrested three lawyers in the city's Dhanmondi area in connection with financing Shaheed Hamja Brigade, a Chittagong-based militant outfit.

Shakila Farzana, 39, and Hasanuzzaman Liton, 30, who reportedly practise at the Supreme Court, and Mahfuz Chowdhury Bapon, 25, who practises at the District Judge's Court, Dhaka, were arrested, said Commanding Officer of Rab-7 Lt Col Miftah Uddin Ahmed at a press conference at its Chittagong headquarters.

Shakila hailed from Chittagong and is the daughter of former BNP MP and whip of parliament Syed Wahidul Alam. Liton hails from Kushtia, while Bapon's address could not be known immediately.

Shakila is a member of Chittagong district (north) unit BNP and joint general secretary of Nationalist Lawyers Forum, Nur Mohammed, joint convener of the district unit told The Daily Star.

Thai authorities said yesterday the man who carried out a devastating Bangkok shrine bombing that killed 20 people was a foreigner and part of a network.

Police released a sketch of a young, bespectacled man shown on security footage walking into the crowded Hindu shrine in a popular tourist hub and placing a backpack believed to contain the bomb.

A few hours later a Bangkok court issued an

arrest warrant for the man, describing him as a foreigner but not identifying him any further.

Bazar area in the capital yesterday, obstructing traffic movement and spreading

an unpleasant smell on the busy road. As of 1:45pm, when the photo was taken,

no city corporation vehicle collected the waste.

Bomber part of a network

The warrant, issued by Bangkok's Southern Criminal Court, accused an "unnamed foreigner of premeditated murder, attempted murder and bomb-making".

Before the arrest warrant was made public, national police chief General Somyot Poompanmoung told reporters a "network" had orchestrated the attack, which has no precedent in the Thai capital.
