

Satkhira judicial magistrate stripped of powers

A judicial magistrate of Satkhira was stripped of his powers yesterday after a 10-year-old girl who bore marks of injuries was rescued from his residence on Wednesday afternoon.

Confirming Nurul Islam's withdrawal, Satkhira Chief Judicial Magistrate Nitai Chandra Saha told the news agency that the law secretary and the department concerned have been informed about the rescue.

A general diary was filed with Sadar Police Station, said its officer-in-charge, Emdad Sheikh.

Meanwhile, Nitai sent a protest letter to Satkhira Press Club's president and general secretary claiming that most of the media published exaggerated news about the rescue.

In it, he said the marks resulted from a fall on the bathroom floor and electrocution. Police admitted the girl to Satkhira Sadar Hospital. Locals said they informed police after spotting the girl on a balcony crying for water around 1:00pm. Neighbours alleged that Nurul and his wife Natasha used to torture the girl.

SC fixes Aug 24 for hearing ACC's challenge against Mosharraf's bail

The Supreme Court yesterday fixed August 24 for hearing a petition filed by ACC seeking stay on a High Court order that granted bail to BNP leader Khandaker Mosharraf Hossain in a money laundering case.

Issue SSC, HSC exam mark sheets on demand: HC

The High Court has ordered all the education board authorities to issue mark sheets of SSC, HSC and Alim examination results to examinees, if they apply for it.

The HC, which has given the direction in April this year following a writ petition filed by an SSC examinee of 2010, released full judgment in this regard last month.

Now transcripts with Grade Point Average (GPA) results are issued to students of secondary and higher secondary examinations.

The HC observed that getting a mark sheet by an examinee is a fundamental right, which is protected under the Right to Information Act, 2009 and the Bangladesh constitution, petitioner's counsel AKM Salaudhin Khan told The Daily Star.

So, the examinees have to be given full mark sheets if they apply for it and the authorities concerned cannot do any negligence, said the HC.

Salaudhin said the HC also directed the authorities concerned of the government and Dhaka Education Board to give the SSC examination mark

sheet of his client M Nafis Salman Khan in 30 days after receiving the copy of judgment.

The Dhaka board authorities have received the HC order on August 2, he said.

He said the education board authorities had earlier issued mark sheets of results to students and they stopped this system in 2003 after the education ministry issued a notification following introduction of grading system.

The writ petition was filed challenging legality of the notification, the lawyer added.

Man beaten to death

Locals, Rab give conflicting versions

An unidentified man was beaten to death allegedly by some men wearing vests of Rapid Action Battalion on Wednesday at Chandona Chowrasta in Gazipur.

The elite force, however, denied having any link with the incident.

Locals said the victim was aged about 34.

Rab-1 Deputy Assistant Director Apurba Kumar Chackrabarti filed a case with Joydebpur Police Station in this connection.

Quoting the case statement, Khandaker Rezaul Hasan Reza, officer-in-charge of the station, said a group of men attempted to extort money from shopkeepers in the area in the evening.

An angry mob then caught one of them and beat him up.

Later, Rab members rescued him and took him to Gazipur Shaheed Tajuddin Ahmed Medical College Hospital where on-duty doctors declared him dead, the OC added.

Locals, however, claimed that some men, wearing vests of Rab, started chasing three men when they came out of a restaurant, and caught one of them. They then beat him up, leaving him critically injured.

Rab-1 Commanding Officer Lt Col Maksud denied this and termed the allegation baseless.

Pickpocket gang busted

Cops foil their plan to send 4 to Makkah during hajj

Detectives yesterday claimed to have busted a gang which had a plan to send some of its operatives to Makkah to pick-pocket hajj pilgrims from across the world.

"The gang was preparing to send at least four pickpockets during this year's hajj spending Tk 12 lakh with a target to cash in Tk 1 crore," said Sanwar Hossain, additional deputy commissioner of Detective Branch (DB) of Dhaka Metropolitan Police yesterday.

Three of the four pickpockets were arrested along with three others during a raid in the capital's Malibagh area, said DB Joint Commissioner Monirul Islam at a press briefing at the DMP media centre.

The three arrestees who were to travel to Makkah are -- Abdul Gafur, ringleader of the gang, Tutul Biswas Suman and Mohammad Ibrahim. The fourth one, Mohammad Raushan, was on the run, detectives said.

ADC Sanwar said Gafur was supposed to take half of the Tk 1 crore, if they could make the money picking pockets, as he had invested Tk 12 lakh.

Detectives also said that the gang, in other times, used to dope people with sedatives in and on the outskirts of the capital and take valuables from them.

Meanwhile, a DB team arrested six members of a dope gang, along with some food mixed with sedatives, raiding Shahbagh area around 7:45am.

Malaysia in late February and took Tk 2.5 lakh from his family. But Ali could neither reach Sohag in Malaysia nor bring him back home.

"Sohag was beaten in the ship. Sohag told us this from the ship by phone and told us to pay money to Nuru Mia," Ahmed Ali told The Daily Star over the phone.

Meanwhile, Nuru Mia also filed a case last week with a Narsingdi court accusing Ahmed and Sohag of trafficking Nuru's nephew, said Apple

Mahmud, head of Police Bureau of Investigation (PBI) in Narsingdi.

"On that basis, we asked Ahmed Ali and Sohag to come to our office. As we interviewed them and saw related documents, we asked Nuru Mia to come to our office and arrested him when he came," he told The Daily Star over the phone.

He said they suspect Nuru to be a member of an international human trafficking network.

According to Apple Mahmud, in the last one month PBI received 10 cases

related to human trafficking and arrested five alleged human traffickers in Narsingdi.

Media reports suggest Narsingdi, Narayanganj, Sirajganj and Cox's Bazar are the four districts from where a large number of youths were trafficked to Malaysia through the sea.

According to the police headquarters, 573 alleged traffickers were arrested in connection with 442 human trafficking cases between January and June this year. However, only three were convicted.

Bari directed the staff to snatch their video camera and cellphones claiming journalists required permission to go there for news reports, they alleged.
