

## Bribery rampant in land offices

TIB study says service seekers have to pay Tk 100 to Tk 20 lakh in bribes; govt initiatives to check graft inadequate

Massive corruption prevails in the land offices and people have to pay bribes starting from Tk 100 to Tk 20 lakh in every step to get land related services, according a report of Transparency International Bangladesh (TIB) reveals.

Though the government in the last five years has taken some positive initiatives but there is a lot more work to be done to check graft and ensure hassle-free services in the offices, said the report titled "Land Management and Services: Challenge of Good Governance and Way Forward."

Corruption and lack of good governance in the sector have a long term social impact as still 60 percent of all pending civil cases -meaning around 18 lakh -- are related to land, added the report presented in a press conference yesterday.

The TIB also found sometimes influen-

tial political leaders make underhand dealings with land officials to record khas land, vested and abandoned properties or properties of courts of wards in their name.

"There is nothing new to say about the corruption in land sector. Graft in land related services has taken an institutional shape," said Iftekharuzzaman, executive director of TIB.

Though the government has initiated digital land management, still a lot more is needed to be done, he said.

The TIB boss explained: people have to follow eight steps for land registration and another 10 steps for mutation of a land. "But we have checked that it is possible to make the process easy. Once the process becomes easy, corruption will also come down."

Cost up 5 times in 5yrs

The government is set to sign a contract with a Chinese company to build a 110km oil pipeline in the Bay of Bengal to facilitate smooth unloading of oil from large ships in deep sea to storage facilities in mainland.

Presently, large oil importing ships anchor in deep sea and smaller ships unload and bring the oil to storage facilities of Eastern Refinery Ltd (ERL) in Chittagong. This process called

"lightering" is an expensive operation and it takes 11 days to unload 1 lakh tonnes of oil. Other than time and cost, a lot of oil is systematically stolen during the process, officials say.

But if a pipeline known as Single Point Mooring (SPM) is installed to replace lightering, it would take just two days to empty a vessel carrying such a volume of oil. This will cut down cost and stop pilferage.

A commercial contract with China Petroleum Pipeline Bureau (CPPB)

DEATH IN 'SHOOTOUT'

The family of Arzu Miah, a Bangladesh Chhatra League leader accused of killing a teenager and later killed in a "gunfight" with Rab, filed a murder case with a Dhaka court yesterday accusing three Rab officials. The Rab officials are Lt Col SM Masud

## Mass graves found again in Malaysia

24 bodies believed to be of trafficking victims from Bangladesh and Myanmar

Three months after the migrant crisis in Asia, Malaysian authorities on Saturday found 24 bodies in mass graves near the country's border with Thailand.

The remains believed to be of Rohingyas from Myanmar and Bangladeshis fallen victim to human trafficking were recovered from 19 graves in Wang Burma hill area of Malaysia's northern state Perlis, reported Malaysian newspaper The Star yesterday.
