Shishir told The Daily Star that they would suspend Shuvo from the organisation.

The victim filed the complaint with Rangpur Kotwali Police Station, saying Shuvo and his followers used to harass her since she had rejected his romantic advances five months ago. Four days back, Shuvo, the main accused, threatened to

throw acid on Asha if she did not accept his proposal, the case statement read. Asha later informed the matter to Md Ali Raj, vice president of the university unit of BCL, and Hadiuzzaman Hadi,

expelled vice president of the unit. After Raj and his men protested against Shuvo's passing comments to Asha on Monday morning, the six with some others attacked them in the evening, leading to a clash.

Four BCL men were injured during the fighting including Raj and Titas Chandra Roy, joint general secretary of the unit, who protested the harassment.

The four were admitted to Rangpur Medical College Hospital.

Bangladesh, Mexico sign MoU to boost relations

Bangladesh and Mexico have agreed to start a dialogue to expand bilateral relations including strengthening trade and commerce.

The two countries signed a memorandum of understanding (MoU) on Foreign Office Consultation (FOC) to that effect.

State Minister for Foreign Affairs Md Shahriar Alam, who is now on a visit to Mexico, and Mexican Foreign Minister José Antonio Meade Kuribreña signed the MoU on Wednesday, said a foreign ministry press release.

Earlier in the day, the Bangladesh state minister had a breakfast meeting with presidents and director generals of leading apparel manufacturing companies of Mexico. The entrepreneurs expressed eagerness to visit Bangladesh at the end of this year for exploring

investment opportunities.

United Nations Special Rapporteur Heiner Bielefeldt will arrive in Bangladesh on August 31 on a nine-day visit to assess the state of freedom of religion or belief in the country.

"I am keen to learn more about the efforts to eliminate root causes of vio-

Heiner Bielefeldt lence, intimidations and vigilantism in the name of religion and developments in promoting and protecting religious freedom, especially initiatives of interreligious dialogues, following the first country visit by my predecessor in May 2000," Bielefeldt said.

"It will also be a timely opportunity for me to assess the freedom of religion or belief in relation to issues of gender, women, children, and in particular, religious minorities or indigenous communities," he noted, according to a UN press release received from Geneva yesterday.

During the visit, Bielefeldt will meet various government officials, representatives of religious or belief communities, minority and indigenous representatives, civil society organisations and the UN. On conclusion of his tour, he will share his preliminary findings with the media at a press conference on September 9 at Jatiya Press Club.

He will also present a report with his conclusions and recommendations to the UN Human Rights Council in 2016.

Police have arrested 16 people on charges of committing different crimes, including impersonating detectives, in raids across the capital in the last two days.

Police arrested three impersonators in Shanir Akhra, seven members of a fraud gang in Pallabi, five robbers in Kalyanpur and a drug peddler in Jatrabari.

The impersonators were arrested and from them a car, a walkie-talkie and a pair of handcuffs were recovered on Wednesday, Syed Nurul Islam, deputy commissioner of Wari division police, said at a press briefing at the media centre of Dhaka Metropolitan Police. "The gang, pretending to be detectives, used to pick up people who just withdrew money from a bank or collected it from someone, and take their money before releasing them somewhere," he said.

The arrestees are Hafizur Rahman, Monir Hossain, Pikul Sheikh.

Another team of police arrested members of a fraud gang with two toy pistols and three knives on Wednesday night, said Kaiyumuzzaman Khan, deputy commissioner of Mirpur division police, during another briefing at the same venue.

The detainees are -- Liyakat Ali, Kamrul, Shohidul Islam, Najmul Islam Didar, Ruhul Amin Ripon, Obidur Rahman Batu and Meherunnisa Keya. Kaiyumuzzaman said the female mem-

bers, mostly college and university students, used to start relationships with targets through Facebook or over the phone. Afterwards, the members would ask the

'Money Laundering' SC stays Khandaker Mosharraf's bail

The Supreme Court yesterday stayed for two weeks a High Court order that granted BNP leader Khandaker Mosharraf Hossain bail in a money laundering case.

The order came after hearing a plea moved by the Anti-Corruption Commission against the HC order. The apex court also asked

ACC to file a leave-to-appeal petition with it against the HC order in two weeks, said ACC lawyer Khurshid Alam Khan.

Earlier on August 18, Mosharraf got permanent bail in the case filed by ACC on February 6, 2014 accusing him of amassing over Tk 9.53 crore between 2001 and 2006 and depositing that into a bank account in the UK.

International Crimes Tribunal delegation visits The Hague

Four judges of the International Crimes Tribunals (ICT) visited The Hague, Netherlands from August 23 to 26 and exchanged views with hosts of legal institutions in the European country.

According to a press release, the delegation made the visit on their way back from Buenos Aires, Argentina after attending an international conference there. Led by Justice Obaidul Hassan, chairman of ICT-2, the team also included Justice M Enayetur Rahim, chairman of ICT-1, and its members Justice Jahangir Hossain and Justice Anwarul Haque.

They visited the International Criminal Court (ICC), and had a comprehensive dialogue with ICC Judge Chang-ho Chung (South Korea) and Judge Raul Pangalangan (the Philippines). They also visited the International Criminal Tribunal for the former Yugoslavia.

Savar College student 'abducted'

Fugitive gets life term for raping girl
