'Thief' beaten to death

A CORRESPONDENT, Comilla

A man was killed in a mob beating for his alleged involvement in stealing money from a mosque donation box in Comilla's Nangalkot upazila early yesterday.

The dead is Mohammad Sohel, 28, of Dakkhin Kachi village in Monohorganj upazila, said Salahuddin Al Asad, officer-incharge (investigation) of Nangalkot Police Station.

Around 4:00am, Sohel was stealing money after breaking the donation box of Manikmora Bazar Mosque, the police official said. The night guard of the mosque

saw it and made an announcement through a loudspeaker. Locals then caught Sohel and beat him up mercilessly, killing him on the spot, the police official added.

On information, police went to the spot and sent the body to Comilla Medical College Hospital morgue for an autopsy.

Police detained the moazzin (who calls for Azaan) and the night guard of the mosque.

Under the new rates, which take effect on September 1, households using a single-burner stove will have to pay 50 percent more with the monthly gas price going up to Tk 600 from Tk 400. For double-burner stove users, the tariff has been raised to Tk 650 from Tk 450 a month.

Industries that turn gas into electricity through generators will see gas tariff double -- Tk 8.36 from Tk 4.18 per cubic metre.

deputy commissioner (media) o DMP, told The Daily Star.

During remand, Mamun divulged some important information regarding the conversation and the police were verifying them, he added. Amid controversy over a leaked

phone conversation between BNP leader Sadeque Hossain Khoka and Manna, Gulshan Police arrested Manna on February 24 at his niece's house in Banani.

Police sued Manna for sedition following the leak of his two telephone conversations.

Student shot dead at **US** university

A student died early yesterday after being shot at a US university in the state of Georgia, in an altercation that triggered a temporary lockdown of the campus.

Christopher Starks, a junior from the Atlanta metropolitan area, died at a local hospital following an "altercation" late Thursday at Savannah State University's student union building, the school said. No arrests have been made,

though the campus was placed on lockdown for about two hours until just before midnight.

The Georgia Bureau of Investigation is investigating the incident along with campus police because the university is

It comes just days after the brazen shooting of two journalists during a live broadcast that has once again renewed calls for stricter US gun controls.

The school said classes would be delayed until 10:00 am yesterday.

"The safety of those who live, study, work and visit Savannah State University remains a top priority no exceptions," the university said in a statement on its website. "Savannah State University has zero

tolerance for violence of any kind." It urged students to report to

campus police with any information about the incident or the presence of weapons on campus.

Ananta was hacked to death near his Subid Bazar home in Sylhet city on May 12.

"The two were arrested from their residence at Kanaighat on the basis of specific information and evidence," Mirza Abdullahel Baqui, special superintendent of CID told The Daily Star over the phone yesterday.

He, however, declined to say anything about their link with the murder.

A Sylhet court yesterday placed them on seven-day CID remand after they were produced before it.

A case was filed by the victim's brother a day after the gruesome murder. The case was handed over to the CID on May 26.

About two weeks ago, Rab claimed to have arrested three people -- Bangladesh-born UK citizen Touhidur Rahman, Sadeque Ali and another suspected Ansarullah member Aminul Mallick -- from the capital for their alleged link with the killing of Avijit Roy and Ananta.

BLOGGER FILES GD COMPLAINING INSECURITY

A female blogger and also an activist of Gonojagoron Mancha yesterday filed a general dairy with Mohammadpur Police Station, claiming she was followed by two unidentified youths on Thursday night.

After filing the GD, the writer told The Daily Star that she had found the movement of the youths suspicious and was now feeling insecure.

"I have rarely gone out of my home after the murder of blogger Niladri Chattopadhyay Niloy," said the girl, who writes in blog site Istishon.

According to her, the youths, aged between 25 and 28, followed her for sometime after she had got out of her home for a Dhanmondi chain store around 7:45pm that night.

Suddenly, she noticed that the two youths -- one in jeans and a checkered shirt, and another in black trousers and a white shirt -- were walking

She claimed that whenever she stopped, they stopped too.

The blogger said she had reasons to be alarmed as Niloy had reportedly been followed in the same manner before his brutal killing early this month.

After walking for some time, she went inside the store and saw the

youths entering it too. "The youths were not buying

anything there," she claimed. She left the place immediately and went to a nearby clothes shop where she found a friend.

Later, they came out of the shop together and noticed that the two youths were staring at them while having tea at a roadside stall.

The blogger said they tried to take photos of the youths but to no avail.

After a little while, the youths entered the clothes shop. This time, the girl managed to take a photo of the youths.

The blogger then went straight to her home.

She said she handed over the photo to police while filing the GD seeking protection.

Contacted, Jamal Uddin Mir, officer-in-charge of Mohammadpur Police Station, confirmed that the GD was filed by the female blogger.

"We will take necessary measures to ensure the girl's safety," he said. This paper decided not to reveal her

identity for the sake of her security. Before his murder, Niloy, who was also a Gonojagoron Mancha activist, had reportedly gone to Khilgaon Police Station after being followed by some unidentified men

and tried to file a GD in vain. Recently, Dhaka Metropolitan Police Commissione Asaduzzaman Mia instructed police to accept a GD from anyone who

thinks his or her life is in threat. Niloy was the fourth blogger to be killed since February 26. Different militant outfits claimed responsibilities for the murders.

An illegal wildlife trader was arrested along with 500 parakeets from a bus in Rajshahi city early vesterday.

Later, the arrestee, Abul Kalam Mafiz, 26, was sentenced to three months in prison.

Mozammel Haque Shah Chowdhury, divisional forest officer (DFO) of Rajshahi, said acting on a tip-off, a team of forest officials, led by him, raided the Dhaka-bound bus in Kashiadanga area around 12:15am.

He said the birds were found inside two iron cages in the bus.

"He [the arrestee] collected the wild birds from Chapainawabganj and was trying to smuggle them into Dhaka," the DFO told The Daily Star.

A magistrate with the wildlife conservation team fined Kamal Tk 5, 000 and sentenced him to three months in jail.

Officials of Wildlife Management and Nature Conservation, Rajshahi, released the birds later.

Mafiz was also arrested along with 805 different types of birds in the district last year.

According to the Bangladesh Wildlife (Conservation and Security) Act, 2012, catching and trading wild birds is a punishable offence.

500 birds seized Nepalese face similar ordeal

those from Bangladesh, where young men often pay a large amount of money for foreign jobs to escape from poverty, loans and social challenges.

Miseries and challenges of migrants from the South Asian nations were presented at a three-day-long workshop on Migration and Media in Nepal jointly organised by the Refugee and Migratory Movements Research Unit (RMMRU) and Migrating out of Poverty Research Programme Consortium (RPC) of Sussex University, UK during the second week of this month. Twenty one journalists from Bangladesh,

India, Nepal and Sri Lanka shared their experiences at the workshop and discussed the success and failure of policy decisions taken by their respective governments to ensure migrants' rights. "One and a half months ago our govern-

ment made it mandatory for employers in seven countries -- Bahrain, Kuwait, Malaysia, Oman, Qatar, Saudi Arabia, and United Arab Emirates -- to provide free visa and tickets to workers from Nepal," said Roshan Sedhai, sub-editor of Kathmandu Post, adding that the decision triggered huge protest among the recruiting agencies.

"The agencies claimed such a policy would shift the demands for labourers towards Bangladesh," he said.

The Bangladeshi journalists described how a similar government-to-government policy to reduce migration costs for workers aspiring to go to Malaysia faced similar resistance and forced many potential migrants to choose illegal sea-routes to reach the destination.

They also pointed out the higher migration costs ranging from BDT 3-4 lakh (about \$3,800-\$5,200) paid by Bangladeshi workers to go to Malaysia and the Middle Eastern countries compared to the Nepalese workers who pay between \$1,000 and \$2,000. On an average, 500,000 workers migrate

Instead of losing the market by overactivism, which has the risk of driving away the recruiters, this clause can be used to strengthen the negotiation power of the labour exporting nations, he observed. In addition to presentation by RMMRU
