

UN special envoy for freedom of religion in town

United Nations Special Rapporteur Heiner Bielefeldt arrived in the capital yesterday for a nine-day mission to assess the state of freedom of religion or belief regarding gender, women, children, and particularly religious minority or indigenous community issues in the country.

He will meet government officials, representatives of religious or belief communities and minority and indigenous communities. He will share his preliminary findings with the media on September 9. Bielefeldt will present a report with his conclusions and recommendations to the UN Human Rights Council in 2016.

WAR CRIMES TRIAL

Taher, Nani implicated in Netrakona freedom fighter murder again

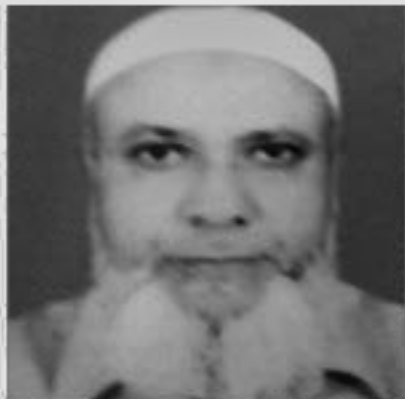

A prosecution witness yesterday corroborated testimonies of previous witnesses that Obaidul Haque Taher and Ataur Rahman Nani killed freedom fighter Dabir Hossain in Netrakona town during the Liberation War in 1971.

Maksuda Hossain Ava, Dabir's younger sister and the 15th prosecution witness in the case, told the International Crimes Tribunal-1 that her father requested Taher's father for Dabir's release but to no avail. Maksuda, who also trained for the Liberation War,

said she heard about their involvement in her brother's abduction and murder from several witnesses. Earlier, Abdul Hamid and A b u B a k a r Siddique, the 13th and 14th prosecution witnesses in the case respectively, also linked them in the killing on October 4, 1971.

Taher and Nani face six charges. They, however, pleaded not guilty

he burnt a Pakistan flag following the March 7 speech of Bangabandhu Sheikh Mujibur Rahman. At one stage of the war, her two brothers went to India's Meghalaya to train and later they took part in the Liberation War,

before the tribunal. Maksuda, who was in class X in 1971, said her brother was involved in Chhatra League politics and became a target of the anti-liberation force as she added.

Later, they learnt that Taher and Nani tortured Dabir and shot him dead near Moktarpara Bridge on that night, she said. Maksuda will face cross-examination tomorrow.

The International Crimes Tribunal-2 yesterday deferred the date for passing order on contempt of court proceedings against Gonoshasthaya Kendra founder Zafrullah Chowdhury.

Zafrullah, also a freedom fighter, was present before the court. On August 10, the tribunal had fixed August 30 to pass an order. He, if found guilty, may face up to one year imprisonment or Tk 5,000 fine or both. Zafrullah faced contempt charges for criticising the verdict of a tribunal on Bangladesh-based UK journalist David Bergman last December.

the World Bank Group organised the seminar on the "Government Performance Management System (GPMS)" at a hotel in the capital.

The numbers provided in performance agreements do not lead to any meaningful conclusion, Saadat said.

The figures fail to forecast the sky-rocketing price of consumer goods and the anarchy in Hajj flights, he said, adding that they utterly misrepresent the cruelties and killings in the society, the colossal losses in state-owned enterprises including Bangladesh Railway and Biman.

Objectives of the GPMS are to help achieve vision 2021, enhance efficiency and accountability of government

organisations and expedite implementation of the declared development programmes, said M Mahiuddin Khan, an additional secretary to the cabinet division.

Approved by Prime Minister Sheikh Hasina in January, the GPMS would help ministries remain aware of their development goals and help the prime minister to have an idea of achievement, said Cabinet Secretary Muhammad Musharraf Hossain Bhuiyan.

Information Minister Hasanul Haq Inu, addressing the seminar as the chief guest, said government employees have to remain loyal to their lawful duties instead of yielding to the lobbying culture and unlawful requests of the ministers, to strengthen democracy.

Ekram Ahmed, chairman of Bangladesh Public Service Commission; Martuza Ahmed, secretary to the information ministry; and Information Commissioner Prof Khurshida Begum Sayeed, among others, addressed the seminar, which was moderated by BIGD Executive Director Dr Sultan Hafeez Rahman.

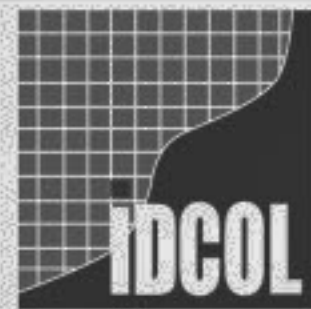
