

LACK OF SPACE IN LALMONIRHAT BUFFER GODOWN

Huge fertilisers on trucks under open sky

Fifty trucks loaded with about 2,000 tonnes of fertilisers have been standing under the open sky in front the 'buffer godown' at Mahendranagar in Lalmonirhat Sadar upazila for the last 10 days, as the items cannot be unloaded due to lack of space in the

"We are waiting in front the buffer godown with the fertiliser-loaded trucks while the truck owners are insisting us to return soon. We will not get extra fare from the contractor for the delay. We may even face job termination," said Nur Alam, a truck driver from Kushtia.

3 fined for arranging marriage of underage girl

A mobile court fined three people for arranging marriage of an underage girl at Ekoriakanda village in Ishwarganj upazila of the district on Saturday.

Police said ninth grader Priya Akhtar, 15, daughter of Mojibur Rahman of the village, was set to be married with Mohammad Ali, an expatriate in Dubai, in the afternoon.

The marriage registrar refused to register the marriage as the bride was under age and left the scene.

Later, the guardians of the bride and bridegroom solemnised the marriage according to religious ritu-

On information, Upazila Nirbahi Officer Tofael Ahmed, who led the court, rushed to the spot and fined the bride, bridegroom and bridegroom's brother-inlaw Abdul Miah Tk one thousand each.

In default, they are to suffer one week in jail, said Borhan Uddin, officer-incharge of Ishwarganj Police Station.

Later, Saiful's relatives rescued him and sent him to Sharsha Upazila Health Complex where he succumbed to his injuries at around 8:30am.


