Govt shuffles key posts at missions

The government has decided to bring changes in key posts at some missions abroad.

The foreign ministry sources said Secretary (Bilateral) to the ministry Mizanur Rahman would replace Kamrul Ahsan as the high commissioner in Ottawa, Canada and the latter would return to the ministry.

Moreover, Bangladesh Ambassador to Japan Masud Bin Momen will replace Dr AK Abdul Momen as the permanent representative in the United Nations.

Dr Momen's tenure was extended for the fourth time on August 19 for the upcoming UN General Assembly and will expire on October 30.

Consul General in Los Angeles, USA Sultana Laila Hossain will take charge as the Bangladesh ambassador to Morocco while the ambassador there will take charge as ambassador to the recently opened mission in Ethiopia.

Director General (Legal Affairs) at the foreign ministry Priyatosh Saha will replace Sultana Laila and DG (External Publicity Wing) S Bodiruzzaman will join as the consul general in Dubai.

The government has also reportedly chosen Rabab Fatima as the new ambassador to Japan but it could not be confirmed.

Meanwhile, the government has already finalised changes at missions in London, Rome, Brussels and Qatar.

The ministry sources said more changes are on the cards and some will come into effect by December.

KISHOREGANJ WAR CRIME SUSPECTS IO finds involvement in murder of 35

The prosecution yesterday told the International Crimes Tribunal-2 that they have found involvement of war crimes suspect fugitive Mohammad Hossain in the murder of 35 people in Dampara village, a Hindu majority area, of Kishoreganj during the Liberation War.

While submitting a progress report on the ongoing investigation against war crimes suspects Moslem Prodhan and Mohammad Hossain, both from Kishoreganj, prosecutor Tureen Afroz said the investigation officer (IO) of the case found that 39 people of that village were detained and of them, 35 were killed on September 23, 1971.

She added that many Hindu women were raped that day.

Moreover, Hindus of the area were forced to accept Islam as their religion, Tureen Afroz told the three-member tribunal.

Hari Debnath, the investigation officer, said so far they have found six charges against the duo. The investigation started

on November 13 last year. Prodhan was arrested on July 7 after an

arrest warrant for him was issued. The proceedings of the case were adjourned until October 8.

PSC staff held for exam question leak

The arrestees are MLSS staff at PSC Md Akbar Hossain and his partners Md Jashim Shikdar Rana, Md Ramjan Ali, fake examinees Md Niyamul Hasan, Md Harunur Rashid and Md Delwar Hossain, and a candidate of Saturday's written test Md Rubel Ahmed, Joint Commissioner of the Detective Branch of police Monirul Islam told the press yesterday. Law enforcers are trying to arrest another MLSS of PSC in Chittagong Billal Hossian. Detectives also seized questions and answer sheets, admit cards, and Tk 50,000 from them.

Mithapukur Police Station, said the Shibir man was charged with firebombing a bus that killed six people in the upazila on January 13. He is also wanted in another 16 cases



Justice Manik was a British citizen when he was sworn in as judge. The allegation of concealing this information is regrettable, the reso-

lution said. It said the SCBA meeting requested the chief justice not to give him salary, allowance and pension benefits until finishing an inquiry into his anomalies through the Anti-Corruption Commission.

He opposed SC lawyers' benefits and development activities, and his behaviour was totally against the interest of the lawyers and the SC, it said, calling him a "controversial judge".

Attorney General Mahbubey Alam said he did not agree with the SCBA resolution, as the pro-BNP lawyers adopted the resolution and brought allegations against Justice Manik with a political and malafide intention.

Meanwhile, SCBA President Khandker Mahbub Hossain yesterday said the president could send Justice Manik's letter about the chief justice to the parliament for a decision.

Justice Manik on Sunday wrote to the president for impeaching Chief Justice SK Sinha, accusing him of "gross misconduct" and "violating oath".
