New cyclone shelter to provide superior utility

The centre with environment-friendly devices to accommodate 1300 people

A highly utilitarian government primary school cum cyclone shelter with capacity to accommodate 1300 people during natural disasters saw inauguration yesterday, much to the happiness of the people of Patuakhali Sadar upazila.

Dr Ferdinand von Weyhe, deputy head of mission of the Embassy of the Federal Republic of Germany in Dhaka, opened the cyclone shelter at Haqtullah village in Patuakhali Sadar upazila around 10:00am yesterday.

He was on a visit to the German cooperation projects including the 'Coastal Livelihoods Adaptation Project' (CLAP) of GIZ (a German governmentowned not-profit enterprise supporting sustainable development) that are being implemented in Patuakhali, a southern district.

Local Government and Engineering Department (LGED) implemented the three storied building construction project at a cost of Tk 2.27 crore jointly funded by Bangladesh government, the World Bank and the government of Germany.

The cyclone shelter includes a well-equipped special room for providing service to pregnant women including delivery during the cyclone, said Abu Saleh Md Hanif, executive engineer for Patuakhali LGED.

Two deep tube-wells as well as rainwater collecting system has been installed to supply pure drinking water in the building while a solar system will ensure power supply there during disasters, he added.

The German envoy also exchanged views with the farmers, who are adapting their cultivation practices to meet the challenges of climate change in the coastal areas.

Local farmers including a good number of women showed vegetables that they produced in their fields after receiving training from GIZ's partner NGO

Two murder case accused arrested

Members of the Rapid Action Battalion (Rab) on early Sunday arrested two youths in the cases for killing a man in Ramchandra purhat area in Sadar upazila in 2014 and hurling cocktails on the elite force members in the same area or

August 20 this year. The arrestees were identified as Mohammad Bagha, 30, son of late Sahabuddin of Chunakhali village, and Sajid Ahmed Tutul, 30, son of Fazlu Manna o Ramchandrapur village in the upazila.

On secret information, a team of Rab-5 of Chapai nawabganj Camp conducted a drive at Amnura village around 1:40am and arrested the two, says a press release.

On June 8, 2014, a gang stabbed Azizul Haque Azu, 40, of Ramchandrapurhat area over previous enmity while he was taking tea at a stall in the area around 11:30am, leaving him dead on the spot.

Victim's wife Rani Begum filed a murder case, accusing 46 people with Sadar Police Station the following day.

On August 20 this year, the same gang hurled several cocktails targeting the elite force members when they went to the area to arrest the accused in the murder case, leaving two Rab personnel injured.

Rab filed a case with Sadar Police Station in this connection the same night.

Failing to rape, criminals poison housewife to death

Criminals killed a housewife by pouring poison into her mouth after failed attempt to rape her in Chirirbandar upazila under the district on Sunday night.

The victim -- Sharifa Begum, 22, wife of Younus Ali of Boardpara village in Chirirbandar upazila, was also mother of a three-year-old daughter.

"Anisur Rahman, 27, and Khabir Uddin, 50, of the same village entered Sharifa's house around 8:30pm on Sunday night and attempted to rape her, finding her alone there,"

said Arjina Begum, elder sister of the victim. "As Sharifa resisted repeatedly, the criminals poured poison into her mouth. Hearing her scream, the neighbours rushed there and the criminals fled before them," said her husband Younus Ali.

The villagers immediately took her to Dinajpur Medical College Hospital but she died early Monday, struggling for life for hours there, said her family members.

The body was sent to the hospital morgue for autopsy.

Contracted, Md Anisur Rahman, officer in charge of Chirirbandar Police Station, said he heard about the incident but victim's family was yet to file any case regarding the incident.

Younus Ali said he will file a case after completing the funeral.
