NAT'L FLOWER TO THE RESCUE IN RAINY DAYS

Plucking water lilies in Bangladesh's bucolic countryside is fun but sometimes it is also money, particularly for the poor agricultural labourers of Munshiganj during this period, when they cannot sell their labour due to lack of farming activities. In Sirajdikhan upazila, several hundred people have taken up the job to support their families. Since the morning, people in small boats scour through the grassy Arial Beel and other such water bodies where the lily is grown between the Bangla months of Ashar and Kartik. One can collect 2,500 to 5,000 lilies till noon if she/he starts in the morning. A wholesaler, Imtiaz Bulbul, said each wholesaler was buying every day about 2,000 bundles, each containing 80 stems. He said one bundle cost Tk 16-21 and sold for Tk 30-35 at the wholesale market in the capital's Jatrabari. PHOTO: FARHANA MIRZA

168 fishermen held for defying seasonal ban on hilsa catching

3,080kg recovered

Bangladesh Coast Guard members yesterday arrested 168 fishermen in the Bay of Bengal near Sangu gas field area and seized 3,080kg of hilsa, worth Tk 24.64 lakh, which they caught defying the ongoing temporary ban on hilsa fishing.

Girl 'gang-raped' in Moulvibazar

A class V student was allegedly gang-raped in Suaratal area of Baralekha upazila in Moulvibazar Thursday afternoon.

Officer-in-Charge of Baralekha Police Station Md Moniruzzaman said the 11-year-old girl was returning home alone Thursday afternoon when some men took her to an abandoned house and raped her.

Hearing her screams, locals rushed to the spot and then admitted her to the upazila health complex.

The girl's grandfather filed a case with Baralekha Police Station accusing two locals on Thursday night, the OC said.

HC circuit bench demanded in Ctg

The High Court Circuit Bench Implementation Council, Chittagong yesterday demanded that the government establish a circuit bench of the High Court in the divisional city.

Leaders of the council raised the demand at a press conference at Chittagong Press Club.

They said there was no constitutional constraint to establish such a bench which can ease the sufferings of justice seekers.

Chittagong District Public Prosecutor Abul Hashem, who is also the convener of the council, was in the chair.

Seven Bangladeshis return from Indian jail after two years

Seven Bangladeshi nationals, including a child, returned home through Benapole check post on Thursday night after serving two years' sentence in a Kerala jail in India.

They are Nurul Abedin, of Brahmanbaria district, Aftabur Rahman, of Sunamganj district, Sharif Molla alias Borhan, of Jessore district, Idris Ali, of Shariatpur district, Shafiqul Biswas of Jessore, his eight-year-old son Saymon Biswas, and Babu Sheikh of Narail.

They were arrested in Tamil Nadu some six months after they entered India illegally in search of jobs, said Benapole check post immigration officer.

A human rights organisation "Rights Jessore" about six months ago informed the home ministry about the seven.

Woman kidnapped from Narsingdi rescued in Ashulia, 3 arrested

Rapid Action Battalion rescued a woman from an Ashulia house in Savar outside the capital yesterday three days after she had been kidnapped from Narsingdi.

It also arrested three people -- Billal Hosen, 24, Monir Hosen, 22, and Obaidul Hosen, 21 -- in this connection. Suprovat, operation officer of Rab-4, said the alleged

kidnapers demanded Tk 2 lakh from the victim's family over the phone.

Community healthcare providers demand nationalisation of job

Such healthcare providers have been working in community clinics across the country under a government project launched in 2008.

Outlawed party man's bullet-hit body found in Kushtia

Police found the bullet-hit body of an outlaw in Panti of Kumarkhali upazila in Kushtia yesterday.

Robiul Islam alias Robi, 45, a top leader of banned Gono Mukti Fouz, was found blindfolded on a field, said Proloy Chisim, superintendent of police in Kushtia.

Robi's rivals might have killed him after abduction, he said. Robi, who hailed from Jhenidah, was accused in 13 cases including seven murder cases field with different police stations in Jhneidah and Kushtia, the SP said.
