Railway land under illegal occupation in Lalmonirhat

Building of unauthorised structures, sale of 'possession' continues

Over a thousand illegal structures have already been built on grabbed railway lands in different areas of the district while a section of occupiers are illegally selling 'possession' of such

About 500 acres of railway lands worth about Tk 500 crore in the district are under illegal occupation and those are mostly being used on commercial basis, said sources at Lalmonirhat railway's estate office.

"I used two bighas of Manik Miah said. railway land for ten years after leasing it from the railway authority. Six on railway lands for running

months ago, I sold its possession for Tk 2 lakh," said Nazrul Islam, at Fulgachh village in Lalmonirhat Sadar upazila.

Abdus Sattar, a trader at

Futani Bazar in the town, said he purchased one decimal of railway land for commercial use for Tk 50 thousand from Manik Miah in the area a year ago and built a structure on it for running a business "I sold the possession of

Estate officials are ready to conduct drives to free occupied railway lands and demolish illegal structures there soon, he said.

Clash over forming Eidgah committee leaves one dead

A madrasa student was killed and four others were injured in a clash between two groups of villagers following a feud over formation of an Eidgah committee and leasing of a local bazar at Jhaugara village in Nandail upazila of the district yesterday.

The dead was identified as Ashraful Islam Farid, 20, a second year Fazil student of Achargaon Fazil Madrasa in the upazila, and son of late Abdul Hamid of the village.

Quoting locals, Md Ataur Rahman, officer-incharge (OC) of Nandail Police Station, said there had been a feud between the family of Farid and neighbour Abul Kalam over formation of Jhaugara Eidgah committee and leasing of local Utla Bazar.

Farid's elder brother Shafiqul Islam Masud, also a local leader of Bangladesh Chhatra League, was elected as secretary of the day.

Rivalry was heightened as Kalam leased the bazar, said the OC.

The two groups locked in an altercation over the issue at the village around 10:00pm on Friday, and at one stage, they swooped on each other, leaving at least five people from both sides injured.

180 tortoises seized

Border Guard Bangladesh (BGB) men recovered 180 rare turtles from Putkhali border under Benapole Port Police Station yesterday. Lieutenant Colonel Jahangir Hossain, commanding officer (CO), Border Guard 26-Battalion, said, being tipped off, BGB personnel raided Baropota Bazar on Benapole-Putkhali Road at around 10:00am yesterday and seized the tortoises. The tortoises, which were smuggled in from India, were kept in sacks and suitcases, said the BGB CO. The tortoises were handed over to the department of wildlife conservation centre in Khulna. None was arrested in this connection. A case was lodged with Benapole port police station in this regard.

28 of 54 detained fishermen jailed in 3 districts

Hilsa, current nets, fishing trawlers seized

Law enforcers detained 54 fishermen in Chandpur, Chittagong and Manikganj districts yesterday and the day before for catching mother hilsa, defying a 15day ban till October 9.

Our Chandpur correspondent reported that mobile courts yesterday sentenced 28 fishermen to jail in Sadar upazila.

Coastguards and district taskforce conducted separate drives in the Megna River in the morning and arrested 28 fishermen from Lagnimara and its adjacent areas.

The detainees were later produced before the courts of executive magistrates Rashed Mohammad Kamal and Udayan Dewan. The courts sentenced 19 fisher-

men to one year's imprisonment and nine others to one month's each for netting hilsa, defying the ongoing ban. Away in Chittagong,
