GRAFT CASE Bodi again fails to get HC stay order STAFF CORRESPONDENT

Ruling Awami League lawmaker Abdur Rahman Bodi has further failed to get any stay order from the High Court on the trial proceedings of a corruption case

against him. Anti-Corruption Commission filed the lawsuit with Ramna Police Station on August 21 last year, accusing Bodi of amassing illegal wealth worth Tk 6.33 crore and concealing information about properties worth Tk 3.99 crore in his wealth

statement. An HC bench refused to stay the proceedings against him and returned his petition seeking stay on them back to his lawyer. Bodi's lawyer Abdul Baset Majumder told The Daily Star that his client may move the petition before any other HC bench. The Special Judge's

Court-3 of Dhaka is set to record statements of witnesses in the case on October 27, said ACC lawyer Khurshid Alam Khan, adding that the MP is now on bail.

WAR CRIME SUSPECTS IN KISHOREGANJ

Evidence found against 2 more

The International Crimes Tribunal's investigation agency yesterday said to have found evidence over the alleged involvement of two persons in war crimes committed in Kishoreganj during the 1971 Liberation War.

Syed Mohammad Hussain alias Hossain, 64, and Muhammad Moslem Pradhan, 66, were involved in the killing of at least 63 people in Nikli and Kishoreganj sadar upazilas, the agency's coordinator Abdul Hannan Khan told journalists at its Dhanmondi office. They were also allegedly involved in the abduction and

confinement of at least 11 people and looting and torching of at least 250 houses there between mid-August and November 26, he said.

Hussain, younger brother of convicted war criminal Syed Hasan Ali, who was tried in absentia, fled to Malaysia on May 21 last year and the investigations began on November 13, said Sanaul Huq, a senior member of the agency.

Interpol has already issued a red notice and talked to the Malaysian police to bring him back, he said.

Moslem is now in jail on being arrested on July 8 this year after International Crimes Tribunal-2 issued an arres warrant against them, he added.

The agency will submit the probe reports, witnesses' statements and other documents to the prosecution today. The prosecutors will scrutinise those and, if satisfied, press formal charges to initiate trial. The case's investigation officer, Hari Debnath, told The Daily Star that Hussain was originally from Machihata village (Pir Bari) in Brahmanbaria sadar upazila but had been living with his family in Kishoreganj sadar upazila since 1936 as his father worked there.

The Mawna Highway Police Station officer-in-charge allegedly assaulted a CNGrun auto-rickshaw driver on the Dhaka-Mymensingh highway yesterday.

The government banned the vehicles on highways from August 1.

Raihan. He, without elaborating, said they had "orders from high-ups to vandalise" the three-wheelers found on highways.

Man 'kills' wife, stepson

A man allegedly killed his wife and stepson and injured his stepdaughter in Keraniganj, outside the capital, early yesterday.

The deceased were Sahera Begum, 35, and her son Faisal, 7. Sahera's daughter Jannat, 11, is undergoing treatment at Dhaka Medical College Hospital.

Police said Ishaq Ali, 40, a day labourer,

married Sahera about one and a half years back. Later he remarried. Following a quarrel over the matter

on Tuesday night he hacked the three. While he was trying to flee, locals, seeing his blood-stained clothes caught him, police added.

FBUTA temporarily expels

minister and announced to continue holding exams and admission tests till the end of this month. If the demand is not met by then, the teachers plan on abstaining from work for an indefinite period from November 1.

However, JnUTA yesterday announced boycotting an admission test scheduled to begin at Jagannath University tomorrow afternoon to press home the pay scale demand, prompting the expulsion decision within a few hours. JnUTA acted against FBUTA's decision

and breached organisational rules, said the FBUTA member. Jagannath University Vice-Chancellor Mizanur Rahman has called for an urgent meeting of the Academic Council today. The association has been waging a movement where government college teachers and education cadre officials have been protesting cancellation of selection grade and time scale in the pay scale. They abstained from work three times

last month to press home their four-point demand, including reinstating the selection grade and time scale and upgrading salary of different posts under this cadre. The association's secretary general, Prof

IK Selim Ullah Khondaker said they would

again abstain from work on October 18 and 19 and stage a sit-in before the Directorate of Secondary and Higher Education on November 1.

Four more witnesses testify

RAJON MURDER CASE

A Sylhet court recorded testimonies of four witnesses yesterday in the 13year-old Sheikh Samiul Alam Rajon murder case.

The witnesses are Rajon's neighbour Istiak Ahmed Raihan, Nizam Uddin, residents of adjacent Anantapur and Sekhpara villages Abduj Jahir and Pongki Miah. A total of 10 witnesses, including Rajon's parents and the complainant, out of 38 have given depositions in three days.

Ten of the 13 accused were produced before the court yesterday while charge-sheeted accused Shamim Alam and Pavel Islam are absconding and Kamrul Islam is detained in

Saudi Arabia. On July 8, a group of brutes bludgeoned Rajon to death in Sylhet Sadar upazila allegedly for his crime of stealing a rickshawvan. One of the culprits even filmed the horrendous scene
