Three children hurt in Chuadanga bomb blasts

Three children, including two boys, were critically injured in two separate incidents of crude bomb blasts in Chuadanga on Tuesday.

Of them, two boys were badly hurt in Jhanjhadanga village of Damurhuda upazila, and a girl was seriously wounded in Raipur village of Jibonnagar upazila.

According to police, when some kids were playing in a mango orchard around 3:30pm, two boys, Laden, 7, son of Selim Uddin, and Tuhin Uddin, 6, son of Badar Uddin, of Jhanjhadanga village, came into contact with a live crude bomb and it exploded.

Right hand and right leg of Laden and left leg of Tuhin were severely injured. Both are undergoing treatment at Damurhuda Upazila Health Complex.

In another incident, a schoolgirl was wounded in a bomb explosion when her father was reportedly making crude bombs at their house in Raipur.

Left hand of Bristi Khatun alias Eka, 14, was blown off in the blast that occurred around 7:45pm, said Humayun Kabir, officer-in-charge of Jibonnagar Police Station.

Eka is a daughter of Aslam Ali, an alleged member of Janajuddha, a faction of outlawed Purba Banglar Communist Party (PBCP-ML), the police official told this correspondent over phone.

Quoting locals, the OC said Aslam was making bombs at his house and the class-VIII student of Raipur High School was doing her homework, sitting nearby her father.

Suddenly a bomb went off there, said the police official. Aslam along with his daughter went

into hiding soon after the incident, he added.

Later, law enforcers recovered splinters from the spot.

The OC said police were trying to nab them.

station for Dhaka four hours after they awoke, freshened up and ate their breakfast. However, the reason for their sleep

was not too unrealistic. They reached Sylhet yesterday at 4:45am driving the same train from Dhaka, six hours behind schedule. It was humanly impossible for them to start another trip in less than one and a half hours. What is most interesting about it is

that the railway authorities had no alternative arrangement even though they were aware of the delay and the suffering it would cause to about 350 passengers. "Kalni Express, which usually

starts for Sylhet at 4:00pm, started for Sylhet at 10:30pm Tuesday night because of an accident on the route the night before," said Divisional Railway Manager Arifur Rahman. Rummi Qureishi, a passenger who travelled to Dhaka with his daughter,

claimed the authorities could not be more indifferent about the mismanagement. "Finally, the train began to move at 10:40am but there was nobody to say

sorry for the sufferings of the passengers," he said. It arrived at the Kamalapur Railway Station three hours late at 8:20pm, he

According to railway sources, operating staffs of a train are given enough

time to rest after driving a train before they are engaged in the next trip. Alternative drivers, assistant drivers and guards are kept ready so that they can take over during the next trip in case of small gaps between the two "But in case of Kalni train, no

alternative arrangement could be made due to shortage of loco masters, assistant loco masters and guards," said Arifur Rahman, a senior railway official The schedule of Kalni Express is

prepared in a way that the operating staffs can take rest before the train's return trip to Dhaka. "But it was not possible yesterday because of the train's delayed arrival in Sylhet," he mentioned. Recruitment in Bangladesh Railway has stopped for years now

because of writs filed against alleged

corruption in the recruitment process.

It was only last year that a new batch of drivers and assistant drivers were recruited. "Over the last four years, we managed the trips with retired drivers with contractual appointment," said Director Establishment of Railway

The alliances also brought out a procession on the Dhaka University campus, demanding fresh tests for admission into the medical and dental colleges.

The main gate of the Faculty of Arts building was kept locked. Classes at the university were mostly vacant but some examinations took place as per the schedule, said students.

At Chittagong University, some departments suspended their classes and examinations.

The medical admission seekers have consistently been agitating since September 19, a day after the admission tests, complaining that many candidates got the questions through Facebook, WhatsApp, and other social media. Yesterday, around 400 students

along with their guardians held a rally at the Central Shaheed Minar around 11:00am. Expressing solidarity with the movement, some students of Dhaka Medical College (DMC) joined in. With banners and posters, they took

out a procession and went to Shahbagh, but found the street in front of the Public Library barricaded. Removing the barricades, they moved on and kept the busy Shahbagh

intersection blocked from all sides from 12:30pm till 2:00pm, halting traffic and creating huge tailbacks. Jote, Samrajjobad Birodhi Chhatra Oikya, students of Bangabandhu Sheikh Mujib Medical University and

some private medical colleges joined

them there.

Talking to The Daily Star, Nowshin Tabaussum, a fourth year student at the DMC, said they quit their classes to join the demonstration. "We will not accept that our juniors

Blatter was informed of the decision by the head of FIFA's Adjudicatory Chamber Hans-Joachim Eckhardt.

Stoehlker said Blatter would be back in his FIFA office Thursday, insisting that the Swiss hadn't served his last day as the organisation's president.

Pressure group NewFIFANow, which has campaigned against Blatter, reiterated its call for radical reform of the world governing body. "With criminal investigations

reaching the highest levels of FIFA, and potential ethics investigations into other Presidential candidates, it once again reinforces the need for a complete 'new broom' at FIFA to implement independent reform and essentially to start again," said a NewFIFANow statement.

If Blatter is suspended, Issa Hayatou, vice-president of FIFA, would potentially be in line to take charge of the organisation.
