Mother burns kid to death, attempts immolation

A housewife burnt her baby to death and attempted the same on herself yesterday, allegedly failing to bear with the torture inflicted by her husband and mother-in-law at Nurpara village in Shalikhapada upazila under Magura district.

The woman, Anima Biswas, 18, daughter of Goutam Biswas of Bamonail village in Jhenidah Sadar upazila, was admitted to Magura Sadar Hospital with critical burn injuries.

Anima was married to Sumon Biswas, son of Swapan Biswas of Nurpara village under Shalikhapada upazila, two years ago, said neighbour Lipi Biswas of Nurpara village.

"After a daughter was born to them eight months ago, Sumon and his mother Monimala started to torture Anima on trivial

matters. As the torture was beyond measure, she finally decided to put an end to her life.

She poured kerosene on her body and her 8 months daughter Shruti Biswas and burnt with gas light around 11:00am yesterday.

They were rushed to Magura Sadar Hospital where Shruti died around 12 noon.

"The baby died due to burn injuries all over her body. Anima got burnt 85% of her body including the windpipe. We suggested shifting her to the Burn Unit of Dhaka Medical College Hospital. But there is little hope of her survival," said Dr Amar Prasad of Magura Sadar Hospital.

Police arrested Anima's husband Sumon and her mother-in-law Monimala and preparation was on to file a case, said Abu Jihad, officer in charge of Shalikhapada Police Station.

The kid's body was sent to morgue for an autopsy.

GP official stabbed, robbed of Tk 3 lakh

Muggers snatched away Tk 3 lakh from a Grameen Phone (GP) official after stabbing him at Pachmaria in Puthia upazila of Rajshahi district on Wednesday, reports UNB.

The victim is Sitanath Banik, 36, son of Shushil Banik of Raninagar upazila in Naogaon district. Sitanath represents the mobile phone operator from its Pachmaria local office.

Hafizur Rahman, inspector of Puthia Police Station, said in the afternoon, Sitanath was going to Rajshahi city after collecting flexiload (an electronic bill payment system) money from the local traders.

When he reached Pachmaria, a gang of six riding three motorbikes swooped on him, stabbed him indiscriminately and took away the money from his possession.

He was rushed to Rajshahi Medical College Hospital (RMCH) and later shifted to Dhaka, said Abdul Malek, in-charge of RMCH police outpost.

In Natore, robbers looted cash and other valuables from three shops after killing a night guard in Sadar upazila of the district early yesterday.

The deceased was identified as Abul Bashar, 65, of Alaipura area in the district town, reports our correspondent.

Mizanur Rahman, officer-in-charge of Sadar Police Station, said a gang strangled Bashar and took away Tk 7 lakh and goods from the shops at Uttara Super Market in the area.

Two cattle traders shot by BSF

Indian Border Security Force (BSF) shot two cattle traders, including a Bangladeshi national, at Pathordubi border in Bhurungamari upazila of the district yesterday.

The injured are Nur Islam, 35, son of Makbul Hossain of Dakkhin Pathordubi village in the upazila, and Jakir Hosen, 44, of Chawdhurhat area under Dinhatia Police Station in Cooch Bihar district of Pashchimbanga in India, said Shahadat Hossain, chairman of Pathordubi Union Parishad.

Nayek Subedar Rafiqul Islam, Pathordubi BOP commander of BGB-45 Battalion, said the BSF men opened fire on the two when they entered the border area around 1:30am. Soon after the incident, the injured managed to flee the scene.

They sent a letter to BSF protesting the incident, said the commander.

Owner of shrimp enclosure hacked to death, 9 arrested

Owner of a shrimp enclosure was hacked to death and five members of his family were injured in an attack by their rivals in Gabura union under Shyamnagar upazila of the district on Wednesday night.

The deceased was identified as Shafiqul Islam, 40, son of Abdus Sattar Khan of Kholpatua village under the union.

Gabura Union Chairman Masudul Alam said Shafiqul had been cultivating shrimp on a land which his father bought 15 years back.

Claiming the ownership of the land, one Lokman Gazi of the same area locked in altercation with Shafiqul on Wednesday night.

At one stage, Lokman and his men hacked Shafiqul, his wife Parul Begum, and their sons Abu Raihan, Abdul Halim, Newaz Hossain and Habibullah with sharp weap-

ons, leaving them critically injured.

The injured were rushed to Shyamnagar Upazila Health Complex. Later, Shafiqul was shifted to Khulna Medical College Hospital where he died at midnight.

Habibullah Khan, brother of the deceased, filed a case with Shyamnagar Police Station, accusing Lokman Gazi and 36 others.

Officer-in-Charge (OC) Enamul Haque of Shyamnagar Police Station said law enforcers arrested nine of the accused named Abdur Rahim Gazi, Shekander Ali, Shariful Gazi, Ahadul Islam, Maniruzzaman Gazi, Jamaluddin, Nazrul Islam, Nurul Islam and Rizia Khatun from the area. Drive is on to arrest the rest of the accused, the OC added.

Additional police have been deployed in the area.

Schoolgirl raped in Meherpur

A schoolgirl was raped allegedly by a college student at Garadoba village in Gangni upazila of Meherpur district on Wednesday.

The accomplices of the rapist also took video of the rape scene, said police.

Rapid Action Battalion (Rab) arrested a youth in connection with the incident.

Shuvo Hossain, an honours first year student of Bashbaria College in the upazila,

and son of Anwarul Islam of the village, used to tease the eight grader of the area, said Rab sources.

Around 8:00pm on Wednesday, Shuvo and his four accomplices kidnapped the girl when she went out of house to fetch water from a neighbour's tube-well. They took her to a nearby brick kiln.

"Shuvo raped the girl when his accomplices took video of the scene," said Moniruzzaman, sub-inspector of Gangni Police Station, quoting the victim.

3 Pabna ASI murder suspects held

Police detained three alleged killers of ASI Sujaul Islam of Pakshey Police Camp early yesterday.

The arrestees are Md Khokon Hossain, 32, of Juktitola village, Jani Pramanik, 21, of Baghail village and Masud Rana, 25, of Thakurpara village under Ishwardi upazila. They are drug peddlers and muggers, police said.

Police produced them before the Chief Judicial Magistrate's Court yesterday afternoon, seeking 10 days remand. The Court fixed October 11 for hearing on the prayer.

Acting on a tip-off, police raided different areas of Pakshey and arrested the three, said Md Abu Jahid, assistant superintendent of police (Ishwardi Circle). They are being quizzed, he added.


Assistant sub-inspector Md Sujaul Islam was strangled early Monday. Later, his body was recovered from a turmeric field near Pakshey rail station.

Sub-Inspector Rezaul Islam of Pakshey Police Camp filed a case with Ishwardi Police Station on Tuesday, accusing unnamed criminals.

Woman commits 'suicide'

A woman allegedly committed suicide at Shalmara village in Aditmari upazila of the district yesterday morning. The dead is Hawa Begum, 46, wife of Ala Uddin of the village. She was a mentally imbalanced woman. Police and family sources said on Wednesday, Hawa went to visit her daughter at Devirpat village where she was insulted by her son-in-law. After returning home, she killed herself by taking poison.

Grocer beaten to death

A grocer was beaten to death at Dalgram village in Kaliganj upazila of the district yesterday. The deceased is Shahjahan Ali, 32, son of Yasin Ali of the village. Locals said three people called Shahjahan out of his shop at Dalgram Bazar around 10:30pm. The following day, locals found the body in the area and informed police who recovered the body and sent it to Lalmonirhat Sadar Hospital morgue for autopsy. Sajjad Hossain, officer-in-charge of Kaliganj Police Station, said the reason behind the killing could not be known immediately.

Man electrocuted

A young man died from electrocution at Haraitrilochan village in Jakiganj upazila of the district on Wednesday. The deceased was identified as Abul Hossain, 25, son of late Moiab Ali of the village. Witnesses said Abul sustained injuries when he came in contact with a live electric wire while he was playing in a field in the area in the morning. He was rushed to the upazila health complex where on-duty doctors declared him dead.

Hizb ut-Tahrir member held

Detective Branch (DB) of police arrested an alleged member of the banned Islamist outfit Hizb ut-Tahrir Bangladesh in Jail Road area of Jessore town on Wednesday. The arrestee is Tanjila Tamanna Asha, 22, wife of Ibrahim Khalil of Durgapur village in Sadar upazila. Officer-in-Charge of Jessore DB police Maniruzzaman said on secret information, the law enforcers conducted a drive in the area and arrested Tanjila at night. Tanjila is a sister of Hizb ut-Tahrir regional commander Tanjib Ahmed alias Ashraf, who was arrested by detectives on September 21, said the OC.
