Horizons principal investigator from Southwest Research Institute (SwRI), Boulder, Colorado, in a statement.

The blue in the picture allows scientists to judge how exactly it is made.

"That striking blue tint tells us about the size and composition of the haze particles," said science team researcher Carly Howett, also of SwRI. "A blue sky often results from scattering of sunlight by very small particles. On Earth, those particles are very tiny nitrogen molecules. On Pluto they appear to be larger -- but still relatively small -- soot-like particles we call

tholins." Nasa also said that it had found small, exposed regions of ice on the dwarf planet. Those bits of ice correlate with previously seen red patches on the surface -- and scientists aren't sure

"I'm surprised that this water ice is so red," says Silvia Protopapa, a science team member from the University of Maryland, College Park. "We don't yet understand the relationship between water ice and the reddish tholin

colorants on Pluto's surface." The water only appears in patches. Scientists are planning to explore why exactly those patches form, and why they appear where they do.

"Large expanses of Pluto don't show exposed water ice," said science team member Jason Cook, of SwRI, "because it's apparently masked by other, more volatile ices across most of the planet. Understanding why water appears exactly where it does, and not in other places, is a challenge that we

Another 37 people were wounded, according to the global charity group, which works in conflict zones to help victims of war and other tragedies, reports CNN.

Direct presidential apologies to victims of American actions abroad are rare, but not unheard-of. In 2012, Obama wrote a letter of apology to President Hamid Karzai of Afghanistan after several copies of the Quran were burned by American military personnel, leading to violent protests across that country. In 2004, President George W Bush apologised for the treatment of Iraqi prisoners at the Abu Ghraib military prison, telling world leaders that he was "sorry for the humiliation."

Whether to deliver an apology is a difficult and sensitive decision for any president, but particularly for this one. Obama has been pilloried since the beginning of his presidency by Republicans who accuse him of being a serial apologizer for America. Mitt Romney, the Republican

candidate for president in 2012, wrote

a book titled "No Apology," a not-sosubtle dig at Obama. And Dick Cheney, the former vice president, recently published a book renewing the apology criticism of the president. In this case, Obama proceeded with caution. Two days after the bombing, he expressed his "deepest condolences" to families of the hospital victims, calling it a "tragic incident."

But he and other White House officials resisted further comment for several days, citing the need to let investigations continue, reports New York Times. That changed on Wednesday after

Two weeks before the Mina incident, 107 people died as a construction crane collapsed into the Grand Mosque in Mekkah.

Many countries that sent pilgrims to this year's Hajj estimated the number of deaths in stampede alone at more than 1,000. News agency Associated Press

yesterday claimed that both the tragedies during the annual hajj pilgrimage to the kingdom killed at least 1,264 people.

The number is based on the tolls offered by 17 countries through their officials or state media broadcasts.

Health authorities in the kingdom had said civil defence officials would be offering any new casualty figure but no new toll has been released since September 26.

The disaster in Mina happened as two waves of pilgrims converged on a narrow road, causing hundreds of people to be suffocated or trampled to death, said the Saudi authorities.

But Iran has blamed it on the kingdom's "mismanagement." It also accused Riyadh of a cover-up, saying the real death toll exceeds 4,700, without providing evidence to support its claim, according to an AP report.

Diplomats in Indonesia, Pakistan and India have said Saudi officials gave them some 1,100 photographs of dead victims of the Mina disaster. Saudi officials, however, say the photographs include pilgrims who died of natural causes during Haji.

Shamuk-khol is an Asian openbill

or Asian openbill stork. It is a large wading bird in the stork family Ciconiidae. This distinctive stork is found mainly in the Indian subcontinent and Southeast Asia. It is greyish white with glossy black wings and tail and the adults have a gap between the arched upper mandible and recurved lower mandible. During a visit to the spot on

Tuesday, 15km off the district headquarters, this correspondent saw over one thousand birds on the trees, while a few of them were flying in and out. Several visitors were also seen there.

Some of them were taking snaps. The chirping of the birds in the

evening makes the surrounding fascinating. During daytime, they leave the

hundreds of Shamuk-khol on the

tree in groups and come back again gradually. Akbar Ali, who came to visit the place, said it was really amazing to see

"The chirping of these birds soothes the mind, and the way they fly overhead adds some adventure to our rural life," he said.

Mollan village's resident Wahedul Islam and his four brothers started conserving the huge Shamuk-khol birds eight years ago as the birds lived near their houses. "It's a matter of pride for us that

people from far-flung areas come here to see the birds," he said. Villagers said BGB men from

Bakher Ali Border Observation Post (BOP) under BGB 9 Battalion in Chapainawabganj keep regular vigil. The trust and bonding that these birds and villagers have developed is

worth admiring. Sundarpur Union Parishad Chairman Matiur Rahman, who pays

Eighteen of the accused are Salamat Ullah Khan, 77, Moulavi Zakaria Sikdar, 78, Md Rashid Miah, 83, Oli Ahmad, 58, Jalal Uddin alias Jalal Ahmed, 63, Moulavi Nurul Islam, 61, Md Saiful alias Sabul, 53, Momtaz Ahmed, 60, Habibur Rahmar alias Habib Munshi, 70, Moulavi Amjad Ali, 70, Abdul Majid, 85, Badsha Mia, 73, Osman Gani, 61, Abdus Shukkur, 65, Md Zakaria, 58, Md Jinnah alias Jinnat Ali, 58, Moulavi Jalal, 75, and Abdul Aziz, 68.

Investigators didn't disclose the name of the other accused.

Of the accused, Salamat, Nurul Islam, Badsha, Osman Gani and Jinnat Ali are behind bars while Rashid Miah is on bail for ill health. The rest are on the run. **IDENTITIES OF ACCUSED** According to the agency, Salamat Ullah was a former vice president of Maheshkhali Convention Muslim League and convenor of Maheshkhali Peace Committee in 1971. In 1978, he became the founding president of Cox's Bazar district BNP. He is still involved with

BNP as a member. Moulavi Zakaria was a former president of Maheshkhali unit Nezam-e-Islami and a vicechairman of the thana Peace Committee in 1971. He contested the Provincial Assembly election in 1970 in the then East Pakistan from Cox's Bazar on Nezam-e-Islami's ticket.

He is now involved with Hefajate-Islam, a Qawmi madrasa-based Islamist organisation. The accused went into hiding after the International Crimes Tribunal-2, now inoperative, issued arrest warrants for him and two others in March this year, said the investigation agency.

As per the law, an individual taxpayer has to pay between 10 and 30 percent tax depending on the amount of the income unless it is tax-free. In the current fiscal year, the tax-free threshold is Tk 250,000, which was Tk 220,000 in fiscal 2014-2015. The NBR official said since the tax

rate for some sectors, including fish farming, was as low as 3 percent in the last fiscal year, some people showed their previously earned money as income from fish farming, and paid a 10 percent penalty on top of 3 percent tax. "That is why the amount of tax

money didn't increase in proportion to the undisclosed money legalised in the last fiscal year. We are looking into the matter. We will take steps if we find that anyone took advantage of the facility, violating the law." NBR officials said the government
