Local polls to be partisan

Proposal goes to cabinet today; amended law to allow political parties to nominate candidates

The LGRD ministry seeks changes to the local government laws for allowing political parties to nominate candidates in local body elections.

It will place a proposal to this effect at today's cabinet meeting for approval, LGRD Minister Khandker Mosharraf Hossain told The Daily Star yesterday.

If the laws are amended, elections to zila, upazila and union parishads, city corporations and municipalities will be partisan just like the parliamentary polls.

Currently, grassroots leaders of political parties can contest local body polls but they cannot use their parties' electoral symbols. And the parties extend support to them but cannot openly campaign for their men.

The changes will remove the restrictions on political parties in nominating candidates and engaging openly in electioneering for their favourites.

According to the proposal to be made, political parties registered with the Election Commission will be allowed to contest the local body elections by nominating their candi-

The Jamaat-e-Islami may not be able to contest local body polls as its registration with the EC has been scrapped by the High Court. The matter is now pending with the Supreme Court.

In defence of making the polls partisan, the LGRD minister said, "The new system will further strengthen democratic SEE PAGE 2 COL 1

Seventeen days have passed since the deadly Hajj stampede but Saudi Arabia has still kept Dhaka in the dark on handing over of the bodies of Bangladeshi victims.

"The Saudi government hasn't yet said anything on whether they will send back the bodies of our hajis or not," Religious Affairs Secretary Chowdhury Md Babul Hassan said.

"We have no information if families of the victims will get back the bodies at all," he told reporters at his secretariat office yesterday.

He heavily criticised the Saudis for their "rigidity" in sharing information on the

Charge sheet states plans of 3 arrested 'IS suspects' to recruit fighters, join jihad

COURT CORRESPONDENT

Three suspected militants, who were among those arrested in the last one year for alleged IS links, had plans to recruit jihadi fighters and go to Turkey disguised as Tablighi Jamaat men en route to Syria, reads the charge sheet against them.

Since September last year, about 15 suspects have been arrested for "having or trying to establish contacts" with Islamic State (IS), according to police press releases and briefings at different times.

In July this year, detectives pressed charges against three of the detainees -- Samiun Rahman alias Ibn Hamdan, a British citizen of Bangladesh origin who allegedly fought in Syria, and his two recruits Asif Adnan Shuvo and Fazle Elahi Tanzil.

The Daily Star has obtained a copy of the charge sheet. "They planned to recruit 8/10 fighters and go to Syria. For this, they decided to go to Turkey first, disguised as members of Tablighi Jamaat [an Islamic movement to spread faith]," reads the charge sheet, submitted to the Chief Metropolitan Magistrate's Court of Dhaka on July 22.
