
Police submitted charge sheet against three people in a case for torturing a schoolboy in the district yesterday.

Four accused in Pabna ASI

A Pabna court yesterday placed four accused in the case for killing police officer Sujaul Islam on a five day remand.

The accused -- Md Khokon Hossain, 32, of Juktitola village, Jani Pramanik, 21, of Baghail village, Masud Rana, 25, of Thakurpara village, and Md Shetu, 25, of Pakshey in Ishwardi upazila of the district -are drug peddlers and muggers, police said.

Shetu was arrested on Saturday from Pakshey while the rest three were arrested from different areas in the upazila on Thursday.

Police produced the arrestees before the Additional Chief Judicial Magistrate's Court yesterday, seeking 10 days' remand for each

of them. Additional Chief Judicial Magistrate Md Rejaul Karim granted five days' remand, said Biman Kumar Das, officer-in-charge of Ishwardi Police Station.

"We have got some clues and vital information from the arrestees during interrogation," the OC said, adding that they found involvement of the arrestees with the murder during primary investigation.

Assistant sub-inspector (ASI) Md Sujaul Islam was called out of his house by an unidentified caller early Monday. His body was recovered from a turmeric field near Pakshey rail station on the day.

SI Rejaul Islam of Pakshey Police Camp filed a case with Ishwardi Police Station on Tuesday, accusing unnamed criminals.

Police, quoting locals, said Apon along with other boys was playing in front of the rice mill, which belongs to one Sultan of the village, at around 9:00am. At that time, the boiler

exploded with a big bang and its broken parts hit the boy, leaving him dead on the spot, said Deen-e-Alam, officer-in-charge (OC) of Islampur Police Station.

One killed, 15 hurt in clash over land dispute

A man was killed and 15 others were injured in a clash between two rival groups over land dispute at Sikandarpur village in Dirai upazila of Sunamganj district yesterday.

The deceased was identified as Abdul Malik, 60, a resident of the village.

Bayes Alam, officer-incharge of Dirai Police Station, said there was a longstanding dispute between Juned Ahmed, 45, and Sumon Miah, 40, over the ownership of a piece of land at the village.

As a sequel to the conflict, supporters of Juned Ahmed, 45, and Sumon Miah, 40, attacked each other at about 9:00am, leaving Abdul Malik dead on the spot and 15 others injured. Five of the injured were

admitted to Sylhet MAG Osmani Medical College Hospital while the rest 10 others took admission at Sunamganj Sadar Hospital and Dirai Upazila Health Complex. Police recovered the

body and sent it to Sunamgani Sadar Hospital morgue for autopsy.
