Three cases have been filed against lawmaker Begum Monnujan Sufian, also the managing committee president of the city's Daulatpur Day-Night College, and 16 others for suspending its former principal and two other teachers.

Former principal Chowdhury Mahbubul Haque, lecturer of biology Kazi Misbaful Tarik and lecturer of English Farzana Haque filed the cases with a Khulna court on Tuesday alleging that the managing committee suspended them illegally on September 17 without giving them any chance of self-defence. 

Pregnant woman killed by stepson in capital

An eight-month pregnant woman was killed by her stepson following an altercation in the capital's Kamrangirchar yesterday.

Bilkis Begum, 26, was the second wife of Zasim Hajari of Hujur Para of the area, Officer-in-Charge of Kamrangirchar Police Station Sheikh Mohsin Alam said.

The stepson Rabiul Islam, 18, killed Bilkis by slitting her throat, Mohsin added.

Hearing her screams, neighbours rushed there and caught Rabiul while he was fleeing. Later, they handed him over to police.

Rabiul's father married Bilkis two and half years ago. Due to his father's remarriage Rabiul and his mother who lives in Barisal used to quarrel with Zasim and Bilkis, said the OC.

Rab captures seven 'blackmailers'

The Rapid Action Battalion detained seven persons allegedly for blackmailing an expatriate and seized around Tk 32,200, US\$33, and eight cellphones from them in the capital's Kafrul on Tuesday.

The detainees are Abdul Maleq, his wife Rasheda Begum, Shirin Aktar, Khairul Alam, Faruq Hossain, Shahidul Islam and Ariful Islam. From Maleq's house, Rab also rescued expatriate Ziaul

Haque, who lives in the Maldives, said Assistant Superintendent of Police Mujahidul Islam of Rab-4. The arrestees admitted that Shirin developed a relation-

ship with Ziaul a couple of months ago over the phone.

Ziaul went to the house on her invitation. Later, the other six took "compromising" photos of him with Shirin, Mujahidul said. Afterwards, they demanded Tk 5 lakh threatening him to publish the photos on the internet otherwise, he added.

for treatment. Ship-breaking Workers Trade Union Forum yesterday demanded Tk 10 lakh in compensation for each of the eight victim families which either had lost or got their members injured in a gas cylinder explosion at Shital Enterprise Ship-breaking yard on September 5. At a press conference in Chittagong city, Convener

of the forum Tapan Dutta mentioned that four workers died, one is still fighting for life in a hospital while the other three were brought back to the shed from hospitals without full treatment. The owner paid a nominal amount only to the

families of the dead, said the convener, threatening to wage tougher movement if the compensations are not paid to the eight families in next seven days.
