

## AL men enraged over MP's arrest

Lay siege to Gaibandha DC, SP offices, scuffle with cops as lawmaker Liton lands in jail over shooting a child

Aggrieved over the arrest of lawmaker Manjurul Islam Liton, several hundred Awami League men in Gaibandha besieged the entrance of local administration offices and the district court yesterday, demanding his unconditional

Liton's supporters also scuffled with police as he was being taken to a court.

The court later sent him to jail, rejecting his bail petitions in two cases over shooting of a 10-year-old boy and vandalising a house in Sundarganj upazila on October 2.

The lawmaker's men from the upazila halted traffic movements on Gaibandha-Palashbabri road for an hour, prompting police to charge batons and fire rubber bullets and teargas shells to disperse them, leaving 17 people injured, sources said.

The AL men led by Golam Mostafa Ahmed, general secretary of Sundarganj upazila AL, called a road and rail blockade in the upazila for Sunday.

They will also hold a protest rally in the upazila the same day to press home their demands -- withdrawal of the "false cases" and the immediate SEE PAGE 2 COL 4

#### MOJAHEED, SQ CHY Govt for quick hearing of review pleas

The government yesterday appealed to the Supreme Court to set a date to hold as early as possible the hearings on the review petitions submitted by war criminals Ali Ahsan Mohammad Mojaheed and Salauddin Quader Chowdhury.

The attorney general's office submitted two petitions to the SC, saying that the review petitions in the cases filed under the International Crimes (Tribunal) Act should be heard and disposed of expeditiously as what was said in the apex court judgment regarding war criminal Abdul Quader Mollah's review petition.

# No militant links found

Claims DMP boss on Tavella murder

Dhaka Metropolitan Police Commissioner Asaduzzaman Mia yesterday said investigators found "not even the slightest" militant link with the murder of Italian aid worker Cesare Tavella.

"Local and international conspirators are involved in the murder," he told reporters at a programme at the DMP headquarters.

The evidence and information collected by police didn't suggest that the murder was a work of militants, he claimed. Tavella, a project manager of the Netherlands-based NGO ICCO Cooperation Bangladesh, was gunned down by three unidentified criminals in the high security diplomatic

area in Gulshan on September 28. Following the murder, SITE Intelligence Group -- a USbased company that tracks online activities of Jihadi organisations -- claimed that the Islamic State terrorists claimed SEE PAGE 17 COL 2 SEE PAGE 2 COL 5
