

# MEDICAL ADMISSION TEST RETAKE DEMAND BMA, agitators at loggerheads

Doctors' association refuses to have Anu Muhammad, Sara Hossain, IT experts in body for probing question leak

High Bangladesh Medical Association (BMA) officials and representatives of agitators demanding fresh medical and dental college admission tests yesterday failed to reach consensus on forming a body to probe allegations that the September 18 tests' question papers were leaked.

The agitators, in a press release, announced holding a press conference today at noon at Dhaka University's Teacher-Student Centre and declare programmes.

The representatives had wanted to include Barrister Sara Hossain, Prof Anu Muhammad and IT experts from their part in the committee which was to be formed comprising BMA members, spokesperson Tanvir Ahmed told The Daily Star.

But BMA rejected it at the two-hour long meeting in BMA Bhaban in the capital's Topkhana Road, prompting the representatives to refrain from providing the leak's evidence, he said.

They were supposed to provide the evidence and discuss on forming the body yesterday as per the decision taken during Monday night's meeting with the Directorate General of Health Services (DGHS) at the BMA auditorium, he added.

Acknowledging this, BMA's Dhaka city unit Vice-President Abdur Rauf Sarder said the body had to comprise only BMA members to remain impartial.

Among those present on Monday night's meeting were noted columnist Syed Abul Maksud, journalist Abu Sayed Khan, and DGHS Director General Prof Deen Muhammad Noorul Haque, Additional Director General Abul Kalam Azad and Director (admin) Ehteshanul Haq Chowdhury.

"Concerned citizens" on Monday formed a 17-member "public committee", convened by eminent economist Prof Anu Muhammad, to investigate the allegations, prepare a report by November 20 and provide it to DGHS seeking measures.

As Dr Omar declined to lead the committee, another committee headed by Ashraf Ali was formed on September 27 and it was asked to submit a report within seven working days. But, it failed to submit the report within the stipulated time and submitted it on Monday.

Talking to The Daily Star, Harun alleged that the doctors had changed the information in Waheda's medical file stating that her left leg and hand were injured in the accident.

"The old file stated that only her left leg was injured in the accident," he said.

He also said doctors of the department hid the report of the X-ray performed immediately after the incident.

This correspondent then contacted Ashraf Ali but he did not want to comment on the matter and said, "Our investigation is going on and we will submit our report very soon."

Dr Alok Kumar Biswas, head of the orthopaedic department, said he did not want to make any comment without permission from the director, and the director did not answer the calls made to him.

Mariam Begum, Waheda's mother, said her daughter lost her hand due to negligence and she wants justice.

Living a hand-to-mouth existence, Waheda's family had to borrow Tk 75,000 from relatives for the treatment so far, Mariam said.

# WAR CRIMES TRIAL Another implicates Taher, Noni in murder

A prosecution witness yesterday corroborated the allegation of murder of one Fazlur Rahman in Netrakona by war crimes accused Obaidul Haque alias Taher and Ataur Rahman alias Noni during the 1971 Liberation War.

The 22nd prosecution witness, Shanto Miah, told International Crimes Tribunal-1 that it was a Tuesday morning on August 17 when Obaidul and Ataur along with 20-25 Razakars and the Pakistani occupation army went to Baushi Bazar.

They detained four-five persons and beat Hannan Chowdhury and Abdul Hye before taking them in front of one Ranjan Saha's shop, he said.

Fazlur arrived at the shop and was detained. "Since Fazlur was a supporter of Awami League, he was repeatedly pierced with bayonets," Shanto said. Releasing the others, Obaidul and Taher took him to Dak Bungalow of Netrakona, he said.

# DEMAND FOR UPGRADE IN NEW PAYSACLE Pry school teachers to stage grand rally on Dec 24

Primary school teachers yesterday called for rallies at district- and division-level from November 1 to December 15, and a grand rally in Dhaka's Central Shaheed Minar on December 24 to press home their demand for upgrading their status to 11th grade in the 8th national payscale, reports UNB.

Prathamik Sahakari Shikhhak Federation, an alliance of four organisations of the teachers' associations, announced it at a press conference at Jatiya Press Club.

Jahidur Rahman Biswas, president of Bangladesh Sarkari Prathamik Bidalaya Shikhhak Samity, one of the alliance members, said some 3.5 lakh assistant primary school teachers were the victims of salary discrimination.

The teachers' leaders demanded elimination of the "disparity" in the new payscale by providing a minimum salary of Tk 12,500, 100 percent departmental promotion to headmaster post instead of direct recruitment in head teacher post, fixing minimum eligibility of a Bachelor's degree instead of HSC to be an assistant teacher, and a separate payscale for teachers.

Our staff correspondent adds, the teachers observed work stoppage several days in the last one month for realising their demands.

Meanwhile, Swadhinata Shikhhak Parishad, a platform of the teachers of non-government schools, colleges, madrasas and universities, yesterday demanded inclusion of adequate representatives from non-government institutions in the proposed separate commission to recruit teachers.

At a press conference, they also sought nationalisation of all non-government educational institutions.
