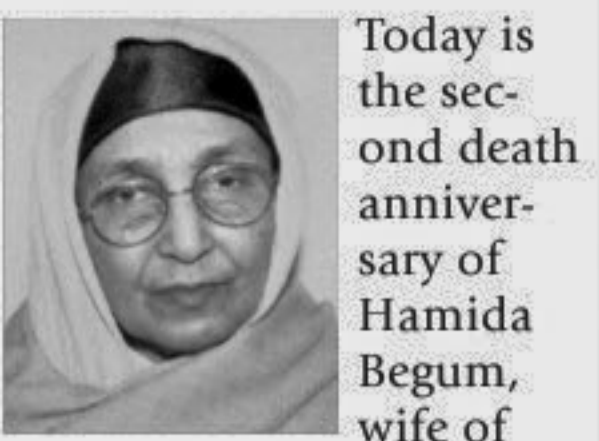


**Death anniversary**

**2 killed in capital**

*Another body found in hotel toilet*

The body of a man was found in a toilet of a hotel room while two youths were killed in separate incidents in the capital yesterday.

Kawsar, 35, a resident of Alamdanga in Chuadanga district, was found dead in a hotel toilet at Jagannathpur in Bhatara.

He along with a woman boarded the Hotel Heaven Touch on Tuesday. The woman told police that Kawsar fell down on the floor when he went to the toilet in the morning.

Police recovered the body and some medicines from the toilet of a room after the woman informed the hotel authorities.

The woman was not a relative of Kawsar and they took her to Police Station for interrogation, said the OC. The body was sent to Dhaka Medical College Hospital morgue for autopsy.

In another incident, Nurul Islam Sabuz, 35, a peon at the office of Gabtali Masjid Market Association, was killed by unidentified criminals at his office in Gabtoli area.

Darussalam police recovered his body from the office around 12:15pm and sent it to Dhaka Medical College Morgue for autopsy. Police said they found two blood smeared bricks lying beside the body. There was an injury mark in victim's forehead. Blood was also spotted in his nose, mouth and some parts of the body.

Meanwhile, Abdul Aziz, 30, a furniture shop employee, was found dead from the shop of Sikder furniture around 10:30 in Uttar Jatrabari area.

Aziz used to live inside the shop at night. When another employee opened the shop in the morning, he found his body lying on the floor, said Sub-inspector Jakir Hossain of Jatrabari Police Station. The body was sent to Sir Salimullah Medical College for autopsy. The body bore stab marks in the head and abdomen, said morgue sources.

**Three hurt workers die in port city**

*Inspectors find lack of safety measures at the yard; owners yet to comply to show cause notice; victims yet to be compensated*

Three ship-breaking workers, who were injured in a gas-tank explosion at RA Ship-breaking Yard in Chittagong's Sitakunda upazila on October 13, died at Chittagong Medical College Hospital on October 18 and October 19.

The dead were Md Russell, 20, his cousin Md Khairul, 22, both of Magura, and Md Alamgir, 35.

4:30pm, Razakars including accused Muhibur Rahman Boromian, Mujibur Rahman Angur Mian, Abdur Razzak and Hamid surrounded our house," said Mostor, adding that Razab attempted to flee.

"At that time, Muhibur Rahman Boromian shot at Rajab Ali with his rifle and other Razakars caught my brother Akal Ali. Hit in the belly, Rajab Ali immediately fell down," he said.

Mostor said he watched from another room as Akal was dragged out by Razakars blindfolded with his hands tied about three-four minutes later.

Akal's two wives begged for his release but to no avail, he said, adding that the Razakars took Akal to their camp, some 200-300 yards away, and tortured him inhumanly and that they heard the screams.

Quoting a neighbour, Torajullah, he said Muhibur, Mujibur and Razzak along with other Razakars took Akal to an unknown place that night and killed him.

Afterwards, the witness identified the accused in the dock and the defence began cross-examining him. Proceedings were adjourned until October 27.

The three accused are facing four charges for their alleged involvement in crimes against humanity during the Liberation War.
