# Teachers, students worried as school under erosion threat

Sundra Kalikapur High School in Mirzaganj upazila of the district is under the threat of collapse into the Payra River, much to the worry of students, teacher and guardians.  
Local people set up the high school in a tin-shed house in 1969 and later Education Engineering Department with the fund of Ashian Development Bank built a concrete building for the school in 1993-94 fiscal year, said school sources.  
That time the Payra River

was over one kilometre away but it has now reached just beside the school.  
A portion of the school building has already caved in and it may collapse any time, said schoolteachers and guardians.  
"Most of the students come from poor families. Their schooling will stop if the school building collapses into the river as they cannot afford to study in distant places. The authority should take immediate steps to shift the school to a nearby safe place," said Abul Kalam, a guardian.

Abdur Razzak, headmaster of the school, said they have already shifted the tin-shed house of the school with furniture and other materials to another place as the river erosion turned serious.  
"We also sent several letters to the authorities concerned including upazila nirbahi officer, district education officer, and the executive engineer of Education Engineering Department for steps to shift the whole school to a safer place but to no effect yet," he said.

# Burglary in Moulvibazar Krishi Bank

Robbers looted Tk 6 lakh from a Krishi Bank branch at Shamsnagar Road in Moulvibazar town on Tuesday night.  
Being informed by Nazmul Islam, manager of the bank, police rushed to the spot and picked up

three people for quizzing. They are the bank's night guard Mujahidul Ahmed, 26, and locals Mansur Mia, 27, and Shafiq Mia, 33.  
A gang of robbers broke into the bank through a window around 10:00pm, said Abdus Salek, officer-in-charge (OC) of Moulvibazar Police Station. They broke the

bank's vault and looted Tk 616,110, he added.  
A case has been filed with the police station in this connection, the police official said, adding that they are interrogating the detainees.  
Deputy Commissioner Kamrul Hasan and police superintendent Mohammad Shah Jalal visited the spot.

### Land dispute leaves 15 hurt

At least 15 people were injured in a clash between two groups of villagers over a land dispute in Birganj upazila of the district on Tuesday. Eight of the injured— Forhad Hossain, his two sons Sohag and Sowrav, 18, Sukur Ali, his son Al Amin, 20, Md Sayed, 24, Sufian Hossain, 23, Md Reaz, 18, and Md Selim, 15—were admitted to Birganj Upazila Health Complex, Thakurgaon Sadar Hospital and Dinajpur Medical College Hospital. Quoting locals, police said there had been a feud between Forhad Hossain and Shukur Ali of Prannagar village over the ownership of a piece of land. The duo locked in an altercation over the issued on Tuesday evening. At one stage, supporters of the two locked in a clash at Pachishmile Bazar, leaving 15 people from both sides injured.

### Body recovered

Police recovered the body of an elderly man from Khatuabhangra village in Manirampur upazila of Jessore district on Tuesday. The deceased was identified as Jakim Biswas, 60, a resident of the village. Locals said they spotted the body of Jakim hanging from a mango tree in the around 6:30pm and informed the police.

### Two youths found dead

The bodies of two youths were found in Patuakhali and Barguna districts. Police on Tuesday recovered the body of an unidentified youth, 30, from a paddy field in Galachipa upazila municipality area of Patuakhali district. Abdur Razzak, officer-in-charge of Galachipa Police Station, said locals found the body at a paddy field and informed the police. The law enforcers later recovered the body around 7:00am and sent it to Patuakhali General Hospital morgue for autopsy. In Barguna, police recovered the body of Raju, 20, from beside the flood control dam at Burichar village under Barguna Sadar upazila at about 2:00am yesterday. OC Md Reaz Hossain of Barguna Police Station said there were several marks made by sharp weapons in different places of the body.

### Youth killed over family feud

A young man, who was stabbed by his cousins over a family feud in Shajahanpur upazila on Tuesday night, died at Shaheed Ziaur Rahman Medical College Hospital (SZMCH) yesterday. The deceased is Abu Hanif, 20, son of Motaleb Hossain of Gondagram Dakkhinpara in the upazila. Police said there had been a longstanding feud between Motaleb and his cousins over the sharing of their family properties and other valuables. As a sequel to that, a group of 10/12 people allegedly led by Hanif's cousin Rony, 22, son of Nehaj Uddin, waylaid him near Phuldighi Intersection around 8:00pm and stabbed him indiscriminately, leaving him critically injured. Hearing screams, locals went to the spot, rescued Hanif and took him to SZMCH in Bogra. He succumbed to his injuries at the hospital around 5:00am yesterday.

### Two drug addicts jailed

A mobile court yesterday jailed two drug addicts for six months each for creating disturbance in a Puja Mandhop area under Dhumat upazila of the district. The convicts are Sultan Mahmud, 22, son of Altaf Ali of Shoilmari village, and Khalilur Rahman, 45, son of Geda Pramanik of Boria village under the upazila. Police said the duo had been creating disturbance at a Puja Mandhop in Alangi Bazar area under Alangi union at around 11:00pm on Tuesday. They were produced before the mobile court of Hafizur Rahman, upazila nirbahi officer (UNO) of Dhumat and also the executive magistrate, yesterday morning. After hearing, the court jailed them for six months each.

### Yaba seized, one arrested

Detectives arrested a man and seized 1000 Yaba tablets from his possession at Bushpara area in Jamalpur town yesterday. The arrestee is Shamim, 35, son of Habibur Rahman of Dakkhin Kacharipara in the town. On secret information, a team of the Detective Branch (DB) of police raided the area and arrested Shamim with the Yaba tablets at 11:30am, said DB Sub-Inspector Nazrul Islam, who led the team.

# Man jailed for torturing wife for dowry

A Gaibandha court on Tuesday sentenced a man to three years imprisonment for torturing his wife for dowry.  
The convict is Jala Mia, 36, of Chuniyakhali village in Sadar upazila.  
Judge Wahiduzzaman of Senior Judicial Magistrate's Court also fined the convict Tk 5,000, in default, he is to suffer another month in jail.  
The prosecution case

said Shova Rani of Ratanpur village in Fulchhari upazila married Jalal Mia in 2014. After the marriage, Jalal Mia put pressure on Shova Rani to bring Tk one lakh from her father as dowry. But the poor father was unable to pay the dowry.  
Failing to get any money, Jalal flew into a rage and beat up Shova. Later, he sent Shova to her father's house, saying that if she wanted to return she would have to bring the dowry money.

Finding no other alternative, Shova Rani filed a case with the Senior Judicial Magistrate's Court, accusing her husband of torturing her.  
After examining the case record and witnesses, the court pronounced the verdict.  
Jalal Mia has been absconding since filing of the case, court inspector Abdul Majid said, adding that the sentence will come into force from the date of his arrest.
