## Badal shown IFIC door

Bangladesh Bank has removed Mohammad Lutfar Rahman Badal from the board of directors of IFIC Bank, citing his negligence in duty and alleged funding of subversive activities.

Banking Regulations and Policy Department of the central bank issued a letter in this regard yesterday.

Badal was also chairman of the Executive Committee and Risk Management Committee of IFIC Bank.

"I have heard about the Bangladesh Bank letter, but I am yet to get a copy of it," IFIC Bank Chairman Salman F Rahman told The Daily Star over the phone yesterday.

Badal is now abroad, said Salman, also private sector affairs adviser to Awami League President Sheikh Hasina.

The BB letter said Badal didn't attend any of the bank's 18 board meetings between December last year and September this year, which was detrimental to the interest of the bank's depositors and the board.

Badal was responsible for creating anarchy in and around Joydevpur of Gazipur, said the central bank. He also funded subversive activities, it said, referring to a

primary police probe against him. A case was filed against him with Joydevpur Police Station, it added.

## 'Genocide occurred' against Rohingyas in Myanmar

In a legal analysis of the human rights situation in Myanmar's Rakhine State, the Allard K Lowenstein International Human Rights Clinic at Yale Law School has found strong evidence of genocide against the Rohingya population.

A paper released by the Clinic yesterday in Bangkok recommends that the United Nations Human Rights Council establish a Commission of Inquiry to conduct an urgent, comprehensive, and independent investigation of the human rights situation in Rakhine State.

Stricken from Burma's 135 officially recognised ethnicities in 1982, the Rohingya have undergone decades of discrimination and disenfranchisement, albeit never to the degree they currently face.

The Myanmar government's official position is that the Rohingya are interlopers from Bangladesh, despite many having lived in the country for generations, and it refuses to even acknowledge their collective name, preferring the loaded term "Ben-

Following the 2012 riots, allegedly orchestrated by the military, more than 1,40,000 Rohingyas were relocated to ghetto-like camps.

### Situation improves, not much in Bangladesh

A total of 1.5 million people died from TB in 2014, says the WHO Global Tuberculosis Report 2015 released yesterday.

It was a significant progress compared to that of 2000 when the figure was almost double, said the report released in Washington.

"In all, effective diagnosis and treatment saved 43 million lives between 2000 and 2015," it said.

Of the deaths from TB last year, 8,90,000 were men; 4,80,000 women; and 1,40,000 children.

The disease ranks alongside HIV as a leading killer worldwide.

Of the 1.5 million people killed by TB last year, 4,00,000 were HIVpositive. HIV's total death toll in 2014 was estimated at 1.2 million.

The TB situation, however, has not improved in Bangladesh where

# Google balloons to cover world

Google believes it is on course to have enough internet-beaming balloons in the stratosphere to form a ring over part of the world next year.

It told the BBC the move would let it trial a continuous data service to people living below the balloons' path.

## China ends one-child policy

China announced the end of its hugely controversial one-child policy yesterday, with the official Xinhua news agency saying that all couples would be allowed two children.

It cited a communique issued by the ruling Communist Party after a four-day meeting in Beijing to chart the course of the world's secondlargest economy over the next five years.

China is "abandoning its decadeslong one-child policy", Xinhua reported.

The policy restricted most couples to only a single offspring, and for years authorities argued that it was a key contributor to China's economic

But after years of strict, sometimes brutal enforcement by a dedicated government commission, China's population -- the world's largest -- is now ageing rapidly, gender imbalances are severe, and its workforce is

The concerns led to limited reforms in 2013, including allowing a second child for some couples in urban areas, but relatively few have taken up the opportunity.

The Communist leadership met in Beijing to discuss ways to put the country's stuttering economy back on a smooth growth path as it struggles with structural inefficiencies and social policies left over from an era

Known as the fifth plenum, the

before it embraced market reforms. conclave discussed the next Five-Year Plan for China -- the 13th since the People's Republic was founded in

Over four days of meetings the 205 members of the Central Committee, plus around 170 alternates, examined the specifics of the plan, which was largely worked out through a process of national consultations before the leaders even set foot in the capital.

The country's rubber-stamp legislature will officially approve the resulting document next year.

## Five JMB men get 10 years in jail

A Dhaka court yesterday sentenced five members of banned Jama'atul Mujahideen Bangladesh (JMB) to 10 years' rigorous imprisonment in a case filed for the serial bomb blasts in Gopalganj on August 17, 2005.

The convicts are Gias Uddin, Milon Khan, Hasan Ali Mollah alias Hasan, Zillur Rahman Mollah and Ziaur Rahman. They hail from different villages of Bagerhat and Natore.

Gias is on the run.

The court also fined them TK 10,000

and Anis - were acquitted as their involvement with the incident was not proved.

After cross-examination of 28 prosecution witnesses, Judge Momtaz Begum of the Speedy Trial Tribunal-2 of Dhaka delivered the verdict in presence of the eight accused.
