

# Commuters suffer for AL rally in city

Thousands of commuters were stuck for hours in tailbacks on all the major city roads since early afternoon yesterday thanks to an Awami League rally at Suhrawardy Uddyan.

People's suffering continued late into the evening although the rally ended at 5:00pm.

Scores of patients heading towards Dhaka Medical College Hospital from different directions were forced to walk leaning on others, as all the adjoining roads were clogged with vehicles.

This correspondent found the entry to the hospital's emergency unit blocked with vehicles stuck in a jam.

Md Sakhawat Hossain, a trader of Nawabpur Road in Old Dhaka, had a severe headache and somehow managed to reach near Bangabazar by a rickshaw. But from there, he said, he had to walk all the way to the hospital with the help of two attendants.

This correspondent walked all the way from the hospital down to The Daily Star office in the late afternoon, as traffic came to a grinding halt.

## Khulna mayor suspended

UNB, Dhaka

The government yesterday suspended BNP-backed Khulna City Corporation (KCC) elected Mayor Moniruzzaman Moni as he had been charged with criminal offences.

A source at the Local Government Division wishing anonymity told the UNB that they issued a circular on Moni's suspension yesterday as a court accepted his name in the charge sheets of two criminal cases.

Moni has been suspended as per the Local Government (City Corporation) Act, the official said.

The law states that any one of the panel mayors of the KCC could now be made acting mayor.

Moni beat ruling Awami League-backed candidate Talukdar Abdul Khaleque in the KCC polls held in June, 2013.

On June 11 this year, a local court accepted charge

## 50 hurt as BCL men clash at CU

Two factions of Chittagong University Chhatra League engaged in a clash over standing in the front row to greet admission seekers on the campus yesterday. The incident left some 50 people including seven cops injured.

Police later raided Shahjalal Hall and Shah Amanat Hall and detained 30 people there. They also seized an improvised rifle, several machetes and four sacks of brickbats from the dormitories.

About 15 CU students and admission seekers were hurt

Chittagong University of Engineering and Technology (Cuet) yesterday closed for an indefinite period over a turf war on the campus between two factions of pro-Awami League student body Chhatra League.

The groups clashed yesterday, leaving injured three final year students -- Sanjid of mechanical engineering, Israk Hossain Rafiq of petroleum and mining engineering and Tanim of civil engineering departments. They were admitted to Chittagong Medical College Hospital, said Nayek Md Hamid of the medical police outpost.

Students led by Shahenewaj Tanvir and those led by Nahid Parvez Napsu were locked into a clash at Gol Chatter of the university around 1:30pm in connection with an assault on a follower of

# Three bidders submit proposals, financing

Three bidders have submitted proposals along with financing to construct the 1,320 megawatt coal power plant in Rampal close to the Sundarbans.

Japanese and Indian consortium Marubeni and Larsen & Toubro have brought in financing from Japan Bank for

International Cooperation. Another Chinese consortium of Chinese Harbin, Alstom China and Etern have brought in Chinese government financing and Indian Bhel brought in Indian Exim financing.

"All three bids are fully finance backed," said Uzzal Bhattacharya, Deputy Managing Director of the Bangladesh-India

## 3 die in 'gunfights' with Rab, police

Three people were killed in separate "gunfights" with law enforcers in Dhaka, Gazipur and Jhenidah early yesterday.

The dead include Rajib, accused in several criminal cases with different police stations in Dhaka, Rafiqul Islam Rafiq, who stood accused in at least six criminal cases in Gazipur, and Kamal Hossain, the prime accused in a case filed over burning dead his mother-in-law and her 15-month-old daughter in Jhenidah.

Rapid Action Battalion (Rab) was involved in two of the incidents and police in the other.

In Dhaka, police arrested Rajib, 35, in Dakkhinkhan area on Sunday night, said Yunus Ali, officer-in-charge of
