# Attack on freedom fighter sparks protest in Shibganj

Freedom fighters of Shibganj upazila yesterday formed a human chain and held a rally demanding immediate arrest and punishment of the attackers of freedom fighter Rafiqul Islam Lalbor.

Shibganj upazila unit command of Bangladesh Muktiyoddha Sangsad organised the programme,

followed by a procession, in front of their office at the upazila headquarters. At the rally, speakers said unidentified criminals brutally stabbed freedom fighter Rafiqul Islam, 58, also headmaster of Shibganj Government Primary School, with sharp weapons while he was returning to his Chaturpur home around 8:00pm on Sunday night. Local people rescued

critically injured Rafiqul and took him to Shibganj Upazila Health Complex, from where he was referred to Rajshahi Medical College Hospital. Condemning the heinous attack, the speakers also expressed dissatisfaction for not arresting the attackers of Rafiqul and such other victims of the past. Freedom fighter Bazlar Rahman Sonu, commander

of Shibganj upazila unit, and freedom fighters Taslim Uddin, Abdul Mannan, Nazrul Islam, Jamal Uddin, Isahak Ali and Ahsan Habib addressed, among others. Contacted, Officer-in-Charge Moinalul Islam of Shibganj Police Station said he heard about the incident but none had lodged any complaint with the police station yet in this regard.

# 55 held while going to India illegally

Members of Border Guard Bangladesh (BGB) arrested 55 Bangladeshi nationals while they were going to India illegally through Putkhali border in Benapole on Tuesday night.

Farid Uddin, in-charge of BGB-23 Putkhali camp, said a BGB team, acting on a tip-off, conducted a drive in the area at around 11:00 pm and arrested 22 women, 30 men and three children while they were crossing the border without valid documents.

The arrestees hail from different areas of Narail, Sathkira and Bagerhat districts.

# Rapist gets life

A Dinajpur court on Tuesday sentenced a man to life imprisonment in a rape case.

The convict is Md Mohsin Ali, 35, son of Mohoram Ali of Gamir village under Biral upazila of the district. The court fined him Tk 50,000. In default, he is to suffer another year in jail, court sources said.

According to the prosecution, Mohsin raped the girl of the village on September 9, 2009, promising to marry her. Later, she became pregnant, but Mohsin refused to marry her.

# College boy tortured on theft charge, 2 arrested

Police arrested two youths in Nesarabad upazila of the district on Tuesday on charge of torturing a college student.

The victim is Tamal Mistry, 18, a first year student of Shaheed Smritee Degree College, and son of retired schoolteacher Suresh Mistry of Batnata village in the upazila.

Following a case filed by the victim's father, the law enforcers arrested Dipankar Mandol, 27, son of Thakur Chad Mandol, and Subrato Mandol, 25, son Shubas Mandol of Gayeshkathi in Sarengkathi union, at night.

Family sources said three youths beat up Tamal in front

of Ranjan, member of the union parishad, bringing charge of stealing betel nut from a local garden against him at noon. At one stage,

they shaved his head forcibly. The following day, the three took Tamal to Nesarabad Police Station with

the help of the UP member. The victim's father Suresh said they have a fish farm and a poultry farm at Gayeshkathi village in the upazila. The three youths often stole fishes from the farm. As he protested the incident, they beat him up.

As he complained with the police station, they beat his son up and shaved off his head as revenge, alleged Suresh.

Though police arrested two accused, they let UP member Ranjan to go, he said.

Mahbubur Rahman, sub-inspector of the PS, claimed that Tamal stole betel nut from the garden.

Police arrested Dipankar and Subrato in the case filed by Tamal's father, said the SI.

# Gunfight over fishing in water body, 147 sued

At least 147 people have been sued in connection with Saturday's gunfight that left two people dead and 10 others injured in Companiganj upazila of Sylhet District.

Two rival groups locked in the clash over fishing in Dolain Beel (water body) at Batumara village in the upazila.

Abdul Haque of the village, who led a group during the clash, filed the case with Companiganj Police Station on Tuesday,

accusing 97 named and 50 unnamed people. None of the accused was arrested as of filing of this report at 5:00pm yesterday.

There was a longstanding dispute between Abdul Haque and Turab Ali over capturing Dolain Beel.

Locals said the clash ensued when the supporters of the two groups went to the water body for catching fish at around 7:00pm.

The two groups used firearms during the clash, leaving the two guards dead and 10 others from both sides injured.
