

WAR CRIMES IN HABIGANJ

Two implicate 3 'Razakars' in murder, rape, looting

Two prosecution witnesses yesterday narrated to the International Crimes Tribunal-1 how three Habiganj war crimes accused along with other "Razakars" and Pakistani occupation army were involved in the murder of two freedom fighters, rape of two women, arson and looting during the Liberation War.

The fifth and sixth prosecution witnesses -- Khasru Miah and Shafique Ali -- testified against war crimes accused -- Muhibur Rahman alias Boroman, 65, his younger brother Mujibur Rahman alias Angur Mian, 60, and their cousin Abdur Razzak, 63, -- before the tribunal in the presence of the accused.

Khasru said he used to live in the house of

MA Rob, deputy commander-in-chief of the Liberation War and also his maternal uncle, in Baniachang of Habiganj.

On October 16, 1971 he learnt that the Pakistani army came to their locality.

He said members of the Pakistani army and Razakars, including the three, came to the locality on boats, adding that they looted Rob's house and set other houses on fire.

Khasru said they also led arson attacks in a neighbouring Hindu majority area.

The witness said the three accused along with the others went to neighbouring houses and raped two women.

Khasru said 15 days later freedom fighters -- Rajab Ali and Akal Ali -- returned to Akal's house in the area.

fugitives in the charge sheet submitted by Sub-Inspector of Wari Police Station Shah Alam -- also the investigating officer of the case -- on September 10.

According to the case statement, a group of BNP-led alliance leaders and activists torched a bus by throwing petrol bombs on Dhaka-Adamjee highway near Mayor Mohammad Hanif Flyover on January 30.

the grenade attacks and she was admitted to Dhaka Medical College Hospital and later died at Combined Military Hospital on August 25, 2004.

Later, female police made an inquest report of the body in their presence. There were injury marks over her whole body. They also singed on some papers submitted by the law enforcers.

In the grenade attack, 24 people, including Ivy, were killed and over 300 injured.

Earlier, the tribunal recorded statements of 196 prosecution witnesses, including complainant of the cases.

Shaheed Noor VIQARUNNISA SEXUAL ASSAULT

Verdict on Nov 25

The judgment in the case filed over violating a class-X girl of Viqarunnisa Noon School and College, Bashundhara branch in 2011, will be delivered on November 25.

After completion of arguments from the prosecution and the defence, a Dhaka court yesterday set the date while lone accused Porimol Joydhor, also a sacked teacher of the institution, was in the dock.

Victim's father filed the case against Porimol, the then principal Husne Ara Begum and chief of the school's Bashundhara branch Lutfur Rahman on July 5, 2011.

According to the case statement, Porimol, a Bangla teacher, violated the student at his coaching centre in the city's Badda twice. Husne Ara and Lutfur were discharged by the court during the charge hearing. The 59-year-old school plunged into trouble after the incident which sparked protests among students and guardians.

of the CCTV installed at the under-construction building.

Sohel went into hiding after police suspected him.

Ripon went to his home in Chandpur to bury his brother but decided not to come back to Dhaka where he worked at a sweet shop. Nor do his mother Rokeya Begum and relatives want to send him back. The family is now dependent on the assistance of their relatives.

"I earned Tk 8,500 per month and sent Tk 5,000 to mother. My brother used to send Tk 2,000 every month from his salary of Tk 3,600 from Ghoroa Restaurant," Ripon said.

He demanded justice for his brother's killing.

The miseries of Rokeya Begum seem to be never-ending. She toiled a lot to raise her children after her husband died around 15 years ago. She worked as a domestic help at different houses to make a living and dreamed of a better life soon. But all her hopes were shattered.

"I don't find any reason to live after my son's death. It would be better if the murderer killed me as well.


"I have lost one son and do not want to lose the other," she said in a choking voice.

Tapan Chandra Saha, officer-in-charge (OC) of Wari Police Station, said Soheli and his family had disappeared after the killing and they could not trace them out yet.

Jasim Uddin, a staff of Ghoroa and an accused of the murder case, gave a confessional statement before a court that Soheli shot the boy dead, said the OC.

All mobile phones of Soheli and his family members remain switched off, he said.

Inspector Alim Hossain, investigation officer of the case, declined to comment.
