

## NBR slated for random use of statutory orders

2 HC judges, AG also rap tax authority for 'not always helping AG office'

Two judges of the High Court and the attorney general yesterday came down heavily on the National Board of Revenue for randomly exercising statutory regulatory orders and not always cooperating with the attorney general's office in settling tax-related cases.

Justice Shamim Hasnain said statutory regulatory orders (SROs) are issued every now and then because of the powers delegated to the NBR.

"An SRO is issued and the duties go down. Two months later, another SRO is issued and the duties go up."

"This is not fair. There must be equality in the system," he said at a seminar on the management of tax-related cases and the effectiveness of alternative dispute resolution (ADR) at the Sonargaon Hotel in the capital.

Suggesting that the NBR's authority to issue the SROs should be curtailed, he sought attention from Finance Minister AMA Muhib, who was present at the seminar.

Muhib said, "In 2009, we said that we were irritated by an excess of the SROs. We are bringing down its number. We will reduce it further."

Attorney General Mahbubey Alam said the ADR system is fine if cases are resolved and money is realised. But it will be a matter of concern whether the system creates further

Matin refuses to give any confessional statement

MA Matin arrested in Italian aid worker Cesare Tavella murder case refused to make a confession yesterday.

Russell Chowdhury alias "Chakki" Russell arrested with two others in connection with the murder earlier said in his confessional statement that Matin, younger brother of former BNP-backed ward commissioner MA Quayum, had given him Tk 5 lakh to shoot and injure any foreigner in the capital's Gulshan to create panic.

Matin had been on remand for 13 days in two phases before he was produced before Metropolitan Magistrate Shahriar Mahmud Adnan for recording of his statement.

There he refused to give any confessional statement. He was then sent to Dhaka Central Jail, sources said.

## JS withdraws bill that 'challenged SC jurisdiction'

The proposed Ports (amendment) Act-2015 was withdrawn from the Jatiya Sangsad last night after a parliamentary committee pointed out that the bill challenged the Supreme Court's jurisdiction to question any legislation.

Shipping Minister Shahjahan Khan had placed the bill in parliament on September 6.

Yesterday, he proposed withdrawal of the bill. The House passed the proposal by a voice vote.

The bill stipulated that no courts will have the jurisdiction to question the construction of "all relevant structures, including terminal building, terminal, gangway, landing station, transit shed, warehouse, jetties, ferries, wharf, quay, dock, mooring, and other facilities related thereto, operated by or under a license from the conservator, or other work on any part of the foreshore or shore or bank of a river within the declared ports limits constructed and operated according to the provision of this Act and Rules made thereunder".

The Parliamentary Standing Committee on the Shipping Ministry in its report to the House said it will not be right for parliament to interfere in the SC's jurisdiction.
