Steenkamp's father 'satisfied'

Reeva Steenkamp's father said Thursday he was "satisfied" after an appeal court judge found Oscar Pistorius guilty of murdering his daughter in a ruling that could see the Paralympian serve at least 15 years in prison.

"I'm satisfied with everything now," Barry Steenkamp told television reporters shortly after the judge threw out an early conviction for culpable homicide, or manslaughter.

"I would hope to God that all of this could have been prevented, but seeing that it has been done, let us now all get on with our lives."

Pistorius now faces a long prison term

South Africa's supreme court of appeal has found Oscar Pistorius guilty of murdering his girlfriend, Reeva Steenkamp, overturning a previous conviction for culpable homicide.

The court has ordered the original trial judge in Pretoria to impose a harsher sentence. No date has been set for this hearing. The minimum sentence for murder is 15 years in prison.

Pistorius is currently living under house arrest at his uncle's home in Pretoria, having been freed from prison after serving less than a year behind bars. He will reportedly be allowed to remain in correctional supervision until a new sentence is handed down.

Pistorius shot and killed Steenkamp on Valentine's Day in 2013, and later said he thought she was an intruder.

Justice Eric Leach, who read out an abridged version of the judgment on Thursday morning on behalf of the court, said: "The accused ought to have been found guilty of murder." He described Steenkamp's death as "a tragedy of Shakespearean proportions". As is custom, Pistorius and his

family were not in the court in Bloemfontein as the judgment was delivered. June Steenkamp, Reeva's mother, was seen sobbing on the stairs of the court in Bloemfontein after the judgment was read out. Pistorius was released into house

arrest in October having served onefifth of his original five-year term, and has been performing courtmandated community service.

The appeal centred on the legal concept of dolus eventualis, or indirect intention - in layman's terms, the question of whether Pistorius had foreseen the possibility that he might kill somebody when he



fired four shots into the bathroom

The appeal court ruled (pdf) that the trial judge, Thokozile Masipa, had applied this concept incorrectly, saying her ruling was "confusing in various respects".

Leach said Pistorius did have the requisite legal intention to be found guilty of murder. "In these circumstances, I have no doubt that in firing the fatal shots the accused must have foreseen that whoever was behind the toilet door might

die, but reconciled with that event occurring, and gambled with that person's life," he said.

Leach was critical of Pistorius's inconsistent testimony in the original trial. "In the light of these contradictions [in Pistorius' testimony], one does not really know what his explanation is for having fired the fatal shots," he said.

The Pistorius family issued a brief statement saying: "We have taken note of the judgment that has just been handed down by the supreme court of appeal. The legal team will study the finding and we will be guided by them in terms of options going forward. We will not be commenting any further at this stage."

The African National Congress Women's League, vocal critics of Masipa's judgment, welcomed the new conviction. "We are happy with what the judges decided today," said the Free State chair Mapaseka Nkoane.

Real face Cup expulsion

Russian international Denis Cheryshev opened the scoring in Andalusia, but shouldn't have been on the field as he was due to serve a onegame ban in the competition after picking up three yellow cards whilst on loan at Villarreal last season.

Cheryshev was replaced a minute into the second-half by Mateo Kovacic.

"Clearly we didn't know. Villarreal and the federation hadn't warned us," said Madrid boss Rafael Benitez.

"When we knew we substituted him to show good faith."

Isco scored twice after the break before Cristian Marquez's late consolation rounded off the scoring in a 3-1 Madrid win.

However, the result could yet prove meaningless if Madrid are proved to have fallen foul of the competition's rules with Cadiz president Manolo Vizcaino confirming his club will launch a formal complaint.

Fifa will debate a proposal to expand the World Cup from 32 teams to 40.

The change can be approved by Fifa's executive committee without consent from the 209 member associations, and could come into effect from 2026.

The proposal is said to have been discussed yesterday in Zurich, where a meeting is taking place focused on reforms of world football's governing body.

Earlier, two high-ranking Fifa officials were arrested in the Swiss city on suspicion of taking bribes.

They are alleged to have taken money for selling marketing rights in connection with football tournaments in Latin America, as well as World Cup qualifying matches.

The arrests came on the opening day of Fifa's Exco meeting. France '98 featured 32 teams, up from the 24 that had qualified for every World Cup since 1982.

La Liga agrees 2.65b euro TV deal

Rahane steers India

Ajinkya Rahane smashed an unbeaten 89 to steer India to 231-7 on the opening day of the fourth and final Test against South Africa in smoggy conditions in New Delhi on Thursday.

Rahane, 27, hit two sixes and nine boundaries in his 155-ball knock, the highest score in what has otherwise been a low-scoring series that India leads 2-0.

The talented right-hander, dropped on 78 by South Africa skipper Hashim Amla, defied an inspired bowling attack led by off-spinner Dane Piedt to consolidate the Indian innings.

Piedt grabbed four wickets for 101 runs while recalled paceman Kyle Abbott chipped in with three scalps on a strip that offered inconsistent bounce to the bowlers.

"We will try to strike with the new ball in the morning. It will be good if we can keep them under 250," said Piedt, who had been out of action this year until this Test with a shoulder injury.

"It is a two-paced wicket, the odd one is skidding on. (But) I think it has been a good wicket for everyone today," he said.

India are looking to pile on the agony for the top-ranked tourists after winning the first and third Tests to take an unassailable lead, while the second in Bangalore was washed out.

Under smoggy skies, Rahane raced to his eighth Test halfcentury and the first in India with a slog-swept six off Piedt followed by a boundary one ball later.

He also shared 70 runs with his captain Virat Kohli who hit a breezy 44 off 62 balls before a freak dismissal cut short his innings.

The 25-year-old Piedt, playing only his second Test and the first this year, provided the early breakthroughs, dismissing Murali Vijay (12) and opening partner Shikhar Dhawan (33).

Vijay was caught in the slips by Amla while Dhawan was given lbw, the sharply turning ball hitting his front pad as he tried to defend.

Piedt was lucky to get the scalp of Kohli, who tried to play a sweep shot, but the ball hit Temba Bavuma fielding at short leg and ricocheted up in the air.
