# Man pours hot water 3 'JMB men' arrested

One a communication technology expert, claims DB

Detectives yesterday claimed to have arrested three Jama'atul Mujahideen Bangladesh (JMB) operatives, including a communication technology expert, from the capital's Uttara on Saturday night.

A metropolitan magistrate's court granted a five-day remand against 10 days sought by the investigation officer of a case filed against the three under the anti-terrorism act. A mobile company engineer, AHM Khairul

Asad alias Sohag used to jam networks in areas where JMB Sura members were holding meetings to prevent law enforcers from tracking them, said Dhaka Metropolitan Police's (DMP) Detective Branch (DB) Joint Commissioner Monirul Islam.

Mir Moazzem Hossain Saifi alias Jarmin and Kafil Uddin Bin Amin, apart from giving sermons regularly, acted as spiritual leaders, motivating young JMB operatives toward militancy, he told a press briefing at DMP Media Centre.

A mobile phone network jammer and a number of books on militancy were recovered from their possession, he added.

However, Sohag's family members earlier claimed to The Daily Star that he was picked up

on the night of November 24 from his Uttara residence. DB at that time had denied detaining him. Monirul said they came to know about

the three interrogating five alleged JMB men arrested for reportedly being involved in the improvised grenade attack at Hossaini Dalan before a mourning procession of Shia Muslims on October 24. The three were not directly involved in the attack, he added. "They recently joined JMB's destructive

faction, which is being lead by two leaders ranked as Sura member," said Monirul. He declined disclosing the duo's names for the sake of investigations. One of this faction's top leaders was

Albani alias Hozza Bhai alias Member Bhai alias Shahadat alias Mahfuz who was recently killed in a shootout, said Monirul. After several meetings with the faction's

members, the trio joined it leaving another faction led by detained Maulana Saidur Rahman, who has been replaced by Faruq alias Jamai Faruq, he said.

Most of the destructive faction's members are young and have been motivated to carry out destructive acts, said Monirul, adding that the trio donated a part of their income for
