## Crunch time for Mourinho

o s e Mourinho faces a decisive moment in his fight to save his job as the belea-

guered Chelsea manager bids to avoid a catastrophic exit from the Champions League against Porto on Wednesday. Mourinho is on the brink of being

sacked by Blues owner Roman Abramovich after Saturday's stunning 1-0 home defeat against lowly Bournemouth left the crisis-torn Premier League champions languishing just two points above the relegation zone.

Mourinho was given a public vote of confidence by Chelsea at the start of October, but Abramovich's patience is wearing thin as the club's worst start to a season in his 12-year ownership shows no signs of improving.

Although Mourinho has continued to insist he retains the support of his players amid rumours of a dressing room mutiny against his hard-line style, the limp manner of their surrender against Bournemouth suggested otherwise.

Abramovich held talks with his closest Chelsea aides, Marina Granovskaia

and Michael Emenalo, over the weekend and it is reported the Russian told Mourinho he must lead the team into the last 16 of the Champions League to avoid the axe.

Chelsea need only a draw at Stamford Bridge in their final Group G fixture to be certain of a place in the knockout stages.

Once virtually unbeatable at the Bridge under Mourinho, Chelsea have lost four times on home turf this season and Porto, who need a win to be sure of progressing, are unlikely to prove a pushover after beating the west Londoners in Portugal earlier this season.

# PISTORIUS granted bail

Former Paralympic champion Oscar Pistorius was released on bail yesterday, as he vowed to appeal against his murder conviction for shooting dead his girlfriend Reeva Steenkamp in 2013.

South African judges last week found him guilty of murder and overturned his earlier conviction on the lesser charge of culpable homicide for killing Steenkamp, a model and law graduate.

Pistorius, 29, wearing a dark suit, white shirt and black tie, appeared relaxed at the bail hearing in the Pretoria High Court, chatting with his legal team before standing in the dock to hear the judge's ruling.

He was released from jail in October to live under house arrest at his uncle's house in Pretoria after serving one year of his fiveyear prison sentence for culpable homicide -- the equivalent of manslaughter.

However, no date was announced for his re-sentencing.

A lawyer for Steenkamp's family told AFP that they "understand it is his constitutional right to (appeal), but believe it is a delaying tactic as they do believe that he is guilty of murder.

Martin Hood, a criminal lawyer based in Johannesburg, told AFP that Pistorius was now "clutching at straws" by trying to appeal to the Constitutional Court. "The Supreme Court of Appeal's judg-

ment was clear, simple, lucid,' Hood said. The Paralympic gold medallist's lawyers

had earlier said that he could not afford further legal battles after being left penniless by huge bills.

On the streets outside the court, South Africans voiced their displeasure with Pistorius, saying he was not prepared to take responsibility for his actions.

"He's supposed to get 15 years in jail, he deserves it," said Thomas Mdlule, a 30-yearold selling newspapers on a corner close to the court.

"He must be inside jail, not under house arrest."

Pistorius killed Steenkamp in the early hours of Valentine's Day two years ago, saying he mistook her for an intruder when he shot four times through the locked door of his bedroom toilet with a pistol he kept under his bed. During his dramatic trial, he denied

killing her in a rage, sobbing and occasionally vomiting in the dock as details of his lover's death were examined in excruciating detail.

The murder conviction ruling last week said that it was "inconceivable that a rational person could have believed he was entitled to fire at this person with a high calibre firearm". The double-amputee sprinter, known

as the "Blade Runner" because of the prosthetic legs he used on the track, made his first appearance in public last month since leaving jail when he reported for community service at a Pretoria police station. He killed Steenkamp at the peak of his

fame, and he has since lost his glittering sports career, lucrative contracts and status as a global role model for the disabled.

# Lukaku denies Palace



his red-hot streak as the Everton striker's late equaliser rescued a 1-1 draw against Crystal Palace on

Monday. Lukaku has been in superb form over the last month and Palace were unable to subdue the Belgium international, who poked home from close-range with nine minutes remaining at Goodison Park.

The former Chelsea star now has 50 goals in 100 appearances for Everton since first joining them on loan in 2013 before making what now looks a bargain £28 million (\$42 million, 38 million euros) permanent move a year later.

He has 14 goals in all competitions this season, with seven of that total coming in his last six matches.

Lukaku's latest crucial intervention was well-timed, coming just five minutes after Palace defender Scott Dann had headed the

visitors into the lead.

Everton moved up to ninth place in the Romelu Lukaku extended Premier League in extending their unbeaten run to seven matches in all competitions, while Palace climbed to the lofty heights of sixth.

"I am proud but I'm a team performer, so I'm happy with the record but disappointed we didn't get the three points," Lukaku said of his goal milestone.

"After their goal we reacted well, it shows

we have great character in the team." Everton had scored 10 in their last two home league matches, but if the watching Wayne Rooney was expecting another goal spree from his former club, the Manchester United captain was destined to leave disappointed.

Instead he had to make do with appreciating the talents of the powerful Lukaku and

his Everton teammate Ross Barkley. In a low-key first half, Lukaku was unlucky not to open the scoring when his shot beat Palace goalkeeper Wayne Hennessey but rebounded off the inside of the far post and flew across the face of goal.

### Ancelotti eyes United job

Former Real Madrid and Chelsea boss Carlo Ancelotti on Monday admitted he would be interested in taking over at Manchester United if the job becomes available.

United's current manager Louis van Gaal has suggested he will retire when his deal with the Premier League club expires at the end of the 2016-17 season.

"Of course, for every manager, they would all think of managing Manchester United," Ancelotti was quoted as

saying. "I will continue to wait. If I don't find a club with a good project, I can wait."
