Fugitives' list gets longer

Police fail to arrest 57 out of 102 war crimes accused despite directives from tribunal

Despite several directives by the International Crimes Tribunal and initiatives of the government to arrest war crimes accused, police have failed to capture more than half of them, frustrating justice seekers.

Two war crimes tribunals had issued arrest warrants against 102 war crimes accused in 18 cases since August last year, but the law enforcers could arrest only 45, according to The Daily Star reports.

Eighteen accused are now facing trial in four cases. Of them, 10 are fugitives. The investigation agency has completed its probe into five other cases in which it has found evidence of crimes by 37 people. Of them, 22 are on the run.

Besides, arrest warrants had been issued against 47 more accused in 10 other cases. But police could arrest only 23. The cases are under investigation SEE PAGE 2 COL 2

The Liberation Struggle was a fight to free ourselves from cultural domination, racial discrimination and economic



Dream of the dawn

December 14 massacre left Prof Anwar Pasha dead but couldn't stop his poetic prophecy come true

"A new acquaintanceship has begun. The old life came to an end on that night of March 25. Ah, let it be true. New people, new acquaintances and a new dawn. How far away is it? Can't be very far. Only this night! There is nothing to fear. It will be over."

These are the last few lines of "Rifle, Roti, Aurat", the first novel on Liberation War, written by Prof Anwar Pasha. Through his protagonist Shudipta Shaheen, he shared his dream of a new country with a firm conviction that the liberation was now a matter of time.

The country tasted that freedom on December 16, 1971. But Anwar Pasha, who had written the epic piece between April and June in 1971, was not there to see his prophetic dream come true.
