# Exhume Happy's body: HC

The High Court yesterday directed the deputy commissioner of Madaripur to exhume the body of Happy Akhtar, 14, who was murdered allegedly after rape this August.

The HC passed the order after hearing a petition filed by Happy's mother Mukta Begum seeking its order on the government to exhume the body. Petitioner's lawyer SM Masud Hossain Dolon told The Daily

Star that Happy and Sumaiya Akhtar, 15, were killed after rape by their stalkers in Madaripur Sadar upazila on August 13. Sumaiya's father filed a murder case against eight per-


sons for killing his daughter, he said.

On September 13, Mukta filed another case with murder and rape charges, he said, adding that two women-- Lipi Begum and Ajufa Begum --, who conducted the inquest of

Happy, told a Madaripur court through affidavit that they found evidence of rape. Shafiqul Islam, residential medical officer of Madaripur Sadar Hospital, did not mention in the post-mortem report

whether Happy was raped or not and so the rape charge was not brought in the case's investigation.

Dolon said if evidence of rape is found, rape charge would be brought against the accused who are out on bail.

# Charges yet to be filed after one yr

Prime suspect still on the run

Today marks one year of the shooting death of Chittagong University student Taposh Chandra Sarker during a factional clash of Bangladesh Chhatra League (BCL), but police have neither nailed the prime accused nor submitted the charge sheet yet.

Police had earlier said charges would be submitted by December 14. Now they sought more time to prepare the charge-sheet. "Our job is almost done; we thought we would be able to submit the charge-sheet by December 14 but one of the 30 accused of the case claimed that he was not in the country at the time of the clash on December 14 last year," said investigation officer (IO) Mustafizur Rahman Chowdhury, an inspector of the Police Bureau of Investigation (PBI). "So we are now verifying his claim and I expect it would take just a week to prepare and submit the charge-sheet," he told The Daily Star.

On December 14 last year, Taposh, a student of Sanskrit, was hit by a bullet when BCL activists of two CU shuttle train based groups -- Varsity Xpress (VX) and Choose Friends with Care (CFC) -- fought with each other. Taposh,

who belonged to CFC, died later. Of the 30 accused, all BCL men, one is detained now while the prime suspect Ashrafuzzaman Asha, an excultural affairs secretary of CU unit of BCL, is on the run.

The prosecution says the eight were "involved" with Razakar Bahini and Al-Badr Bahini, two auxiliary forces of the Pakistani occupation

The case's investigating officer said to have already found their "involvement" in crimes including genocide and murders committed in Muktagachha and Harinakundu upazilas.

Meanwhile, the tribunal granted a prosecution petition allowing the investigation agency to interrogate a war crimes accused of Moulvibazar at its safe home.

Accused Akmal Ali Talukdar, from Rajnagar upazila's Ranchgaon village, will be interrogated on December 20, said prosecutor Sheikh Mosfeq Kabir.

Akmal was arrested on November 26 following an arrest warrant issued by the tribunal against him and three others.

emerging nation of its brightest luminaries. Press Institute of Bangladesh (PIB) organised at its office in the capital the launching of its book "Bangladesher Muktijuddhe Shaheed Sangbadik" contain-

ing biographies of 13 martyred journalists. The 13 are Serajuddin Hossain, Shahidullah Kaiser, Khondakar Abu Taleb, Nizamuddin Ahmed, SA Mannan (Ladu Bhai), ANM Golam Mostafa, Syed Nazmul Haque, AKM Shahidullah (Shaheed Saber), Abul Bashar, Shivsadhan Chakraborty, Chishti Shah Helalur Rahman, Muhammad Akhtar and Selina Parveen.

Actress Shomi Kaiser, daughter of writernovelist Shahidullah Kaiser, urged the government to prepare and make public the first complete list of martyred intellectuals.

Urmi Mostafa, daughter of Golam Mostafa, said, "I was born after 1971. I have never experienced my father's love."

She opined that if the intellectuals' works were highlighted, the new generation would realise what they had lost.

Serajuddin Hossain's son journalist Zahid Reza Noor criticised the electronic media for broadcasting war criminals Mojaheed and Salauddin Quader Chowdhury's near simultaneous executions "as if they were famous personalities".

Information Minister Hasanul Haq Inu said Pakistan led the horrific killings out of vengeance. "But the trial of war criminals is not being conducted out of vengeance but to ensure justice for victims," he said.

Prime Minister's Media Adviser Iqbal Sobhan Chowdhury, Prof Golam Rahman of Dhaka University's mass communication and journalism department, and journalist Monjurul Ahsan Bulbul also spoke while PIB Board of Directors Chairman Golam Sarwar presided over the discussion. **OBSERVANCE**




