#### 6 passport brokers, 2 staff jailed

A mobile court backed by Rab on Monday sentenced six brokers and two staff of Rayerbagh regional passport office in the capital to different jail terms for their illegal dealings.

The court issued a 15-day jail term to Rafiqul Islam, 30, a staff, as he was using fake identity cards of higher officers and Shiba Das, 26, for assisting the brokers, said a press release.

The brokers -- Md Bayezid, Abu Hanif, Shymol Hossain, Shahidul Islam, Md Mostafa and Anwara Hossain -- were sentenced to three months in prison. Rab also seized around Tk.3.82 lakh and 15 passport forms and eight mobile phones from them.





HC tells Rajuk

The High Court yesterday directed the Rajdhani Unnayan Kartripakkha (Rajuk) chairman to submit a list of unauthorised structures, including shops built on spaces allotted for car parking, in Dhaka before it in two months.

The court also issued a rule upon the government and Rajuk to explain in four weeks why they should not be directed to remove these unauthorised structures to ease traffic congestion in the city.

The HC came up with the order and rule after hearing a writ petition filed by Human Rights and Peace for Bangladesh.

The organisation filed the petition on December 14, saying these unauthorised structures were a cause of traffic congestion in the city.

During yesterday's hearing, petitioner's council Manzill Murshid told the court that owners of buildings have built shops and businesses at ground floors of buildings which were supposed to be for car parking.

Therefore, cars are now parked on roads causing traffic jams, he added.

Manzill also said Rajuk had prepared a list of such 208 unauthorised structures built in car parking areas during the armybacked caretaker government, but no action has been taken in this regard yet.

# Give list of unauthorised Why advance income tax on pvt automobiles?

HC asks govt to explain

The High Court yesterday questioned the legality of the government's action to collect advance income tax (AIT) from private cars, jeeps and microbuses.

The court issued a rule asking the government to explain in four weeks why its gazette notifications of 2009 and 2012 to impose AIT on these vehicles should not be declared illegal. The HC bench of Justice Justice Sheikh Hassan Arif and

Justice JN Deb Choudhury came up with the rule after hearing a writ petition filed by Supreme Court lawyer Abul Kashem. The petition said private cars, jeeps and microbuses are

used for private purposes, not for earning money, so impos-

ing AIT on them is illegal. Secretaries to the ministries of finance and law and chairman of the Board of Revenue have been made respondents to the rule, petitioner's lawyer Masud Ahmed Sayeed told

The Daily Star. Kashem said the finance ministry issued a gazette notifi cation imposing AIT on the vehicles in 2009 and it issued another notification in 2012 increasing the AITs.

and others again detained my grandfather and took him to the camp. My grandfather was never found," said Dudu.

His grandfather along with 15 others was taken to a crematorium and shot there, he said, quoting Saidur Rahman alias Sadu Chairman, who was among the 15 men but

survived the shooting. The 12th prosecution witness, Asadullah alias Shona Miah, the son of martyr Yad Ali, gave almost a similar description of the

night of July 7. The defence counsels cross-examined the two before the proceeding was adjourned until December 27.

The four along with another four alleged Al-Badr men -- Shamsul Haque, SM Yusuf Ali, Harun, and Abul Hashem -- face five charges of crimes against humanity.

# Why shouldn't family be compensated

Akondo asked Dhaka Wasa and Dhaka South and North city corporations to list pipes, wells, tube-wells, sewerage pipes, holes and water tanks left uncovered or unsafe in the capital and submit the list to the court in three months.

The court also demanded explanations from the authorities as to why they should not be ordered to make those pipes, wells, tube-wells, and so on safe, petitioner's counsel Abdul Halim told The Daily Star.

Following a similar petition filed by the rights organisation, the HC in February issued a rule upon the government to explain why it should not be directed to give Tk 30 lakh in compensation to the family of four-year-old Jihad, who died after falling

down a 300-foot well shaft in the capital's Shahjahanpur Railway Colony on December 26 last year.

The rule is still pending with the HC. Meanwhile, a Dhaka court yesterday

placed Shahriar Ahmed Shukkur, 40, who is responsible for maintenance of the sewer in Shyampur, on a two-day remand. The order came after police produced

him before the court seeking seven days' remand. Shukkur was nabbed due to negligence in his job that caused Nirob's death, said

Kadomtoli police Officer-in-Charge Kazi Wazed Ali.

Inspector Saiful Islam filed a case on Sunday, accusing Shukkur and some unnamed persons.
