Syndicate extorts truckers at Burimari land port

A syndicate has continued forcing transport workers to pay huge illegal toll for loading and unloading imported and exported goods at Burimari land port in Patgram upazila under the district, despite the shipping minister's warning against the malpractice during his visit there on October 18.

A syndicate run by an Awami League leader collects Tk 3,000 to 5,000 as illegal toll against each truck, transport workers said, adding that they face threat of prohibition of entry into the land port,

anyone declines to meet the demand.

The organised syndicate illegally collects about Tk 5 to 6 lakh from 200 to 220 trucks daily, and the money is shared by the toll collectors, transport leaders, and a section of people belonging to law enforcement agencies, customs department and land port authorities, said sources of Burimari land port.

"I can load and unload goods in the land port only if I pay illegal toll to the syndicate," said Jahirul Islam, 44, a truck driver from Rangpur.

"We hoped that we won't have to pay illegal toll after even physical harassment, if Shipping Minister

Shahjahan Khan ordered stern action against such malpractice during his visit here on October 18, but the situation has remained as before," said another truck driver Badiul Islam, 45,

from Bogra.

importer and exporter at the land port, said the illegal toll collection has led to increase in fare of vehicles for loading imported goods.

On November 12, the matter of illegal toll collection from vehicles was discussed in the law and order committee meeting presided over by the deputy commissioner at his office. The meeting decided that the adminis-

tration would take necessary steps to stop the illegal toll collection.

Seeking anonymity, a few security guards at the land port said they collect toll from transport workers as per the direction of their in-Mithu Islam, 40, an charge Ataur Rahman.

The money goes to the syndicate and then it is shared among many people, they said.

Asked about the matter, Ataur Rahman said, "We never demand illegal toll from any transport worker, we only receive what they give us willingly."

Rezaul Karim, officer in charge of Patgram Police Station, declined to talk regarding the matter.

Kalapara in Patuakhali

Land grabbers force 2 Hindu families out of home

Twelve people belonging to two Hindu families of Alipur village in Kalapara upazila under the district had to leave their houses following threat from alleged land grabbers who also kidnapped the head of one of the families on

December 8. Members of the victim families, who are staying in Kalapara upazila town for the last three days, met the deputy commissioner (DC) of Patuakhali at his office on Sunday noon and submitted a complaint over the

"My father Jitendra Nath Bepari bought 3.53 acres of land of Latachaplee mouja

at Alipur village from Rakhain people and later he sold 2.82 acres of land to some Abdul Mannan Khan. Now I and my brother Jotindra Nath Beparee own the remaining 71 decimals of land," goes the complaint signed by Jagodish Chandra

Bepari.

"But a section of local influential people led by Eusuf Musulli wanted to grab the land. As they threatened us to leave the land, I filed a civil suit with Patuakhali Joint District Judge's Court on November 25 accusing six people including Eusuf Musulli and the court summoned the accused," says the com- said. plaint submitted by

"After knowing about the case, they gave us death threat on December 2 and I filed a GD with Kalapara Police Station in this regard. It made them angrier still. At about 10:30pm on December 8, one of the accused called Jotindra Nath and since then he has

remained missing." "We went to Kalapara Police Station to file an abduction case but the OC declined to receive it. We had to leave our houses as the accused gave threat continuously," Dijendra

Contacted, Eusuf Musulli on the matter.

Jogodish's son Dijendra said, "We bought land from the father of Jogodish and Jitendra and their complaint is false. We didn't threaten them. I don't know who

kidnapped Jitendra." Mohammad Azizur Rahman, OC of Kalapara Police Station, said, "Jogodish and his family members came to me and orally made the complaint. I suggested them to file a complaint in written but

they did not come later." Patuakhali DC Amitav Sarker said after receiving the complaint, he has asked the upazila nirbahi officer of Kalapara to take immediate lawful step after proper investigation

Poor civic amenities frustrate residents

Over 15 thousand people of Kuakata municipality in Kalapara upazila under the district are deprived of basic civic amenities as the municipality set up five years ago has not seen any mentionable development in last five years.

The municipality covering 9.40 square kilometres started functioning on December 15 in 2010 and Md Jahangir Alam, upazila nirbahi officer of Kalapara, is conducting its activities as 'administrator' from the beginning.

The municipality with its present population of 15,326 will see its first election on December 30 when 6,845 voters including 3,495 male and 3,350 female will choose their representatives.

Municipality office is running at a rented portion of 'WDB rest house' in Kuakata Zero Point area. Vehicles like buses, microbuses and trucks are parked on the roads as there is no parking area in Kuakata, said Md Sahajan Akon, a local resident.

Of the 18 kilometre road of the municipality area, only 1.5 km is pucca road although the picturesque tourist spot in the beach area attracts thousands of visitors from home and abroad round the year, he said.

There is no water supply

and sanitation system and N a b i n p u r, we have to depend on Kachchhopkhali and tube-wells for drinking water, said Monju, a Rakhaine youth of tourists," said Fatima Keranipara area.

"We have to pay munici- municipality. pality tax but get no facilities," said Bulbul, another youth of the same area.

"We have hardly any feeling of living in a municipality area as facilities are very poor. Most of the earthen roads become muddy during the rainy season. There is no metalled road at West Kuakata, Khajura, Keranipara,

JMB suspect held in Mymensingh

Members of Rapid Action Battalion (Rab) detained an alleged member of banned militant outfit Jama'atul Mujahideen Bangladesh (JMB) in Bhaluka upazila of Mymensingh on Monday night.

The detainee, Md Hafiz Uddin of Hobirbari Jibontala area in Bhaluka, is one of the members of the militant outfit, said Md Zobraj Hossain, assistant superintendent of police (operation) of Rab-14.

The elite force members held Hafiz, son of late Noor Uddin Haider alias Nuru Munshi, from his grocery shop around 8:30pm yesterday and handed him over to Bhaluka Police Station in the afternoon, Rab sources said.

Hafiz faces several charges, including those of killing and extortion, a Rab official said, adding that an arrest warrant was also issued against him in a case by a Mymensingh court.

Transport strike in Sylhet called off

Transport owners and workers called off their indefinite strike on all roads of Sylhet district yesterday.

The decision came after a fruitful meeting with the district administration held at the deputy commissioner's office around 6:00pm, Sylhet District Transport Workers Union President Selim Ahmed said.

At the meeting, the local administration assured the transport union leaders of meeting their demands within the shortest possible time.

District Transport Workers Union and District Truck and Tank Lorry Transport Workers union jointly enforced the strike on Monday to press hometheir five-point demand.

Their demand includes arrangement of an alternative microbus stand in Sylhet city, removal of corrupt traffic police officials, and steps to stop alleged extortion and harassment by police on highways.

Criminals cut down betel plants at Khasi village


