Agri loans often fraudulent, controlled by brokers

'Defaulters' include fake names, never received listed amounts

A good number of sharecroppers and marginal farmers at villages in 45 unions of five upazilas under the district are recorded as loan defaulters with the Rajshahi Krishi Unnayan Bank (Rakub) authority, allegedly through forgery.

"I got loan of Tk 20 thousand only but I have been shown as a defaulter of Tk 60 thousand," says landless farm labourer Jamal Uddin, 42, of Basti Khatamari village in Lalmonirhat Sadar upazila's Kulaghat union. "I took the loan two years ago, when local bank broker Abul Hossain introduced me with a bank official."

Unscrupulous bank officials employ many local brokers to tempt villagers to get agricultural loans from Rakub, he added.

Sharecropper Shah Alam, 48, of the same village said he took a loan of Tk 25 thousand for cultivating crops on two acres of land but he is now shown as defaulter of a Tk 60 thousand loan. A broker and a bank official did everything to arrange the loan, he added.

"It is difficult for genuine farmers to get agriculture loans from Rakub," says farmer Nazrul Islam of Lalmonirhat Sadar's Rajpur village. "Rather, cheats are recruited as brokers by unscrupulous

officials and these people control the agriculture loans Rakub provides."

Mozahar Ali, a farmer at Barakhata village of Hatibandha upazila, says the names of a good number of farmers have been recorded as agriculture loan defaulters in the village as these loans were disbursed against fake names with fake documents.

Rakub, he added.

Mohammadul Islam, Kulaghat union land officer, said Rakub officials never check the land documents submitted by loan seeking farmers and so, people can get agriculture loans with fake documents.

Rakub official sources said a total of 17,944 farmers are recorded as loan defaulters, the total Unscrupulous bank amount of such 'unpaid'

are finding no trace of most of the listed loan defaulters in the areas concerned.



Initially Mizanur Rahman and Rekha Khatun, villagers of Jhenidah's Moheshpur upazila, weren't sure whether or not to send their son Sangram Ahmed Kabir to school. Sadly, Kabir cannot speak and is deaf, which made the parents wonder how he would manage in

the classroom. But by the time he was eight years old, Kabir had begun to show an interest in drawing, initially scratching out pictures on the ground of his home yard. He also learnt to make different toys and became adept at sewing designs on cloth. Kabir's mind and in particular his memory, is sharp.

Moreover, when inquisitive Kabir saw other children heading off to school in their uniforms, school bags in hand, he wanted to join them. On many occasions he cried from the disappointment of not accompanying the other students. So, in 2010, his parents decided to grant his wish. His mother took Kabir to Khalishpur Primary School

for admission.

Kabir and his family are fortunate to have enrolled him at Khalishpur, for the headmistress Taslima Khatun, together with an assistant teacher at the their wings.

"We made every effort to teach Kabir to read," says Khatun. "It wasn't easy since he can neither speak nor hear our instructions."

Teaching aids were brought from teacher's homes, especially simple pictures like a tiger or a mango. Through a process of matching the written word with each picture, Kabir was able to memorise how each word was spelt and thereby learn to read. Now 14 years old and studying in class 6, he can write whatever he wishes.

The keen student has also learnt to make fishing implements, paper flowers, tops and model carts. He is an avid computer enthusiast. Yet his greatest enjoyment is undoubtedly in

drawing and painting. "When I first noticed Kabir's love of art I thought to encourage it," says

Khatun. "Specifically my object was to train him to be able to write signboards as a possible future career." She taught him how to

mix water colours and facilitated his participation in school, took Kabir under several competitions. Kabir picture would become an has already completed more than 300 drawings and paintings during his school years, and when he was in class 3 one of his pictures won first prize in an upazilalevel drawing contest.

Now a confident young artist who prefers to draw landscapes, it was only natural that when Khatun heard in May 2015 that the upazila office was looking for pictures from children with disabilities, Kabir came first to mind. She duly submitted one of his pictures to the Moheshpur upazila nirbahi officer, Naima
